- 1. Please refer your appeal dated December 11, 2023 (received on December 14, 2023) preferred under the Right to Information (RTI) Act, 2005. The said appeal, your RTI request dated November 13, 2023, CSL's reply (ref no. CSL/SEC/CS/CORRESP/RTI/2023/2 dated December 06, 2023) and other relevant documents have been examined.
- 2. In your RTI request referred above you have sought for the dates on which Cochin Shipyard Limited (CSL) forwarded your application dated June 01, 2020 and April 03, 2023 w.r.t your joint option for higher pension to the Asst. Provident Fund Commissioner, Employees' Provident Fund Organisation (EPFO), Kaloor, Ernakulam. CSL provided a detailed reply on December 06, 2023 wherein it was inter alia informed that your application (hard copy) w.r.t the joint option for higher pension was received by CSL in April 2023. The reasons for not forwarding the same to EPFO was also provided in the said reply.
- 3. In your appeal referred above you have contended that CSL has not provided information on whether CSL has forwarded your application dated June 01, 2020 w.r.t the joint option for higher pension to the Asst. Provident Fund Commissioner, Employees' Provident Fund Organisation (EPFO), Ernakulam and the date of forwarding the same to the EPFO.
- 4. On examination of the relevant records of the Company this Authority could not find any documents to show that your application dated June 01, 2020 w.r.t the joint option for higher pension was forwarded by CSL to the EPFO.
- 5. With this, the first appeal stands disposed off.
