Dear Sir,

1. Please refer your appeal No. CSLTD/A/E/24/00008 dated June 15, 2024. The said appeal, your RTI request (ref no. CSLTD/R/E/24/00029 dated May 13, 2024), UCSSL's reply (ref no. UCSSL/REC/RTI/2024/002 dated June 07, 2024) and other relevant documents have been examined.
2. In your RTI request referred above you have inter alia sought for the real administrative reasons for cancellation of vacancies notified vide Vacancy Notification Ref No. UCSSL/IMS/HR/VN/F/11-OFCDR/2023/19. Udupi Cochin Shipyard Limited (UCSSL) vide its reply referred above has informed that the information sought is in the form of a query and does not fall under the definition of 'information' under the Right to Information Act, 2005.
3. In your appeal referred above you have contended that you were refused access to the information sought and also requested for new information not covered in your original RTI request.
4. During examination it was observed that the Vacancy Notification in question had to be cancelled due to some errors. New Vacancy Notification has been issued on June 06, 2024 after correcting the errors.
5. Further, the new information sought in the appeal, which has not been covered in your original RTI request is outside the scope of this appeal.
6. With this, the first appeal stands disposed off.
