Dear Madam,

- 1. Please refer your Appeal dated November 27, 2024 received by the undersigned on November 29, 2024. The said Appeal, your RTI request dated October 12, 2024 and CSL's reply (ref no. CSL/SEC/CS/CORRESP/RTI/2024/7 dated November 14, 2024) have been examined.
- 2. In your RTI request referred above you had sought for various information relating to the CSR funds provided by CSL to a Skill Development Center located at Pathanamthitta. CSL vide its reply referred above had informed that as the name of the agency is not mentioned, CSL won't be able to provide any information. Upon review, this Authority could not find any deficiency in the said reply as the CPIO is not obligated to provide information based on assumptions or vague references. For the CPIO to process a request effectively and provide accurate information, the request must be clear, specific, and include sufficient details, such as the name of the concerned agency, to facilitate the identification of the relevant records or information.
- 3. Further, in your Appeal referred above you have raised several allegations. However, please note that, under the provisions of the Right to Information Act, 2005, this Authority's mandate is limited to examining two specific aspects: (i) whether the information sought for by the RTI Requester was provided to him; and (ii) if the same was denied, whether such denial was justified. Hence, this Authority has not examined the veracity of the contentions raised in your Appeal as the same is outside the purview of the Right to Information Act, 2005. Further, in your Appeal you have also mentioned the name of the agency to which the CSR funds were provided by CSL. This being a new information not covered in your original RTI Request, the same is outside the scope of this Appeal, for which you may submit a fresh RTI Request with the CPIO.
- 4. With this, the first appeal stands disposed off.
