1. Please refer your RTI request no. CSLTD/R/E/23/00008 dated January 22, 2023. The information sought under the said request relating to the selection for the post of Executive Trainee (Mechanical) as per Vacancy Notification No. CSL/P&A/RECTT/PERMANENT/EXECUTIVE TRAINEES/2021/11 dated October 01, 2021, is given below:

- (i) In one of the previous RTI Request, it was informed that there is only one EWS candidate between rank 56 and 105. What is that rank number? Is that person only the RTI Requester means i.e rank 105?

Answer

The EWS candidate between Rank Nos. 56 and 105 is Rank No. 82.

- (ii) Is there any joined executive trainee (Mechanical) resigned which created further vacancy? How many resigned category wise?

Answer

Two candidates, one in ST and one in EWS category, who joined as Executive Trainee (Mechanical) in Cochin Shipyard Limited have resigned.

- (iii) What is the status of filling those vacancies caused due to resignations.

Answer

One vacancy has been filled.

- (iv) Which rank has been called or is to be called to fill those vacancies category wise?

Answer
