The information sought pertains to sensitive and strategic infrastructure of the Company and it is pertinent to note that direct and pointed queries aimed at seeking specific infrastructure details from a company handling defence projects may pose a potential threat to national security. Such disclosure is not only contrary to the larger public interest but may also jeopardize critical security protocols. Accordingly, the information is exempt from disclosure under Section 8(1)(a) of the Right to Information Act, 2005.
