- (i) What is the duration of Rank list for examination conducted by CSL.

**Answer**

The validity period of the wait list shall be up to 18 months from date of joining of the last candidate advised from the list against the vacancies notified, unless a fresh notification for the same post is issued.

- (ii) Reason for asking different years of experience for posts in same scale.

**Answer**

The experience requirement for various posts notified is as per the recruitment rules for the respective posts.

- (iii) Reason for asking candidates to write their names along with the Registration Number in phase 2 exam of contract and permanent post, since Registration Number is enough for the same?

**Answer**

The information sought is in the nature of a query and hence is outside the purview of the Right to Information Act, 2005.
