- (i) How much public money was spent on the renovation of the entire toilet complex near the Outfit warehouse store, including both the large toilet area and the single room separate toilet facility?

Reply

The expenditure incurred by Cochin Shipyard Limited (CSL) for the renovation of the toilet complex near the Outfit Warehouse Store, including the large toilet and single toilet facilities is Rs. 9.39 lakhs, excluding GST (18%).

- (ii) Was the single room separate toilet facility near the Outfit warehouse store originally designated as a ladies toilet?
- (iii) If the single room toilet facility was originally designated as a ladies toilet, what prompted the change in its use or policy, allowing men to use it as well?
- (iv) Who are the individuals or groups authorized to use the single-room toilet facility? Has the usage policy changed over time?
- (v) Why is the single-room toilet facility near the Outfit warehouse store always kept under lock and key?
