


Subject: Transfer of Public Grievance Nos. DPUBE/E/2024/0000066 and DPUBE/E/2024/0000087-reg.

The Department of Public Enterprises (DPE) has been receiving complaints related to non-compliance of DPE's OM No. DPE-GM-12/0001/2015-FTS-3756 dated 24.06.2020 or related guidelines by University Grants Commission (UGC) by Central Public Sector Enterprises (CPSEs). In the Public Grievance Nos. DPUBE/E/2024/0000066 and DPUBE/E/2024/0000087, the applicants have raised concern over mandating regular/full time qualification and excluding recognized part-time/correspondence/Open and Distance Learning qualification as eligibility criteria in public recruitment by the CPSEs.

2. Since recruitment matters below the board level rest with Central Public Sector Enterprises (CPSEs) through their respective Board of Directors, therefore the matter referred above is hereby transferred to the administrative ministry or department to direct the concerned CPSE to examine the matter and ensure compliance of their recruitment policies with the DPE's OM dated 24.06.2020.

Reply

Cochin Shipyard Limited (CSL) had already been in compliance with the DPE OM Nos. DPE-GM-12/0001/2015-GM-FTS-3756 dated 25.05.2018 & DPE-GM-12/0001/2015-FTS-3756 dated 24.06.2020 on the same subject, as CSL's Recruitment Policy contains the necessary clause in this regard which is reproduced below for reference.

Clause 25.5.1 – The minimum qualification stipulated for the posts shall be from any University/ Institute recognized by AICTE/ appropriate statutory authority in India. The qualification may be full-time/part-time/distance course.

Hence, CSL has been in compliance with the directives on the subject.

2.
