It is informed that the Department of Public Enterprises (DPE) under the Ministry of Finance is the nodal department for all the CPSEs. As part of its mandate the Department of Public Enterprises brings out a survey report every year. The Public Enterprises Survey traditionally covers, beside certain statutory corporations, those Government companies wherein more than 50% equity is held by the Central Government. The subsidiaries of these companies, if registered in India, wherein any CPSE has more than 50% equity are also categorized as CPSEs. *The Survey, does not cover departmentally run public enterprises, banking institutions, and insurance companies.*

Based on the information as furnished by Ministries/Departments/CPSEs to DPE, no such information as raised in queries are available in records of DPE. In fact, all these matters are internal and vary according to needs of individual CPSEs. Hence, all queries are being forwarded to the concerned CPSE, to reply directly to the applicant.
