- 1. Please refer your RTI request ref no. DPENT/R/T/23/00113 dated June 02, 2023 transferred through e-mail to Cochin Shipyard Limited (CSL) by the Department of Public Enterprises vide letter ref no. DPE/6(01)/2023-Survey dated June 20, 2023. The information sought vide point nos. 3, 5, 6, 7, 8 and 9 of the said request pertaining to Cochin Shipyard Limited (CSL) is given below:
 - (i) No. of employment generated by the National Career Service portal in the last 5 years.

Answer

The number of employment generated by the National Career Service portal in the last 5 years is not available with CSL.

(ii) Mechanism to monitor the Right to Equality in employment given to each citizen of India in both public and private sectors.

<u>Answer</u>

The information sought is in the nature of query which does not fall under the definition of "information" under the Right to Information Act, 2005 (RTI Act) and therefore outside the purview of the RTI Act.
