1. Please refer your RTI request no. CSLTD/R/E/25/00031 dated May 08, 2025. The reply to the information sought under the said request is given below:

- (i) PLEASE SHARE COPIES OF ALL PURCHASE ORDERS OF MANILA & SISAL ROPE AS PLACED BY CSL PURCHASE DEPT. FROM 01.04.2022 TILL DATE.

Reply

Manila and Sisal ropes were procured in the recent past for defense projects as per the requirements projected by the Indian Navy. The purchase orders are commercially sensitive in nature, the disclosure of which would harm the competitive position of third parties and the same is not warranted in large public interest. Hence, it is exempted from disclosure pursuant to Section 8(1)(d) of the Right to Information Act, 2005.

- (ii) PLEASE INFORM DETAILS OF INSPECTION PROCEDURE CARRIED OUT BY CSL PURCHASE DEPT. FOR ROPES BEFORE ACCEPTANCE.

Reply

All rope inspections are conducted strictly in accordance with the standardized inspection protocols of Cochin Shipyard Limited (CSL). These procedures include dimensional conformity checks, detailed visual inspection & verification of certificates, labeling and documentation.

- (iii) PLEASE INFORM REASONS FOR AVOIDING PURCHASE OF BIS/ISI MARKED ROPES BEING SAFETY & CRITICAL ITEM.

Reply

There is no decision such as to avoid BIS/ISI-marked ropes. The ropes were procured as per specifications provided by the Indian Navy.

- (iv) PLEASE INFORM PRESENT STOCK POSITION OF MANILA & SISAL ROPES OF ALL SIZES AT CSL PURCHASE DEPT. STORES ALONG WITH DETAILS / PLAN FOR NEXT PURCHASE OF ROPES.
