- (a) When an employee does not seek and get prior permission from CSL before applying for outside employment, the NOC sought subsequently based on that application will be rejected.
- (b) As per the offer of appointment to Executive Trainees, during the period of Training and after appointment as Assistant Manager in the regular rolls of shipyard, during the period of probation and three years thereafter, permission for applying outside employment is not considered. NOC applications received from the concerned during this period will be rejected.
- (c) As per the offer of appointment to regular Workmen, Supervisors, and Executives, during the period of probation, application for outside appointment will not be forwarded nor will permission be granted for applying for employment elsewhere. NOC applications received from the concerned during this period will be rejected.
