Reply (i) to (iii)

No prescribed syllabus is available. With respect to the previous exam question paper, it is hereby informed that the selection process for the post of Executive Trainee (Safety) inter alia includes Objective Type Online Test for 60 marks. The disclosure of unpublished question paper to a particular candidate would be against larger public interest and also will lead to unfair advantage to a particular candidate in the said Objective Type Online Test. Hence, the same cannot be provided.
