CSL has implemented NPS (National Pension System) on April 01, 2021. Number of employees deceased while in service from April 01, 2021 to December 31, 2023 is 6.

- (ii) Number of family has been given the family pension during the said period.

Reply

On death of the employee, the nominees submit the death claim form of NPS directly to the PoP. Hence, the number of families who are availing family pension under NPS is not available with CSL.

2.
