The information sought under the said request relating to the selection for the post of Executive Trainee (Mechanical) as per Vacancy Notification No. CSL/P&A/RECTT/PERMANENT/EXECUTIVE TRAINEES/2021/11 dated October 01, 2021, is given below:

- (i) Is there any joined executive trainee (Mechanical) resigned which created further vacancy? If Yes, How many resigned category wise?

**Answer**

Two candidates, one in ST and one in EWS category, who joined as Executive Trainee (Mechanical) in Cochin Shipyard Limited have resigned.

- (ii) What is the status of filling those vacancies caused due to resignations?

**Answer**

One vacancy has been filled.
