This information should include the type of safety equipment procured, the quantity, the specification, the cost of each item, the total expenditure, and the respective vendors or suppliers.

<u>Answer</u>

Cochin Shipyard Limited (CSL) procures numerous safety equipments at its various units at Kochi, Mumbai (CMSRU), Kolkata (CKSRU) and A&N Islands (CANSRU). Hence the information sought is vague, voluminous and non-specific and its collection, collation and transmission will lead to disproportionate diversion of our available resources. Further, the disclosure of such information is also not warranted in larger public interest.

Additionally, CSL does not maintain the information in the form and manner in which the same is sought in your RTI Request and is also not required by any law to maintain the same in such form and manner. Hence, the same does not fall under the definition of "information" under the Right to Information Act, 2005 (RTI Act) and therefore outside the purview of the RTI Act. The RTI Act does not cast an obligation upon the public authority, to collect or collate such non-available information and then furnish it to the Requester.
