

Refer to RTI Reg.no. DPENT/R/E/22/00388, under RTI Act, 2005 received in this Department on 22/09/2022, directly.

It is informed that the Department of Public Enterprises is the nodal department for all Central Public Sector Enterprises (CPSEs) and formulates policy pertaining to CPSEs. It lays down, in particular, policy guidelines on performance improvement and evaluation, autonomy and financial delegation and personnel management in CPSEs. It furthermore collects and maintains information in the form of a Public Enterprises Survey on several areas in respect of CPSEs. The Public Enterprises Survey traditionally covers, beside certain statutory corporations, those Government companies wherein more than 50% equity is held by the Central Government. The subsidiaries of these companies, if registered in India, wherein any CPSE has more than 50% equity are also categorized as CPSEs. The survey, does not cover departmentally run public enterprises, banking institutions, and insurance companies.

The information sought by the applicant regarding Guest House accommodation and other various details related to its booking etc is entirely internal matter of CPSEs and DPE has no stake in the matter. Hence, the queries which pertain to internal administrative matter of CPSEs is being transferred to all CPIO of the CPSEs with supposition to reply directly to the applicant.
