1. Please refer your RTI request no. CSLTD/R/E/26/00030 dated March 02, 2026. The reply to the information sought under the said request relating to the selection for the various posts in the Workmen category in Cochin Shipyard Limited vide Vacancy Notification Ref No. CSL/P&A/RECTT/PERMANENT/ITI WORKMEN/2025/6 dated January 05, 2026, is given below:

The recruitment process for the various posts notified vide the above referred Vacancy Notification is on-going. The disclosure of information relating to the on-going recruitment process may hinder the said process and may also have a deleterious impact on public interest and will serve no public purpose. Hence, the said information may be provided only after the selection process is completed and specific request is received under the Right to Information Act, 2005.

Charge) & Appellate Authority, Cochin Shipyard Limited, Administrative Building, Cochin Shipyard Premises, Perumanoor, Kochi – 682015.
