Sub: Information Under Right to Information Act

Dear Sir,

1. Please refer your RTI request dated November 25, 2024 received by us on November 29, 2024, our letter dated December 23, 2024 seeking additional fees and your letter dated December 27, 2024 forwarding the said additional fees received by us on December 30, 2024. The reply to the information sought under your RTI request relating to the CSR support provided by Cochin Shipyard Limited (CSL) to Sidhanar Service Society, Kozhencherry Taluk Union No. 6, is given below ad seriatim:

- (i) The certified copy of the documents are placed at **Annexure I**. Please note that the information which is exempt from disclosure as per the provisions of the Right to Information Act, 2005 is excluded. However, the part of the information which could reasonably be severed from the exempt information, is provided with the exempt information masked.
- (ii) An amount of Rs.15 lakhs was transferred to their account maintained at State Bank of India, IFSC SBIN0070331 in three instalments viz.,
 - (a) November 05, 2022 - Rs. 7.50 lakhs (50% advance);
 - (b) February 14, 2023 - Rs. 6.00 lakhs (40% upon utilization of 1st tranche); and
 - (c) March 30, 2024 - Rs. 1.50 lakhs (Balance 10% upon completion).
- (iii) The income and expenditure statement submitted by Sidhanar Service Society comes under the realm of third party information exempt from disclosure under the Right to Information Act, 2005. Further, the disclosure of such information has no relationship to any public activity or interest and is also not warranted in the larger public interest. However, the certified copy of the utilisation certificate issued by a Chartered Accountant, submitted by Sidhanar Service Society w.r.t the CSR funds provided to them by CSL, is placed at **Annexure II**. Please note that the information which is exempt from disclosure has been masked.
- (iv) CSL does not pay any commission to anyone for providing its CSR funds.
- (v) No further application has been submitted by Sidhanar Service Society for availing CSR funds from CSL.



2. If you are not satisfied with the above reply, you may prefer an appeal within 30 days from the date of receipt of this letter to Shri Bejoy Bhasker, Director (Technical) & Appellate Authority, Cochin Shipyard Limited, Administrative Building, Cochin Shipyard Premises, Perumanoor, Kochi – 682 015.
