Dear Madam,

1. Please refer your RTI request no. CSLTD/R/E/23/00078 dated December 07, 2023. The reply in this regard is given below:

- (i) With reference to the construction of new dry dock to the North west side of Cochin Shipyard Ltd, Cochin Perumanoor, whether the water front property belonging to the NIPPHATT, Cochin and Fishery Survey of India- MED, Cochin will be acquired by CSL for the developmental works and wharf construction for berthing of vessels? Request copy of area development plan and proposal.

Reply

The information sought are in the nature of query which does not fall under the definition of "information" under the Right to Information (RTI) Act, 2005 and therefore outside the purview of the RTI Act. However, please note that the construction activities of the new dry dock of Cochin Shipyard Limited (CSL) is limited only to the areas already acquired by CSL.

- (ii) Whether the vessel berthing at the existing jetty of NIPHATT, jetty and slipway of FSI will be operable in the close proximity of the new drydock. Alternate arrangements that will be provided for the departments if any?

Reply

The information sought are in the nature of query which does not fall under the definition of "information" under the Right to Information (RTI) Act, 2005 and therefore outside the purview of the RTI Act. However, please note that we don't see any reason as of now to believe that the existing jetty of NIPHATT, jetty and slipway of FSI will be inoperable consequent to the commissioning of the new dry dock of CSL.
