Based on marks obtained in the Objective type online test, the candidates will be shortlisted for Group Discussion and Interview. Schedule of Group Discussion and Interview will be published on CSL website and shortlisted candidates shall be informed through e-mail. On completion of selection, offer of appointment indicating date of joining and details of medical examination will be issued to the selected candidates. It is expected to complete the selection process by June 2025.
