Sub: Appeal Under Right to Information Act, 2005

Dear Sir,

1. Please refer your Appeal No. CSLTD/A/E/20/00001 dated January 02, 2020. The said Appeal, your RTI request no. CSLTD/R/2019/50040 dated November 18, 2019 and CSL's reply letter no. SEC/50/2019-IV dated December 10, 2019 to your RTI Request and other relevant documents have been examined.

2. In this regard, it is observed that the CPIO vide letter no. SEC/50/2019-IV dated December 10, 2019 has already provided the information as required under the Right to Information (RTI) Act, 2005, i.e., the copy of Selection Committee report which contains all the information sought by the candidate of himself and the selected candidate. The marks obtained by non-selected candidates in Personal Interview is personal information related to a third party, the disclosure of which has no relationship to any public activity or interest. Accordingly, the disclosure of such information is exempt pursuant to Section 8(1)(j) of the RTI Act, 2005.

3. The above reasoning adopted by the CPIO is legally valid in the light of the provisions of section 8(1)(j) of the RTI Act, 2005. This authority finds no reason to differ from the decision of the CPIO as no materials are placed before this authority to show that the information withheld by the CPIO has any relationship to any public activity or interest.

4. Further, the "valid justification for the score obtained by the candidate under each weightage category" was not sought in the original RTI request no. CSLTD/R/2019/50040 dated November 18, 2019 and hence the same is outside the scope of Appeal.

5. For the above reason, the appeal is devoid of any merit and hence it is hereby dismissed.
