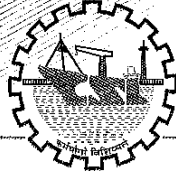

1. Please refer your RTI request no. CSLTD/R/E/20/00010 dated February 20, 2020. The information sought under the said request is given below:

- (i) Has Cochin Shipyard contributed Rs. 20 lakhs to Kottayam Press Club from its CSR funds in the last two years?

Answer

Yes. CSL has contributed Rs. 20 lakh to create an additional floor for Skill Development Centre at Kottayam Press Club.

- (ii) Is the Press Club which is not registered as a society, trust or club eligible to receive CSR funds from a Central Public Sector Unit?

Answer

As of now, there are no restrictions on supporting Press Clubs under CSR.

- (iii) Has Cochin Shipyard verified the eligibility criteria of Kottayam Press Club while allotting the amount?

- (iv) Has Cochin Shipyard received utilization certificate from Kottayam Press Club for the allotted amount?
