Dear Sir,

1. Please refer your RTI request dated October 28, 2019 transferred by Lakshadweep Development Corporation Limited (LDCL) vide their letter F.No.LDCL/RTI/2019 dated November 29, 2019 and received by us on November 30, 2019. As required by LDCL, the information sought vide point nos. 2, 4 (b), 5, 6 and 7 of the said request is given below:

- (i) Agencies who are undertaking refit and maintenance of your ships with value of work awarded to each agencies.

Answer

Refit and maintenance of LDCL vessels are being undertaken by Cochin Shipyard Limited (CSL) under tripartite MoU signed among UTL, CSL and LDCL. The works are being carried out either through CSL staff/ CSL registered sub-contractors/OEM authorized representatives based on the type of work. Regarding the list and value of work, the information sought being in nature of commercial in confidence of a third party and its disclosure is not warranted in larger public interest, the same cannot be provided pursuant to Section 8(1) (d) of the RTI Act, 2005.

- (ii) Details of any policy consideration given to MSME units in the area of ship repairs.

Answer

The Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 and amendments therein (25% of total procurement from MSEs) is complied with.

- (iii) Whether the contractor assigned with the job is meeting your time schedule for completion especially on critical jobs.

Answer

Yes.



- (iv) No: of MSME units undertaking your refit/maintenance of your vessels with their names.

Answer

There are 337 MSME registered subcontractors/suppliers in Ship Repair at CSL. We avail the services of these firms on case to case basis based on the requirement.

- (v) Details of Memorandum of Understanding (MoU) with agencies for refit and maintenance of your ships.

Answer

The information sought being in nature of commercial in confidence of a third party and its disclosure is not warranted in larger public interest, the same cannot be provided pursuant to Section 8(1) (d) of the RTI Act, 2005.
