1. Please refer your RTI request no. CSLTD/R/E/22/00100 dated August 09, 2022. The information sought under the said request relating to the selection for the post of Executive Trainee (Mechanical) as per Vacancy Notification No. CSL/P&A/RECTT/PERMANENT/EXECUTIVE TRAINEES/2021/11 dated October 01, 2021, is given below:

- (i) Till now how many students have joined in ET mechanical category?

### Answer

The total number of candidates joined for the post of Executive Trainee (Mechanical) vide the above referred vacancy notification is 37.

- (ii) How many EWS category people have joined in 3 EWS category vacancies?

### Answer

All the 3 posts reserved for EWS category for the post of Executive Trainee (Mechanical) vide the above referred vacancy notification have been filled.

- (iii) What is the merit list general rank of the last called EWS candidate (not from the first selection list, asking about waitlisted candidates)?

### Answer

The rank position of the last joined EWS candidate for the post of Executive Trainee (Mechanical) vide the above referred vacancy notification is 56.

- (iv) If there is any EWS vacancy in mechanical, after how many students rejects, the RTI Requester may get called?
