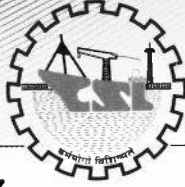

**Answer**

The date of publication of result for the above post was October 17, 2020. As per Clause E(g)(xi) of the vacancy notification, the validity period of the wait list has expired on October 17, 2021.

(iii) Whether any extension of time limit was given for the list?

**Answer**

Extension of time limit for the list is not applicable.
