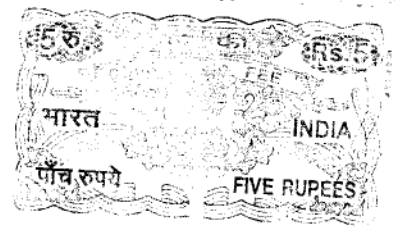

**Sub: Information Under Right to Information Act**

Dear Madam,

Please refer your RTI request dated December 21, 2018 received by us on December 26, 2018. The information sought under the said request relating to the result of selection of Executive Trainee (Safety) published in the official website of Cochin Shipyard Limited on December 19, 2018, is given below:

- (i) On the basis of what criterion /rule an 'OBC' candidate is provisionally selected to the vacant seat of the 'unreserved' category?

**Answer:**

As per the DoPT OM No. F. No. 43011/4/2018-Estt.(Res.) dated 04 April 2018 the reserve category candidates can compete for the non-reserve posts and the reserve category candidates who are selected on the same standard as applied to general candidates will not be adjusted against reserved vacancies. Only when a relaxed standard is applied in selecting reserved candidates, for example in the age limit, experience, qualification, permitted number of chance in written examination etc. such candidate will be counted against reserved vacancies. Thus, an OBC candidate who has not availed the benefit of relaxation of standards specified for OBC candidates can be selected to an unreserved post.

- (ii) On the basis of what criterion/rule a candidate can be mentioned to belong under both 'OBC and/Unreserved' category?

**Answer:**

- (iii) Furnish the individual scores I gained for the Group Discussion and the Interview conducted on November 01, 2018 and the rank I possess under the 'unreserved' category (RollNo. 1013400).
