1. Please refer your RTI request no. CSLTD/R/E/21/00042 dated September 30, 2021. The information sought under the said request relating to the selection for the post of Junior Safety Assistant in CSL Mumbai Ship Repair Unit (CMSRU) as per Vacancy Notification No. P&A/18 (204)/2018 Vol II (B) dated October 17, 2019, is given below:

- (i) How many applications have come to CMSRU Junior Safety Assistant? How many people have written the exam? What is the cut off mark in that exam?

Answer

The cut off marks for the online test for the post is 15 and circular for the cut off marks is published on CSL website.

- (ii) While 6 people were selected for interview in one post, instead of 12 people were selected in two posts, 8 people were selected. What is the reason for omitting the remaining 4 people?

Answer

As per the Vacancy Notification No. P&A/18 (204)/2018 Vol II (B) dated October 17, 2019, the method of selection to the post of Junior Safety Assistant was; Phase I : Objective type online test for 30 marks & Phase II : Practical / physical test in the relevant trade / discipline for 70 marks. Interview was not specified for selection as per the vacancy notification. Only 8 candidates became eligible for Phase II : Practical / physical test.

- (iii) Did all those selected for the interview have completed 4 years of experience on the date of application? Are there all provident fund details included?

Answer

Please refer answer to point no. (ii) above. 8 candidates shortlisted for practical / physical test met the eligibility requirement of 4 years of experience as per the vacancy notification. The second part of the question is not clear and hence unable to furnish the information.
