#### <u>Answer</u>

Financial Results of the Company for the financial year 2018-19 are yet to be published. The year 2018-19 had a mandated target of Rs. 10.15 Crore (2% of the average of last three years Profit Before tax). CSR budget for the year 2019-20 shall be finalised only after the results for year 2018-19 are announced.

(ii) What are the eligibility criteria to apply for CSR as per your mandates? Kindly share the details for this year?

#### **Answer**

Institutions, organisations, government bodies, autonomous bodies and people's representatives can submit CSR proposals to CSL. The implementing agency, who will be owning the project for the beneficiaries, could be either an NGO, Not for Profit agencies, Government Institutions, Section 8 Companies, etc., having no other source of fund to undertake a particular social project. The implementing agency should have clean and credible performance track record of at least three years evidenced by audited annual accounts and annual reports.

(iii) In which month we can apply for CSR? Is it 24\*7\*365 days open or is there any specific time to apply for CSR?

## **Answer**

Generally CSL would receive CSR Project proposals throughout the year. The application will be processed in batches and allocation would be confirmed based on merit and budget availability.
