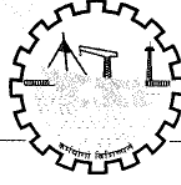

I. Please refer to your RTI application dated 04 May 2017 on the above subject. Information sought is given below.

1. Why list of selected candidates not published in CSL website.

Ans: Selection for the post of Assistant Manager (Finance) could not be conducted for want of eligible candidates.

The result of selection for the post of Executive Trainee (Finance) was published on CSL website in June 2017.

2. Do all candidate have complied with following eligibility given in notification No.P&A/18(186)/13-(B)-Vol II,

- Member of ICAI/ICWAI
- Full time graduation etc

Ans: 36 applications were received against the post of Executive Trainee (Finance), of which 23 applicants were short listed. 13 candidates were present for the selection and these 13 candidates have complied with the eligibility criteria mentioned in the vacancy notification No.P&A/18 (186)/13-(B)-Vol II dated 06 Feb 2017.

3. No. of applications received for Executive Trainee and Assistant Manager Finance respectively.

Ans: 36 applications were received against the post of Executive Trainee (Finance). Only one application was received against the post of Assistant Manager (Finance).

4. No. of candidates appeared for selection process Executive Trainee and Assistant Manager Finance respectively.

Ans: 13 candidates appeared for the selection to the post of Executive Trainee (Finance). No candidate was short listed for selection to the post of Assistant Manager (Finance) for want of eligible candidates.



5. Marks of candidates for written exam, GD and interview.

Ans: Please pay Rs.4/- towards copy of list containing roll number and marks of candidates, who appeared for written test, GD and interview covering two pages.

6. List of candidates short listed for GD and Interview.

Ans: Roll numbers of candidates short listed for GD and interview is are under:

7. What is CA/ ICWA membership number and date of enrolment of selected candidate

Ans: CA/ ICWA membership number and date of enrolment of selected candidate cannot be provided as it is a third party information and there is no larger public interest which warrants disclosure of the same.

8. Is the candidate eligible to apply for the post on date of application.

Ans: The candidate is eligible for the notified post as per the vacancy notification.

9. Who is held liable for appointing a candidate who had not complied with eligibility notification.

Ans: Please see the answer to the question No. 2 above.

10. As per Notification P&A/18(186)/13-(B)-Vol II for Executive Trainee and Assistant Finance, Candidate should not be member of ICAI/ICWA as per clause E(b)(i), on what ground candidates who did not qualify the same is allowed to appear for selection process. Many candidates including myself did not even apply for the vacancy seeing this notification eligibility but came to know CSL allowed candidates for selection process who are not member of ICAI.

Ans: The information sought is in the nature of a query and the same need not be considered under the RTI Act.

Ans: Verification of documents is done by Personnel & Administration Department, CSL.
