Please refer your RTI request no. CSLTD/R/2018/50021 dated December 20, 2018. The information sought under the said request relating to the result of selection to the post of Executive Trainees (Information Technology) No. P&A/18(194)/2016-Vol II and candidates short-listed for group discussion and personal interview, No. P&A/18(194)/2016(B), is given below:

(i) Could you please clarify as to how roll number of a candidate (1028234) whose number is not listed in the interview call appeared in the final result.

## Answer:

As per the vacancy notification, two posts were earmarked for PwD (Persons with Disabilities) candidates across all disciplines. Roll no. 1028234 was a candidate belonging to PwD category. In order to provide equal opportunity, separate GD/Personal interview for candidates belonging to PwD category across different disciplines, against the posts earmarked for PwD, was held on November 02, 2018.

(ii) The cut off marks in Online exam for PWD candidates and selection process of PWD candidates with notification number.

#### Answer:

The cut off marks of PwD candidates was 53.45. The short listed candidates were informed directly over phone / e-mail on October 25, 2018 to attend the GD/interview on November 02, 2018. Selection process is same for all candidates including PwD candidates, ie online test followed by GD and Interview.

(iii) Why is candidate with roll number 1028306 (PWD) of mechanical is already present in the interview shortlist unlike candidate with roll number 1028234?

#### Answer:

Unlike Roll No.1028234, the Roll No. 1028306 in Mechanical discipline was short-listed under the general merit list of candidates and not under the special list for PWD



candidates and therefore included in the merit/ reservation list prepared and published on CSL website (No. P&A/18(194)/2016(B) dated October 10, 2018).

(iv) When and why was a separate interview conducted for PwD candidates and when did the candidate appear for online examination?

#### Answer:

In order to provide equal opportunity, separate GD/ Personal interview for candidates belonging to PwD category across different disciplines, against the posts earmarked for PwD, was held on November 02, 2018. Online test for all candidates, including PwD candidates, for the post of Executive trainee was held on September 09, 2018.

(v) Marks obtained in online test, group discussion and interview for all the candidates call up for interview for Executive Trainee (Information Technology).

### Answer:

Marks obtained in the online test, group discussion and interview of all candidates short listed for the interview to the post of Executive trainee (Information Technology) is attached at **Annexure I**.
