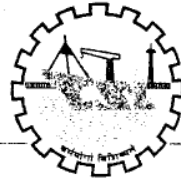
- ✓1. Kindly provide me a copy of the instructions issued within the Organization by you for implementation of the DIPP order referred above.


5) There is no requirement for appointment of nodal officer as per the "Make in India Policy". Should a requirement arises in future, CSL will appoint in appropriate time.
