ANNUAL ACTION PLAN

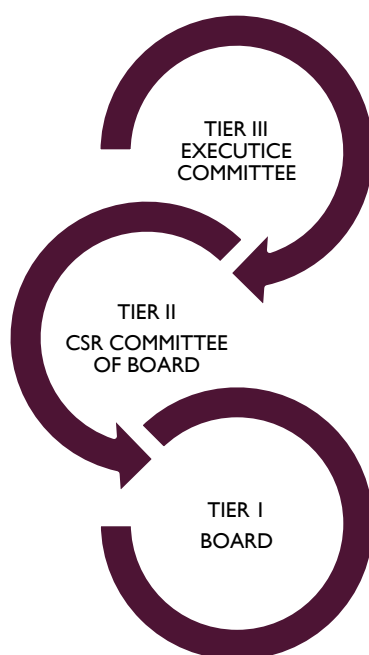
Annual Action plan of the company approved by the Board is published each year, which covers the target, budget allocation and theme adopted by the Government of India, in line with National priorities.

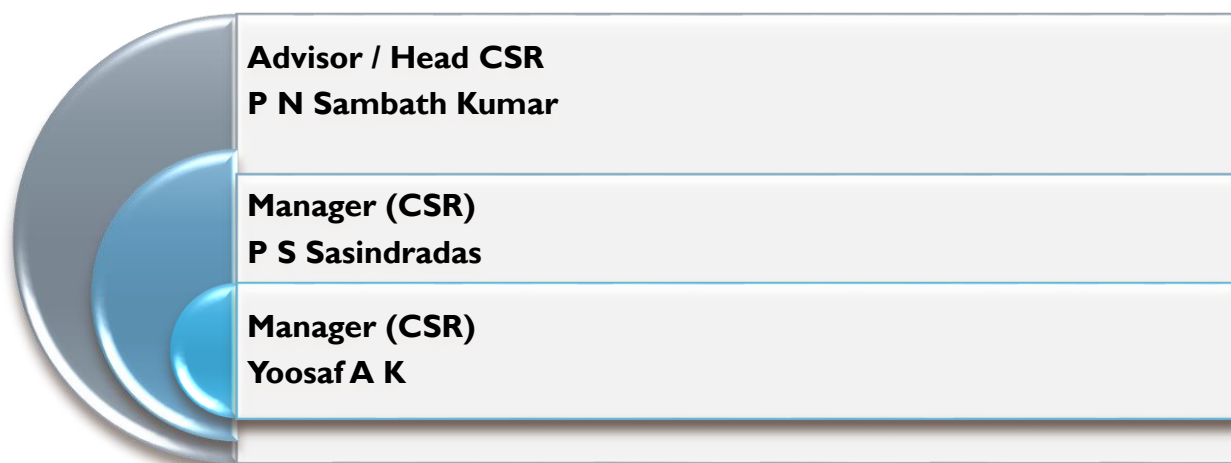

The CSR cell of the company consists of a professional implementation team. The following officers of the CSR cell function as the frontline professionals within the company to manage the CSR activities of the company.



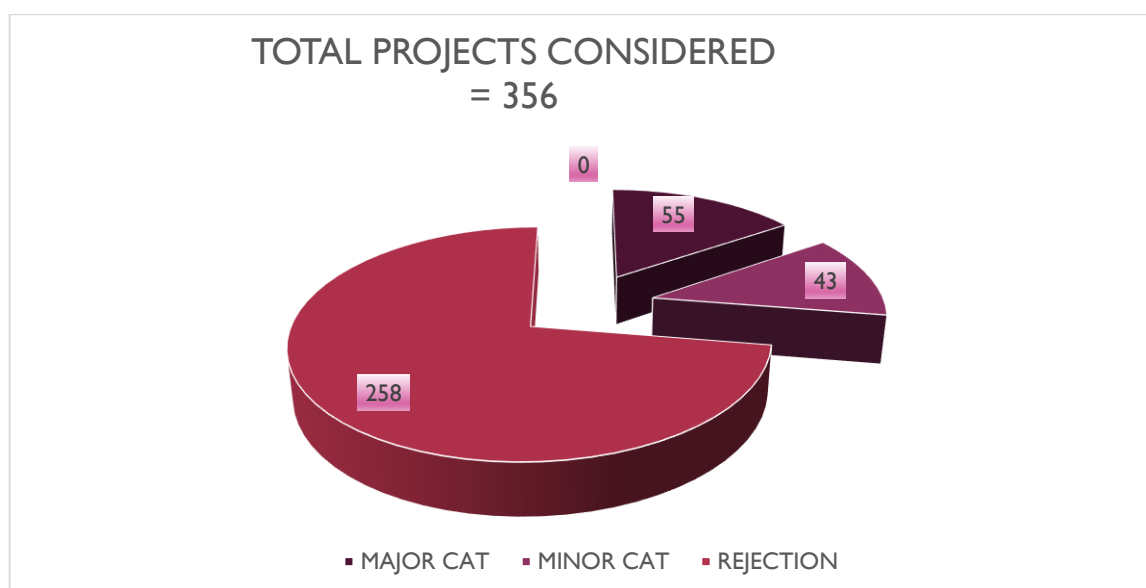

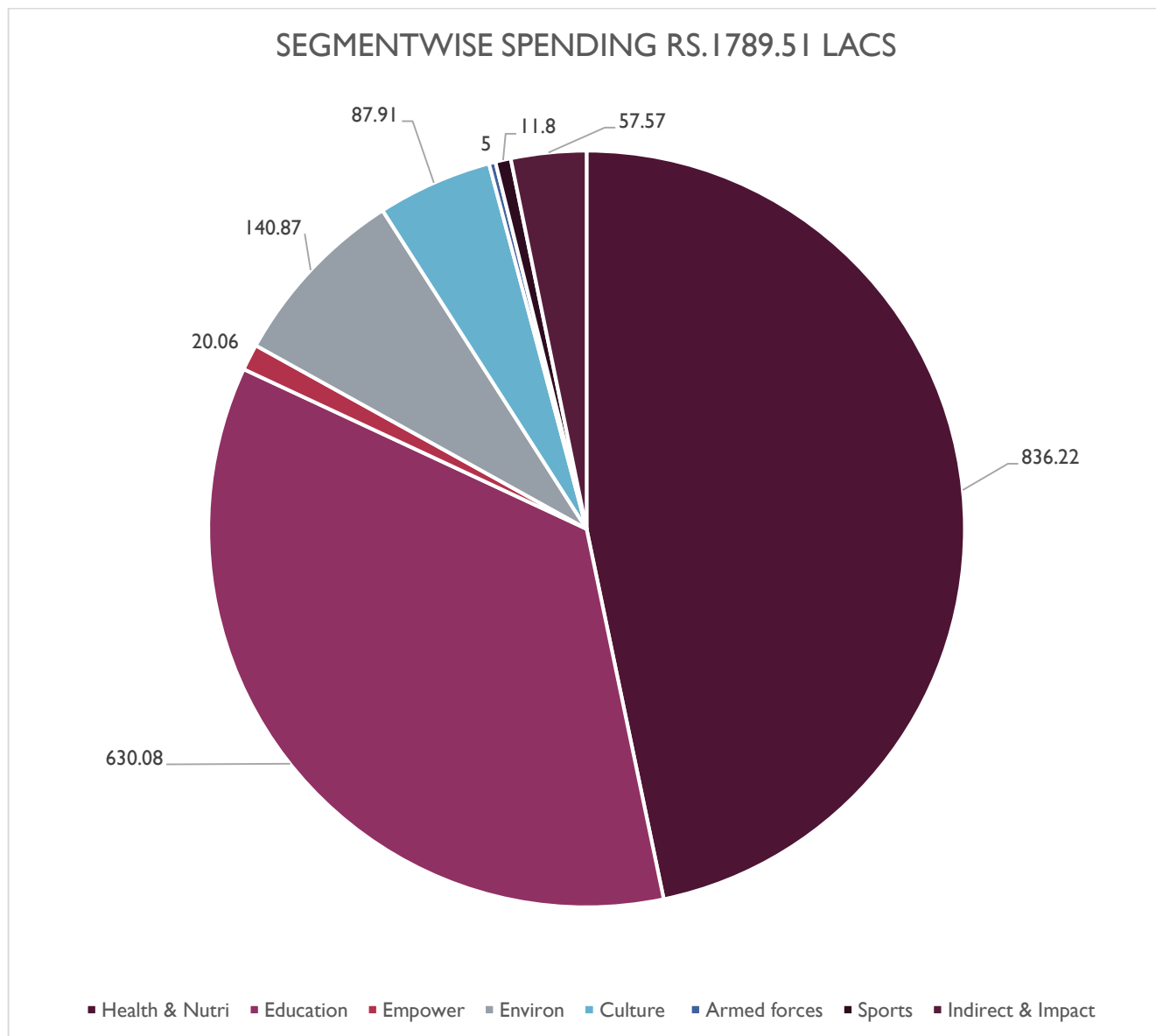

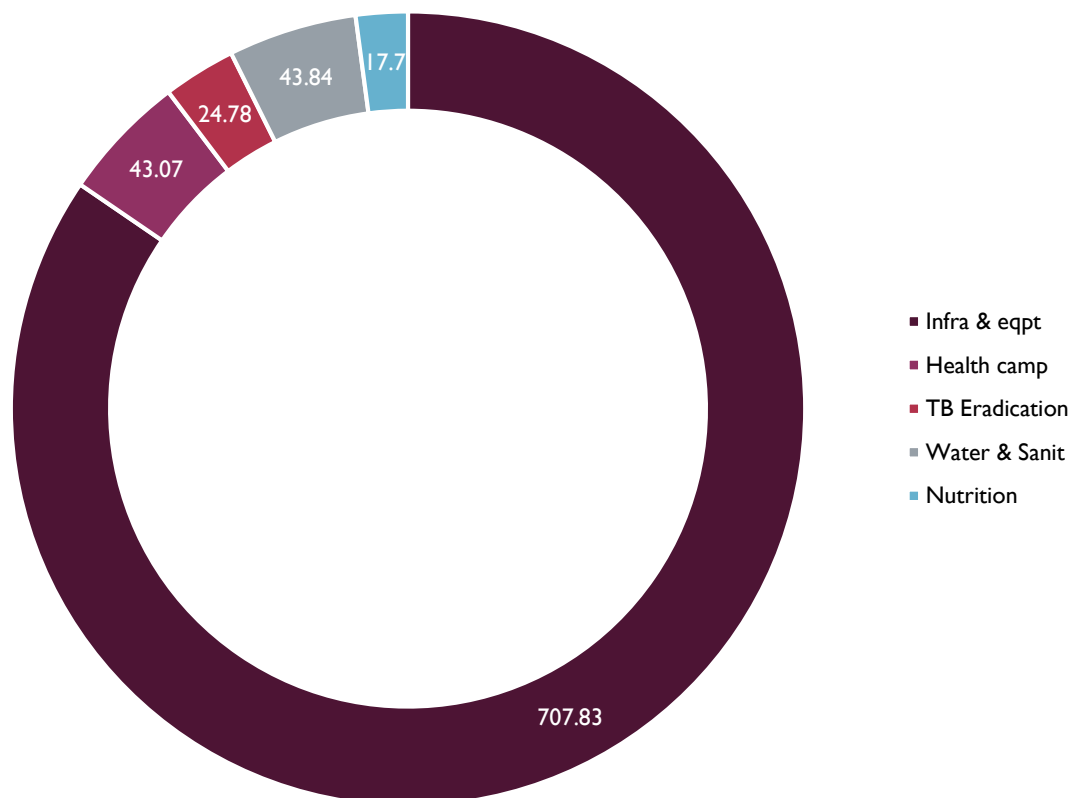

SUB THEME - RS.836.27 LAKHS



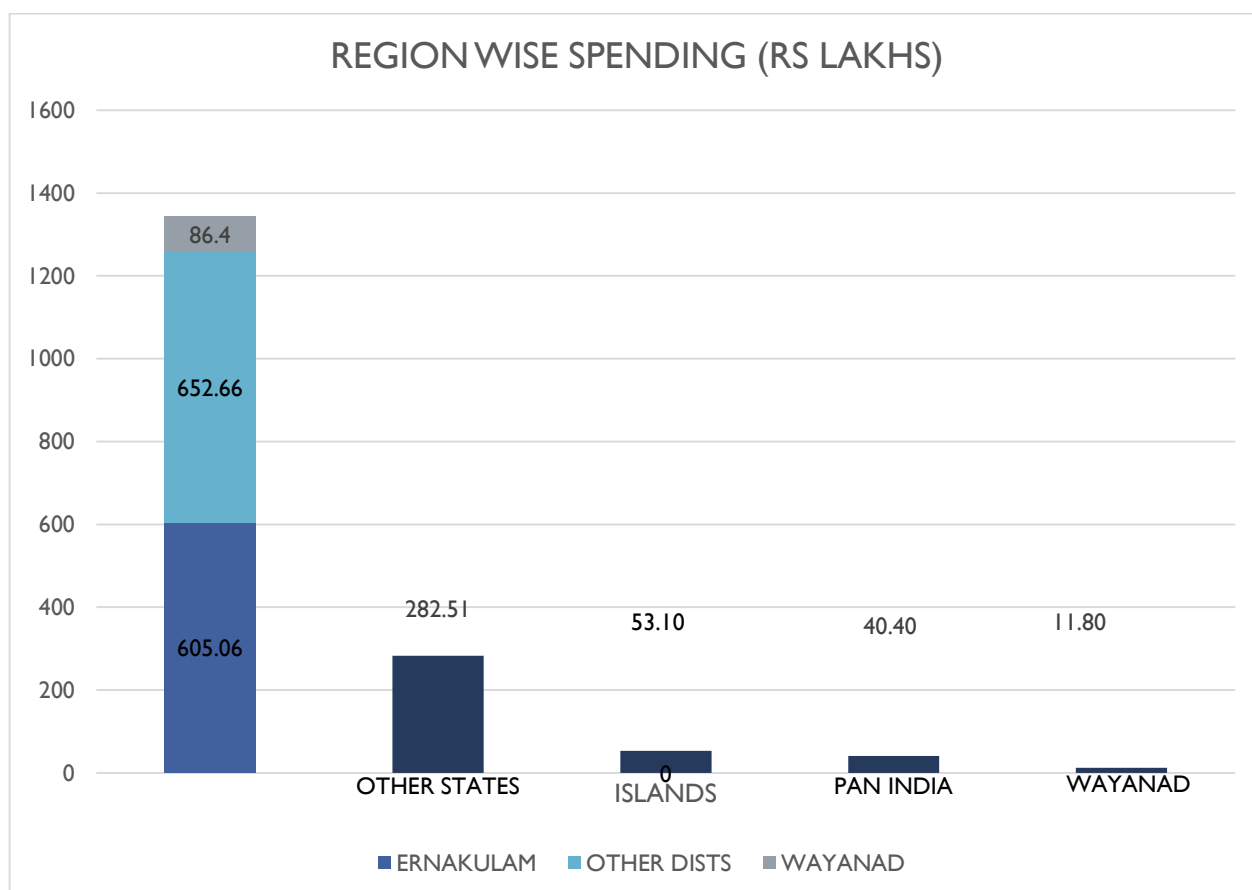

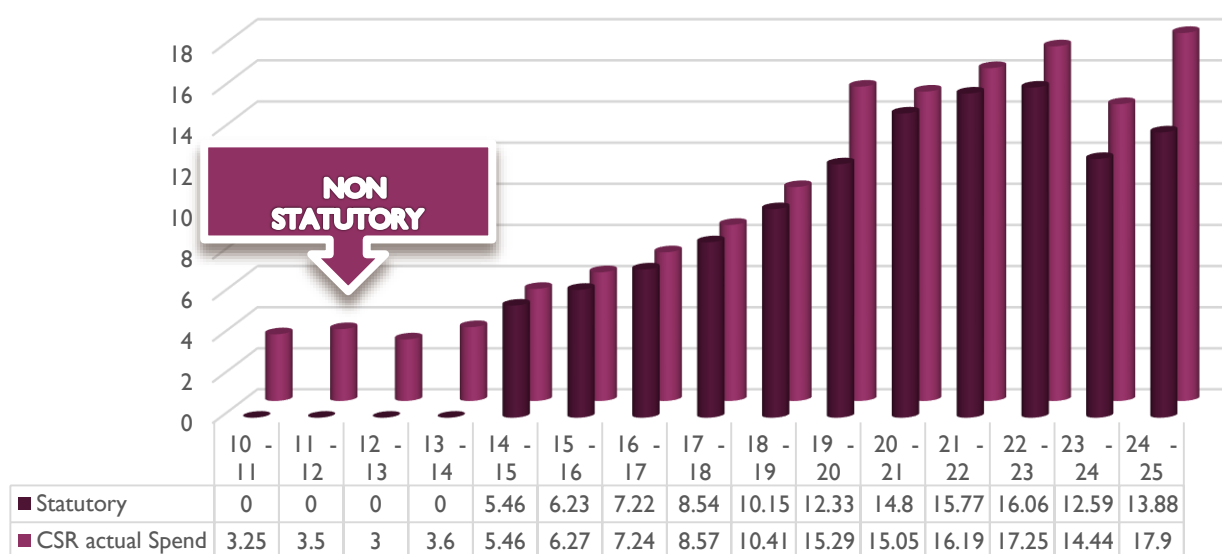

ACHIEVEMENTS IN THE PAST 10 YEARS:

Since inception as on date, CSL has undertaken more than 600 projects and spent more than 125 crores in CSR.

In the year 2014-15, from the time when 2% spending was mandated by the Ministry of Corporate Affairs, the company has never failed in achieving the target. Instead the company has always been spending in excess of the mandated spend of 2%. Since 2010-11, Cochin Shipyard has spent the following expenditure on CSR. Healing with purpose: Empowering Healthcare in Wayanad



Cochin Shipyard proudly reports the successful completion of two significant healthcare enhancement projects in the aspirational district of Wayanad, Kerala. Recognizing the unique health challenges faced by the region's significant tribal population and the broader community, we directed our support towards strengthening the infrastructure of the District Cancer Centre in Tribal Speciality Hospital in Nalloornad.

Understanding the critical need for comprehensive cancer care, we partnered in establishing an advanced oncology rehabilitation unit. Prior to this intervention, patients, many from poor and marginalized backgrounds including tribal communities, faced arduous journeys to access essential post-treatment rehabilitation services. Through collaborative efforts, the unit is now fully operational, equipped with state-of-the-art equipment. This vital addition is already making a tangible difference in the lives of cancer survivors, aiding their functional recovery, effectively managing pain and lymphedema, and fostering greater independence in their daily lives. This achievement underscores our commitment to enhancing well-being and directly supporting vulnerable populations in the region.

Furthermore, we addressed the crucial issue of timely chemotherapy administration by supporting the establishment of an advanced blood storage unit at the hospital. Previously, delays in accessing necessary blood transfusions posed a significant challenge, particularly for anaemic cancer patients. The newly constructed and fully functional blood storage unit, complete with compatibility testing facilities and round-the-clock availability, has effectively eliminated this bottleneck. This ensures that patients receive their chemotherapy without undue delay, a factor critical for improving treatment outcomes and overall prognosis. The impact is particularly profound for the many individuals who rely on this government institution for essential medical care.

These projects, meticulously planned and executed by the District Medical Office (Health), Mananthavady, with construction undertaken by the District Nirmithi Kendra and procurement managed by the Hospital Management Committee, stand as a testament to effective collaboration. The successful completion of the advanced oncology rehabilitation unit and the blood storage unit has transformed the healthcare landscape at the District Cancer Centre in Tribal Speciality Hospital. The enhanced facilities are providing comprehensive care closer to home for the tribal communities and all residents of Wayanad, ensuring timely access to critical services. Cochin Shipyard is immensely proud to have played a role in these impactful initiatives, which directly align with our CSR vision of fostering progress and well-being within the communities we serve. We remain committed to identifying and supporting projects that create meaningful and sustainable change in the lives of those in need.

"Investing in Inclusion: CSL Paves the Way for Empowerment at Fr. Tezza Special School"



Cochin Shipyard Limited (CSL) has made a meaningful contribution to enhancing the infrastructure of Fr. Tezza Special School, a non-profit institution focused on the rehabilitation and integration of mentally challenged girls. Established in 1982, the school offers therapies and training to foster cognitive, functional, and creative development in a safe and supportive environment. Situated in the scenic Wayanad district, an aspiring region in Kerala known for its natural beauty and commitment to sustainable development, the school benefits from an area that is gradually investing in better infrastructure and social welfare.

As part of its Corporate Social Responsibility (CSR) efforts, CSL has provided valuable support to the school by improving its infrastructure. The school's proposal aimed at making the environment more accessible for students with special needs, with projects such as an inclusive park, accessible travel options, and the creation of a fish pond and courtyard. CSL contributed by renovating the road, building a

children's park, and constructing the fish pond. These improvements have created a more inclusive, comfortable, and engaging space for the students.

The impact of CSL's support is profound. The enhanced infrastructure has not only made the school more accessible but also helped improve the students' overall quality of life. The inclusive park and renovated road have provided safer, more accessible areas for the children, while the fish pond has become a new recreational feature. These changes have contributed to the students' holistic development, fostering their self-esteem and promoting better integration into society. This collaboration between CSL, Fr. Building Waves of Knowledge: CSL's Support in Shaping Wayanad's Educational Infrastructure"



The CSR initiative by Cochin Shipyard Limited (CSL) to support the infrastructural development of Sree Sankara Vidyaneketan Upper Primary School has brought about substantial positive changes in the Wayanad district. One of the key outcomes of this project has been the improved access to education for children, especially those from remote and tribal areas. The provision of school vehicles has significantly reduced transportation barriers, ensuring that students can now attend school regularly and without the challenge of long and difficult commutes. This accessibility has made education more reachable for many children who otherwise might have missed out on learning opportunities due to geographical constraints.

Furthermore, the newly constructed two-storey building, equipped with modern furniture and fittings, has transformed the school's environment into one that is

more conducive to effective learning. With updated classrooms and facilities, students now have a more comfortable and engaging space in which to study. This improved infrastructure enhances both the teaching and learning experience, as it allows for the use of modern educational tools and methods that can lead to better academic outcomes. As a result, the students' enthusiasm for learning has likely increased, providing them with a greater sense of pride in their education.

The project has also contributed to increasing the enrollment and retention rates at the school. As the school's infrastructure has been upgraded, it has become more attractive to families, especially in a region where educational facilities may not always meet the required standards. The improved environment encourages more children to attend, while also helping reduce dropout rates, ensuring that more children, particularly from vulnerable groups like the tribal population, stay in school and complete their education.

In addition to the academic improvements, CSL's initiative has had a positive impact on the local community as a whole. By providing better educational facilities, the project empowers the community, fostering a greater appreciation for the importance of education. It helps break the cycle of poverty and ignorance, offering the children of Wayanad a brighter future and a pathway to greater opportunities. In essence, CSL's contribution has had a far-reaching impact, not only enhancing educational outcomes but also playing a vital role in the overall upliftment of the Wayanad community.

Reaching the unreachable: Towards a TB free Wayanad

Support for Infrastructure Enhancement and Nutrition Support for TB Elimination Mission in Wayanad.



Wayanad, a rural district in Kerala, is home to the state's largest tribal population. These indigenous communities face disproportionate health challenges, with the incidence of Tuberculosis among them being at least three times higher than that of the general population. The high burden of TB in Wayanad's tribal regions is driven by multiple social and environmental factors such as poor access to healthcare, under nutrition, low health-seeking behaviour, indoor air pollution, tobacco use, and alcoholism. These compounded vulnerabilities hinder early diagnosis and effective treatment of TB, posing a significant public health concern. In alignment with the National TB Elimination Program, CSL has collaborated with the District Medical Office, Wayanad, to address the TB crisis among tribal populations in the district.

Under this initiative, CSL extended financial support for enhancing infrastructure and providing nutritional aid to TB patients. The key components of the intervention included strengthening diagnostic capacity by establishing molecular testing facilities for TB, provision of sample storage equipment to ensure effective and timely diagnosis, support to the TB public health workforce in reaching remote tribal settlements through improved outreach services, distribution of nutritional support packages to TB patients currently undergoing treatment, aiming to improve treatment adherence and recovery outcomes.

This collaborative effort has significantly improved the accessibility and quality of TB care services in Wayanad's tribal areas. Enhanced diagnostic facilities have led to faster detection and treatment initiation, while the nutritional support has contributed to better health outcomes and increased treatment adherence. The initiative exemplifies a successful public-private partnership in addressing a pressing health issue within a vulnerable community, advancing the goal of TB elimination in Wayanad district.



EDUCATION

Empowering Dreams through Education

Cochin Shipyard Limited (CSL) recognizes education as a vital pillar of sustainable development and continues to make impactful contributions in this domain through its CSR initiatives. With a comprehensive and inclusive approach, CSL's support in education spans across three key focus areas: school education, skill development for employment generation, and special education.

In the realm of school education, CSL actively supports both infrastructural and qualitative improvements to enhance learning environments and academic outcomes. Infrastructure development includes the construction of classrooms and sanitation facilities, creating safer and more conducive spaces for learning. Complementing this, CSL also promotes qualitative initiatives such as the introduction of smart classrooms, syllabus enrichment, and programs aimed at raising academic standards. These efforts ensure that students are not only provided with essential facilities but also empowered with innovative and effective learning tools.

Understanding the changing dynamics of employment, CSL has placed significant emphasis on skill development as a pathway to economic empowerment. Through programs like 'Welding for Nation Building', CSL nurtures alternative employment opportunities by equipping youth with practical, industry-relevant skills. These initiatives bridge the gap between education and employment, especially in industrial sectors, aligning with CSL's expertise and commitment to nation-building.

Further reinforcing this commitment, CSL collaborates with government bodies and academic institutions such as ASAP (Additional Skill Acquisition Programme) and KUFOS (The Kerala University of Fisheries and Ocean Studies). These partnerships ensure structured and accredited training, enhancing the employability of participants and meeting industry standards.

In addition, CSL extends its support to special education, reinforcing its belief in inclusive development. By supporting institutions and programs catering to the needs of differently-abled children, CSL ensures that education remains accessible to all sections of society.

Through these multifaceted efforts, CSL continues to foster an ecosystem of learning, skill-building, and empowerment laying the foundation for a brighter and more inclusive future.

Transforming walls, empowering education: Construction of Second Floor for Classrooms at SHGUPS, Malipuram, Ernakulam



SHGUPS, Karthedom, located in Malipuram, Ernakulam, has long been recognized for its excellence in both academic and non-academic spheres. As one of the leading upper primary schools in the Vypin sub-district, it has attracted students from various coastal areas. However, the growing demand for admissions had placed significant pressure on the school's infrastructure. Limited classroom space had become a major hurdle, affecting the quality of education, increasing student-teacher ratios, and potentially contributing to student dropouts.

Ernakulam Social Service Society (ESSS) is an organization committed to promoting, supporting, and sustaining the socio-economic and developmental initiatives of the poor and marginalized through social mobilization, empowerment, and decentralization. With a strong presence in the region, ESSS works to uplift vulnerable communities by fostering inclusive development and enabling access to basic services, education, and livelihood opportunities. Cochin Shipyard Limited, in collaboration with the Ernakulam Social Service Society (ESSS), undertook a CSR initiative to construct a second floor comprising four additional classrooms. The intervention was strategically planned to enhance the learning environment and increase the school's capacity to accommodate students without compromising on quality. The construction focused on creating well-ventilated, well-lit classrooms that promote academic focus and overall student well-being.

With the successful completion of the project, the school has seen a remarkable transformation. The new second-floor classrooms have eased congestion in the existing infrastructure and enabled the school to admit more students from the surrounding coastal communities. Teachers now have better space and resources to conduct interactive and engaging sessions. The improved infrastructure has also boosted the morale of both students and staff, leading to a more vibrant academic atmosphere.

"Anchored in Inclusion": Cochin Shipyard CSR Empowering Special Young Minds

Support for Construction of Classrooms including toilet complex for inclusive education at Gayathri Vidya Mandir, Changanassery.



Cochin Shipyard Limited (CSL), through its Corporate Social Responsibility (CSR) initiatives, is dedicated to fostering inclusive growth and uplifting local communities. Recognizing the significance of accessibility in education, CSL has extended its support towards the development of inclusive classrooms at Gayathri Vidya Mandir in Changanassery. This initiative includes the renovation of classrooms and the provision of therapy equipment tailored for children with special needs. The well-structured and accessible learning environment aims to empower differently abled students by enhancing their educational experience and overall well-being. This project is being carried out in partnership with Sukrutham Charitable Trust, an organization that works for the welfare of special children.

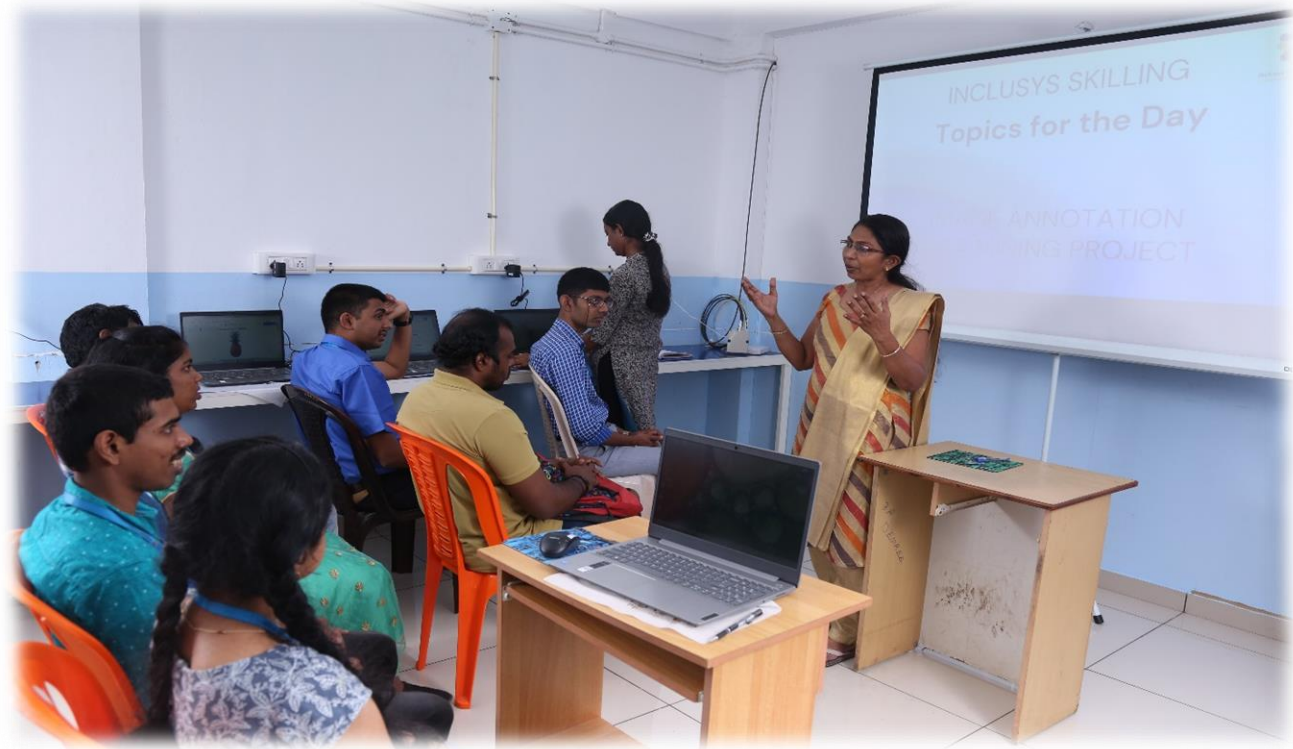
Sukrutham Charitable Trust was founded by a group of socially conscious individuals in the Changanassery Taluk of Kottayam district, Kerala. Officially registered under the Indian Trust Act of 1882 and also under Sections 12A and 80G of the Income Tax Act of 1961 for tax exemptions, the Trust has consistently served as a beacon of hope. It supports individuals with disabilities, those suffering from poverty and illness, and children facing financial challenges.

To address the specific educational needs of differently abled students, Sukrutham proposed a collaborative project with CSL under its CSR program. The primary aim of the initiative is to create a shared learning environment where students of varying abilities can learn together. Instruction is adapted to meet the diverse needs of individual learners, while also encouraging interaction and integration within the community school setting.

This partnership between CSL and Sukrutham Charitable Trust has brought significant improvements to the educational infrastructure for children with special needs. It has enhanced their learning opportunities, supported skill development, and promoted social interaction with mainstream students, fostering better inclusion in both school and society.

The collaboration between Cochin Shipyard Limited and Sukrutham Charitable Trust has led to a transformative impact on the educational experience of differently abled children. Through upgraded classrooms and the availability of specialized therapy equipment, the project has created a more inclusive and nurturing environment. Empower, Enable, Excel: CSL's IT Training for Neurodivergent Talent



Cochin Shipyard Limited (CSL) has undertaken the project 'IT-Based Skill Training for Neurodivergent Individuals' as part of its Corporate Social Responsibility (CSR) initiatives. This project aims to empower neurodivergent individuals by equipping them with essential digital skills, thereby enhancing their employability and integration into the workforce. The initiative is aligned with CSL's commitment to fostering inclusivity and promoting skill development among marginalized communities.

The project is implemented in collaboration with Welfare Services Ernakulam, a well-established organization dedicated to the upliftment of differently-abled individuals through educational and skill development programs. Welfare Services Ernakulam has been instrumental in facilitating the training process, ensuring accessibility, and providing tailored support to neurodivergent individuals. The organization brings extensive experience in working with special needs communities, making it a suitable partner for executing this initiative effectively.

One of the major issues faced by neurodivergent individuals is the lack of access to quality education and skill development opportunities, leading to barriers in

employment and social inclusion. Despite advancements in technology, this segment of society continues to rely on conventional methods for education and rehabilitation. Recognizing this gap, CSL designed this project to create a structured digital ecosystem that not only imparts IT skills but also fosters confidence and independence among neurodivergent individuals.

Under this initiative, a rigorous selection process was conducted to identify 52 neurodivergent individuals with a keen interest in digital applications. The selection process involved skill assessments, personal evaluations, and online entrance tests to understand their aptitude and learning preferences. Training centers were established across five locations—Sanjo Sadan in Thuravoor, Shanthibhavan in Chalakudy, Snehadeepthi in Mannuthy, and Jyothinilayam in Muttikulangara, Palakkad. These centers provided a supportive learning environment where participants were trained in basic computer literacy, programming, data management, digital communication tools, and cybersecurity fundamentals.

A key component of the project was the 'Train the Trainers' program, which ensured that digital coaches were well-equipped to support neurodivergent learners. This ten-day online training provided trainers with specialized knowledge on adapting digital instruction for neurodivergent individuals, thereby enhancing the effectiveness of the program. Additionally, the project incorporated job-readiness modules, including résumé building, interview preparation, and workplace etiquette, to enhance employment prospects for participants.

The outcomes of this initiative have been promising. The trainees have exhibited significant improvements in digital literacy and technical skills, with many demonstrating readiness to take up roles in the gig economy and other employment sectors. The initiative has not only empowered neurodivergent individuals but has also contributed to fostering an inclusive work environment where diverse talents are recognized and valued. As the project progresses, CSL remains committed to expanding its reach, integrating innovative digital interventions, and creating sustainable employment pathways for neurodivergent individuals.

‘Science for her, Hope for all’ : Collector’s Super 100 Project



Education for girl children is a powerful catalyst for social transformation, unlocking their potential and empowering entire communities. Girl students from tribal and coastal regions of Thiruvananthapuram district face significant barriers in accessing quality education, particularly in STEM (Science, Technology, Engineering, and Mathematics) fields. Due to socio-economic challenges, cultural constraints, and geographical isolation, these students often lack the exposure, resources, and mentorship needed to pursue academic and career opportunities in science and technology. This underrepresentation not only affects their individual growth but also limits the overall development of their communities.

In collaboration with the KANAL Innovations Charitable Trust, Cochin Shipyard Limited (CSL) supported the Collector's Super 100 project as part of its CSR initiative. A batch of 25 girl students from Class 9, belonging to tribal and coastal communities, was selected through a rigorous identification process. The program was carefully planned and structured to provide early exposure to STEM education through interactive sessions, conceptual training, and skill-building workshops. It focused on improving scientific reasoning, problem-solving abilities, and academic performance while being sensitive to the girls' cultural and environmental context.

The initiative has empowered the selected students with enhanced scientific knowledge and confidence to pursue STEM studies for higher education. It has sparked interest and motivation among the girls to envision careers in science and technology, paving the way for long-term social mobility. The project contributes to narrowing the gender and regional gap in STEM fields, thereby uplifting not just the individual participants but also contributing to the development of their communities. Deploying Robotic Kits in Schools of Ernakulam and Alappuzha Districts



Scientific learning plays a crucial role in shaping young minds to think critically, solve problems creatively, and adapt to emerging technologies. It lays the foundation for innovation and empowers students to actively engage with the world around them. In the rapidly evolving landscape of science and technology, there exists a significant gap in access to quality STEM (Science, Technology, Engineering, and Mathematics) education among school students, particularly in public educational institutions. Despite a growing emphasis on experiential learning, many schools face challenges such as lack of infrastructure, high-cost equipment, and insufficient training to introduce students to modern technological tools like robotics. This limits the ability of students, especially at the secondary school level, to develop critical 21st-century skills including problem-solving, innovation, and hands-on technical expertise.

To address this gap, CSL, under its Corporate Social Responsibility (CSR) initiative, partnered with Kerala Infrastructure and Technology for Education (KITE) to support the deployment of Robotic Kits in schools across Ernakulam and Alappuzha districts. These kits, based on Open Hardware Arduino Uno platforms, were provided to schools where Little KITEs IT Clubs are functional. Through this initiative, students received access to multipurpose robotics kits along with structured training

and mentoring. Teachers and student club members were equipped with the necessary skills to facilitate learning, build functional robotic models, and explore creative solutions through technology.

The project has significantly enhanced students' engagement with science and technology by providing hands-on exposure to robotics. It fostered a spirit of exploration and innovation among learners and contributed to the development of interdisciplinary skills, including logical reasoning, mathematical applications, communication, and teamwork. By integrating robotics into the school curriculum through Little KITEs Clubs, the initiative has created a sustainable model of technology-led learning. It also empowered teachers and students alike to confidently navigate emerging technological fields, thereby contributing to a future-ready generation.

Pulaya Samskarika Samkhadana, the implementing agency, is a registered organization established in 1961 by families from the Pulaya community in Olanad Karayil, Paravur Taluk, Ernakulam District. The organization has been actively

working towards the educational, economic, and cultural upliftment of its members, who face severe socio-economic challenges. With limited financial resources, the community had initiated the construction of a Knowledge Centre in 2018 but was forced to halt progress due to financial constraints and damages caused by the devastating Kerala floods of the same year. Despite multiple efforts to secure funding from government bodies and other organizations, no significant support was received until CSL stepped in to bridge this gap.

Recognizing the urgent need for intervention, CSL sanctioned financial assistance to complete the remaining construction of the Knowledge Centre under its CSR Development Scheme. The funding facilitated the procurement of essential construction materials, repair of flood-damaged structures, and completion of the office space, knowledge centre, and multipurpose hall. These facilities will serve as vital resources for children and families in the community, enabling access to quality education, skill development, and a dedicated space for cultural and social gatherings.

The successful completion of the Knowledge Centre has significantly transformed the community's educational landscape. Children now have access to a conducive learning environment, and the facility acts as a central hub for community engagement and development programs. This project has not only strengthened the social fabric of the Pulaya community but has also reaffirmed CSL's commitment to inclusive growth and sustainable development. Through such initiatives, CSL continues to contribute towards building a more equitable and empowered society.

To cater to the needs of differently-abled students, Sanjoe Sadan proposed a project in partnership with Cochin Shipyard Limited as part of their CSR efforts. The project aimed to acquire a school bus and physiotherapy equipment. The main objective of this initiative was to provide proper training for children with intellectual disabilities and create an accessible environment, with the school bus ensuring they could easily reach school. Hybrid Solar Boat for State Seed Farm, Aluva



The State Seed Farm, located on an island near Aluva in Kerala's Ernakulam District, is a historic agricultural institution with a legacy spanning over 120 years. Despite being recognized as India's first carbon-neutral organic seed farm in December 2022, it faces a significant operational hurdle due to its geographical isolation. With no direct road connectivity, the farm relies solely on boats for transporting personnel and agricultural goods to and from the mainland. This dependency on conventional fuel-powered boats created logistical challenges and contradicted the farm's eco-sustainable goals.

To address this challenge, Cochin Shipyard Limited, through its Corporate Social Responsibility (CSR) initiative and in collaboration with the District Panchayath, Ernakulam, funded the development and deployment of a hybrid solar-powered boat. This innovative transport solution was designed and technically developed by the Department of Ship Technology at Cochin University of Science and Technology (CUSAT), Kalamassery. The vessel was engineered to operate primarily on solar energy, offering a clean, efficient, and reliable mode of transport for both people and cargo between the farm (Thuruth) and the mainland.

The introduction of the hybrid solar boat has significantly improved the farm's connectivity while aligning with its carbon-neutral objectives. This eco-friendly transportation solution not only eased logistical challenges but also enhanced daily operations without adding to environmental degradation. The initiative reinforced the farm's commitment to sustainability by integrating renewable energy into rural infrastructure. Moreover, it serves as a pioneering example of how CSR can drive green innovation and support climate-resilient development in rural India. The model stands as a replicable framework for similar agricultural and island-based communities across the country.

'From Shelter to Self-reliance'

Support for Construction of Girls' Home for destitute girls.



Destitute girls, especially those who have crossed the age of 18, often face severe challenges in finding secure shelter, access to education, and opportunities for employment. Without proper support, they are at high risk of exploitation, abuse, and continued poverty. The absence of safe, nurturing spaces for such young women impedes their ability to lead dignified, independent lives. There is a critical need for long-term residential facilities that not only provide basic needs but also focus on holistic development, skill building, and empowerment.

Sevasadanam Youth Home (Girls) is a charitable organization dedicated to supporting destitute girl children and young women from economically and socially weaker sections of society. The organization provides shelter, nutritious food, clothing, healthcare, and education. For girls above 18 years of age, Sevasadanam focuses on continued care through vocational training, life skills education, and educational assistance until they attain financial independence. The organization plays a pivotal role in bridging the gap between institutional care during childhood and independent adult life.

As part of its CSR initiatives, Cochin Shipyard Limited has extended financial support for the construction of the first floor of the Sevasadanam Youth Home for Girls. This critical infrastructure will serve as a residential facility for young women above 18 years, enabling them to live in a safe and supportive environment while they pursue higher education, vocational training, or early employment opportunities. The construction is aligned with Cochin Shipyard's CSR focus on community development and women empowerment.

The intervention will significantly enhance Sevasadanam's capacity to support more young women in their transition to self-reliance. With the completion of the first floor, the organization will be able to provide extended accommodation and personalized development plans for girls beyond the age of 18. The project is expected to directly benefit several young women each year by offering them a secure environment, access to training and education, and a pathway to employment and social integration. One of the major challenges identified by the Trust is the lack of care facilities for individuals with special needs, especially after they turn 18. Parents often struggle to provide ongoing care for their differently-abled children, and nearby regions lack institutions that offer the necessary long-term support for such individuals.

To address this gap, the Trust proposed the construction of "Blooming Valley Care Home"—a dedicated facility that would expand their existing services. The aim is to provide a safe, nurturing residential environment equipped with therapy services and occasional training for differently-abled children and adults, particularly for those who have lost their caregivers or are without family support.

The primary goal of this project is to ensure rehabilitation and empowerment of differently-abled individuals by providing a secure and supportive space. It seeks to create an environment where these individuals can live with dignity and access opportunities for personal growth. The mission is to help them become independent, active contributors to society by protecting their rights and integrating them into mainstream life.

This stay home also envisions setting up a strong foundation to ensure equal opportunities in education, training, employment, and social participation for people with disabilities, supported by an effective legal and institutional framework for their protection and development. The collaborative project between Cochin Shipyard Limited and Unarvu Charitable Trust has resulted in the creation of "Blooming Valley Care Home", a safe and inclusive space for differently-abled children and adults. This initiative not only addresses the urgent need for long-term residential and therapeutic care but also empowers individuals with special needs to live independently and engage meaningfully in society. The project has laid the groundwork for ensuring equal rights, social integration, and sustainable rehabilitation for persons with disabilities, ultimately contributing to a more inclusive and compassionate community.

access to structured learning and face the risks of malnutrition, hindering their overall growth.

To tackle this, the project supports well-established "Balwadis" – nurturing daycare centers that offer an informal yet effective learning environment. Here, children learn through engaging play, games, and storytelling, guided by trained "Balasevikas" (teachers) equipped with essential educational materials. A cornerstone of the initiative is the provision of nutritious food for 315 days annually, including a morning malt drink, a balanced midday meal, and a protein-rich evening snack, ensuring the children receive the nourishment crucial for healthy development.

Recognizing the central role of educators, the project incorporates annual refresher camps and training for both new and experienced Balasevikas. These programs focus on enhancing their teaching skills, including practical methods for creating affordable teaching aids, and cultivating values like patriotism, strong character, and community spirit. The project also actively fosters community engagement through the celebration of national and cultural events, promoting unity and involving parents, local leaders, and schoolteachers, positioning the Balwadi as a vital community hub.

The impact of this initiative is profound and multifaceted. Regular medical check-ups and careful monitoring of children's height, weight, and upper arm circumference facilitate the early detection and prevention of malnutrition. Teachers conduct both formal and informal assessments to track the children's cognitive and language development. Furthermore, by encouraging interaction among children from diverse backgrounds and celebrating community events, the project actively promotes communal harmony, a significant aspect in the region. Regular home surveys and parent meetings ensure a strong connection between the Balwadi and the home environment, reinforcing positive habits and values. Witnessing the positive outcomes firsthand fuels our continued commitment to this vital initiative, grounded in the belief that investing in early childhood is an investment in a brighter future for everyone. These technologies help trainees develop better hand-eye coordination, a crucial skill for welding. The RRF enables scientific sorting, segregation, and processing of plastic waste, while ensuring it is forwarded to certified channels for recycling and responsible disposal. The facility also offers dignified, stable employment to individuals from underprivileged backgrounds, ensuring a people-centric approach to sustainability.

The RRF has transformed waste management in Kochi by enabling 100% segregation and processing of collected dry waste, thereby eliminating the need for landfilling and significantly reducing environmental pollution. It supports the principles of a circular economy by recovering resources and reducing reliance on virgin materials, ultimately cutting down greenhouse gas emissions. The project also prioritizes worker safety, offering traceable waste management systems and promoting the health and well-being of its workforce. Furthermore, it provides secure employment and income generation opportunities for marginalized communities, making environmental sustainability socially inclusive.

Recognizing the urgency of the situation, the Grama Panchayat has proposed the demolition of the existing structure and the construction of a new, well-equipped Ayurvedic dispensary. This project aligns with CSL's objective of uplifting marginalized communities by improving healthcare infrastructure and ensuring holistic development.

The construction of a new Ayurvedic dispensary in Kalloorkad will significantly enhance the healthcare infrastructure of this rural region. With improved facilities and a safe, hygienic environment, the dispensary will be able to offer better quality treatment and cater to a larger number of patients, particularly those from BPL families who rely heavily on affordable healthcare options. In the Andaman & Nicobar Islands, CSL partnered with Amrita Heartcare Foundation to fund pediatric heart surgeries for ten children from economically challenged backgrounds diagnosed with congenital heart disease. These children received comprehensive cardiac care, including surgery and follow-up, significantly improving their health and quality of life.

CSL views these islands not just as remote regions, but as critical nodes in India's maritime security, biodiversity, and blue economy. By contributing to their development, Cochin Shipyard aligns its CSR vision with its professional ethos – strengthening the very maritime framework it thrives within. This alignment ensures that CSL's contributions are not only socially relevant but also strategically sustainable, bringing long-term value to the island populations.

"Saving Little Hearts"

Amrita Heartcare Foundation & Cochin Shipyard Ltd. Unite to Provide Life-Saving Pediatric Cardiac Surgeries for Underprivileged Children."



Port Blair, situated on the southeastern coast of South Andaman Island, is isolated from the mainland. The island faces transportation challenges due to its numerous clusters of islands and its lack of adequate transportation for the patients requiring medical services and treatments. With the limited medical services and infrastructure the patients often struggle to reach out the health care services.

Advancements in healthcare have led to increased detection of congenital heart disease (CHD) in children across India. However, many families from economically disadvantaged backgrounds cannot afford life-saving cardiac surgeries. This financial barrier often results in delayed treatment, causing severe health complications or death. Addressing this issue is essential to ensure timely care and improve the chances of a healthy life for affected children.

Many underprivileged families struggle to afford pediatric heart surgeries, despite the availability of advanced medical care. For recognising this issue Amrita Heart care foundation (AHF) is a non- profit foundation constituted as a public charitable trust on January 2020 and is registered under section 12 A of the IT Act 1961 and has obtained approval under section 80 G of the act also. They enable fund heart surgery for poor and needy children with heart disease at the paediatric cardiac program of AIMS Cochin.

By underpinning this, Dr. R. Krishna Kumar, trustee of Amrita Heartcare Foundation, partnered with Cochin Shipyard Ltd. Through their CSR program, Cochin Shipyard covers 75% of the cost for pediatric heart surgeries for economically disadvantaged children.

Under this CSR initiative, Amrita Heartcare Foundation provided comprehensive cardiac care for ten children with congenital heart defects, identified through screening camps and referrals to AIMS Cochin which was supported by Cochin Shipyard Limited CSR. The project covered pre-operative, surgical, post-operative, and follow-up care, offering families access to quality treatment without financial burden.

The project significantly improved the health of the children who received heart surgery, with many showing enhanced cardiac function and overall physical development. These interventions enabled them to lead near-normal lives without continuous medication. This CSR initiative not only transformed lives but also highlighted Cochin Shipyard Ltd.'s commitment to addressing critical healthcare needs through partnerships, paving the way for future collaborations in pediatric cardiac care.

Rides for Relief : Provision for Medical Ambulance to Dialysis Centers

Lakshadweep, being a geographically isolated region, faces significant challenges in accessing healthcare services. The island communities often struggle with transportation for critical medical treatments, particularly for patients requiring dialysis. Recognizing this gap, Thanal Charitable Organization, based in Kavaratti, has been at the forefront of providing essential healthcare services, including free dialysis treatments. However, the need for reliable medical transportation remained a pressing concern, particularly for residents of Androth and Amini Islands who required consistent access to the dialysis centers. The absence of dedicated medical transport facilities for dialysis patients posed a severe challenge to healthcare

accessibility in Androth and Amini Islands. Patients had to rely on inefficient and often unavailable means of transport, leading to delays in treatment and an increased risk of medical complications.



The lack of emergency response services further exacerbated the healthcare crisis, making it crucial to introduce a sustainable solution to bridge this critical gap. To address this pressing issue, Thanal Charitable Organization sought corporate support to enhance its healthcare services. Recognizing the impact of Thanal's initiatives, Cochin Shipyard Limited (CSL), as part of its Corporate Social Responsibility (CSR) commitment, provided two ambulances to support the operations of the dialysis centers. This intervention was a result of a collaborative effort involving multiple stakeholders, ensuring the effective deployment of medical transport services. The initiative significantly strengthened the healthcare framework in the region by facilitating timely and safe transportation for dialysis patients. The provision of two ambulances has greatly improved medical accessibility for residents of Androth and Amini Islands.

The new ambulances have enabled timely emergency response and uninterrupted access to dialysis centers, significantly reducing the health risks associated with treatment delays. This initiative stands as a testament to the positive outcomes achievable through corporate partnerships in community development. Both the local communities and CSL representatives have expressed their satisfaction with the project, acknowledging its role in enhancing the quality of life for the people of Lakshadweep. The successful implementation of this initiative marks a significant milestone in healthcare development and reaffirms the commitment of Thanal Charitable Organization and CSL towards improving medical infrastructure in the region.

Redifining Infrastructural Facilities : " A Pathway towards National Progress"

Renovation and Repairs for Kalyan Ashram Goa's Panchaseel English High School and Shree Santeri Bhagwati Boys Hostel.



Education is a cornerstone upon which any nation's progress is built. It empowers individuals, transforms communities and ultimately drives the growth and prosperity of the entire nation. Providing them quality educational facilities like the infrastructural development helps the students to acquire enough knowledge from the appropriate environment.

Goa is a state that have a large number of Scheduled Tribes or Janajati Community which happens to be the integral part of the Indian Society in Social, cultural, Material, Moral, Economic, Intellectual and Educational field and to unite them on the basis of Indian culture and Indian values. Goa has 12% of it's population as tribal and is prominently placed in South Goa.

The Kalyan Ashram Goa, a non-governmental organization, has successfully addressed the educational needs of tribal students in remote areas. In 2011, it adopted Panchsheel English High School in Ponda Taluka, which was on the verge of closure, with only 15 students enrolled. Through various efforts, the student enrollment increased, leading to a need for extra classrooms. However, the current facilities, including school classrooms and hostel rooms, are insufficient to accommodate the growing number of students. The organization also operates a residential institute and hostel to support boys and girls from single-parent families or low-income backgrounds, ensuring access to education for those in need.

To bridge this gap , Kalyan Ashram Goa sought Corporate support to enhance it's Infrastructural development. In response to it Cochin Shipyard Limited as part of its Corporate Social Responsibility commitment stepped forward to support the request that was initiated by Kalyan Ashram. Through the multiple visits the need for infrastructural development was evident. Acknowledging the need Cochin Shipyard Limited supported in improving the infrastructure including furniture, smart class rooms, improved class rooms, painting etc. An equal amount to be embarked for creating infrastructure outside the school including stage, play ground and equipments.

Safe Drinking Water – A Gift of Health and Hygiene

Potable Drinking Water Supply Initiative



Cochin Shipyard Limited (CSL) recognizes access to potable drinking water as a fundamental necessity for human well-being. The project areas near the Bay of Bengal face acute water scarcity due to high salinity levels, making access to safe drinking water a significant challenge. With groundwater only available at depths of 1000 to 1200 feet, the construction of deep tube wells is beyond the financial reach of individual households. Additionally, numerous tube wells installed by local Gram Panchayats are defunct, exacerbating the crisis. The non-availability of safe drinking water also impacts sanitation and hygiene, leading to increased health risks among the local population. Given these concerns, CSL took the initiative to address this pressing issue through its Corporate Social Responsibility (CSR) program.

The target villages, namely Durbachati, Paschim Surendranagar, and Krishnapur in the Patharpratima block, suffer from severe freshwater shortages. The primary sources of domestic water, such as ponds, are unsuitable for drinking due to contamination and salinity intrusion. The affected communities, comprising a total of 1,697 beneficiaries, were compelled to travel long distances to access potable water. The scarcity of clean water not only posed serious health risks but also disproportionately affected women and children, who were primarily responsible for collecting water.

In collaboration with South Sundarban Janakalyan Sangha (SSJS), CSL funded the installation of three deep tube wells across the identified villages. The installation process ensured that the tube wells were elevated to mitigate the risks of flood-induced contamination, as evidenced by the destruction caused by cyclones Amphan (2020) and Yaas (2021). Community awareness programs were conducted alongside the installation to educate villagers on hygiene practices and the importance of safe drinking water. By strategically placing these wells within the villages, CSL aimed to reduce the burden on community members who previously traveled long distances for water.

The installation of these three tube wells has significantly improved access to safe drinking water, benefiting 1,697 individuals. Women and children no longer need to travel long distances to fetch water, thereby saving time and effort. The availability of potable water has contributed to improved sanitation and reduced instances of waterborne diseases, leading to better overall health in the community. Additionally, the intervention has fostered community empowerment by promoting awareness of hygiene and sanitation practices. The success of this initiative has also spurred further demand for similar interventions in neighboring areas. Cochin Shipyard Limited remains committed to supporting sustainable community development through such impactful CSR initiatives.

Saral services DIGIKUL: Skill development in Digital technologies for creating waves of knowledge and skill for enhancing access to Livelihood.



In India, 71% of women own a mobile phone, compared to 83% of men, with only 30% of women's phones being smartphones. Women's mobile internet usage has stalled at 30%, while men's usage has increased from 45% to 50%, especially in rural and disadvantaged areas. In Bihar, the unemployment rate is 17%, significantly higher than the national average of 7.6%, resulting in 60 lakh unemployed individuals.

Saral Services was established to bridge the digital divide gap, by utilizing digital monitoring systems with desktops, laptops, mobile phones, and tablets. Since 2009, it has been working in Nalanda, focusing on marginalized communities, particularly students from underprivileged backgrounds in government schools and colleges.

The key objectives of this particular initiative that was carried out by Saral Services was to impact the livelihoods of 50 youths by imparting digital skills, mobilizing work

opportunities and thereby, enhancing their employability. To bridge this gap Saral Services sought Corporate support to accomplish this goal. The idea that digital access will improve learning and impact earning of the youth originates from the combined grassroot experiences of Saral Services and Cochin Shipyard Limited.

During 2023-24 CSR, Cochin Shipyard Limited (CSL) supported initiative known as DIGIKUL of Saral Services in Nalanda. In this project CSL provided 10 computer systems and furniture to strengthen the digikul training centre for training youths in digital skillset. In addition to that , CSR also supported the resource cost of the trainers.

Through this collective effort that was initiated by Cochin Shipyard Limited and Saral Services reaffirms the commitment towards Digital enhancements in the region Bihar of India's most underserved regions in terms of digital infrastructure. However, skill development initiatives have allowed individuals from marginalized communities to bridge this gap, giving them access to essential. This inclusion helps reduce the digital divide and ensures that marginalized groups are not left behind in a rapidly digitizing world.

Cochin Shipyard Cares: "A CSR Initiative for Health Equity"

Enhancing Healthcare Infrastructure at CHC Tambour, Sitapur



The Community Health Center (CHC) located in Tambour, Sitapur, Uttar Pradesh, serves as a crucial lifeline for the local population, particularly the underprivileged sections of society. Despite its vital role, the center grapples with a persistent and critical challenge: the lack of adequate healthcare infrastructure, most notably the absence of private ward facilities. This deficiency has led to several pressing issues, including overcrowding, compromised patient privacy and comfort, insufficient critical care provisions, and limited access to quality healthcare.

To address these long-standing issues, the Promising Indian Society—an organization dedicated to transforming lives through initiatives in education, healthcare, and livelihood generation—has undertaken a project to strengthen the CHC's infrastructure. Established in 2017 and registered under the Indian Trust Act, 1882, the Society is committed to making a global impact through its grassroots initiatives.

In alignment with its Corporate Social Responsibility (CSR) mandate, Cochin Shipyard Limited has extended support to this project, recognizing the opportunity to make a meaningful difference in the lives of the people in Tambour, Sitapur. The primary objective of the initiative is the construction of two fully equipped ward rooms at the CHC. These new wards are intended to enhance patient care and address the growing healthcare demands of the region.

This collaborative effort represents more than just infrastructure development—it symbolizes a shared commitment to community welfare and sustainable development. By alleviating the infrastructural constraints at the CHC, the project is poised to significantly improve the quality of healthcare services, thereby uplifting the overall well-being of the local community.

Breaking Barriers, Building Futures – CSL’s Commitment to Education



TARPAN Foundation Orphan Student Scholarship: A CSR Initiative by Cochin Shipyard

Education is a fundamental right and a key driver for social and economic progress. However, orphaned children often lack the necessary financial and emotional support to pursue education, making them vulnerable to poverty and social exclusion. Recognizing this critical need, Cochin Shipyard, through its CSR initiative, partnered with the TARPAN Foundation to provide scholarships for orphaned students in Maharashtra. This initiative aligns with our commitment to empowering underprivileged communities and ensuring inclusive growth.

Orphaned children, upon turning 18, are often required to leave their orphanages without adequate financial security or guidance. Many of them lack access to higher education, proper career counseling, and emotional support, limiting their

opportunities for a stable future. Additionally, the absence of structured interventions in education and skill development hampers their integration into mainstream society, leading to unemployment and socio-economic hardships.

To address these challenges, Cochin Shipyard extended financial aid through the TARPAN Foundation to support the education of orphaned students. This initiative facilitated scholarships for 53 students, enabling them to enroll in various educational programs suited to their skills and interests. In addition to financial assistance, the program provided mentorship, career guidance, and training in cultural values and ethics. Other supportive measures included the distribution of essential study materials such as tablets, mobile devices, sweaters, and raincoats to ensure a conducive learning environment.

The initiative has yielded significant positive outcomes. All 53 supported students successfully enrolled in higher education programs, securing opportunities that would have otherwise been inaccessible. The financial assistance helped improve their academic performance, as they could focus on studies without the burden of financial constraints. The program also contributed to their personal growth, fostering self-confidence and resilience among the students. Many beneficiaries have expressed aspirations for promising careers, demonstrating a newfound optimism about their future. This initiative has not only transformed individual lives but also contributed to broader societal development by ensuring that vulnerable youth become self-reliant and empowered members of society. Cochin Shipyard remains committed to such impactful initiatives that drive meaningful change in the lives of those in need.

Building Bright Beginnings : Construction of Anganwadi Building at Padukere – Malpe, Karnataka by Palli Srinivas Hegde Charitable Trust.



Early childhood education lays the foundation for lifelong learning, cognitive development, and social well-being. Ensuring safe and supportive environments during these formative years is crucial for nurturing young minds and unlocking their full potential. The Anganawadi school building at Padukere, managed by Sri Ramamitra Bhajana Mitra Mandira, has been serving poor and backward-class children from the local fishing community for over five decades. Despite its historical impact, the current structure is in a depleted condition, posing challenges to the safety and learning environment of the children. There is an urgent need for

reconstruction to ensure continued access to early childhood education in a secure and conducive setting.

Sri Ramamitra Bhajana Mitra Mandira is a community-based organization that has been actively involved in educational and cultural initiatives in the Padukere area. In partnership with the Department of Education, Government of Karnataka, the Mandira established and has successfully run the Anganawadi center for more than 50 years, primarily serving underprivileged children of the fishing community.

In response to the request for support, Cochin Shipyard Ltd. – Udupi unit visited the site to assess the condition of the Anganawadi. The visit was conducted in collaboration with Palli Srinivas Hegde Charitable Trust, an NGO with a track record in the education sector in Udupi district. The trust expressed its willingness to support the construction of new classrooms under the CSR initiative of Cochin Shipyard, aiming to enhance the learning environment and infrastructure.

The construction of the new Anganawadi building at Padukere has been successfully completed under the CSR initiative of Cochin Shipyard Ltd. – Udupi unit, in collaboration with Palli Srinivas Hegde Charitable Trust. The new facility includes well-ventilated classrooms, child-friendly infrastructure, and essential learning amenities. The upgraded building has significantly improved the learning environment, enabling over 50 children from the local fishing community to access quality early childhood education in a safe and welcoming space. The initiative has been well-received by the local community and has encouraged greater enrolment, reflecting the project's positive social impact.

‘Strengthening roots of learning’

Construction of Classrooms at Government Higher Primary School, Hangarakatte, Udupi District, Karnataka

Quality education is essential for the holistic development of students and forms the foundation of an equitable and progressive society. However, many government schools, especially those in rural areas, continue to struggle with inadequate infrastructure, which directly impacts the learning experience. The Government Higher Primary School in Hangarakatte, Udupi, a nearly 100-year-old institution, was facing severe infrastructure challenges. Several of its old classrooms were in a dilapidated state, posing safety risks to students and affecting the overall learning environment.



Established in 1924, the Government Higher Primary School, Hangarakatte, serves around 500 students from Classes 1 to 8. This Kannada-medium school is located beside the Cochin Shipyard Limited (CSL) production unit in Udupi. Despite its long-standing legacy and dedicated staff of 6 permanent teachers and 1 guest teacher, the school had been grappling with deteriorating classroom infrastructure. Recognizing the urgency of the situation, CSL and the Palli Srinivas Hegde Charitable Trust came together to support the school under a CSR initiative.

Following a visit to the school by representatives of Cochin Shipyard Limited, Udupi, and the Palli Srinivas Hegde Charitable Trust, the decision was made to construct three new classrooms to replace the unsafe structures. The intervention was designed to ensure that students have access to a safe, hygienic, and conducive environment for learning. The NGO, in collaboration with CSL, undertook the complete construction process, from planning and design to execution.

The construction of three new classrooms has been successfully completed and handed over to the school. The new infrastructure has significantly improved the learning environment, ensuring safety, comfort, and better engagement for the students. Teachers have also reported a positive change in classroom management and student participation. This project stands as a successful example of CSR partnership contributing to the strengthening of public education, ensuring that children in rural areas are not deprived of their right to quality learning spaces.

Enhancing Infrastructure for Spiritual and Personal Development at Vipassana Centre



As part of its Corporate Social Responsibility (CSR) commitment to fostering community well-being, Cochin Shipyard Limited (CSL) has supported the expansion of the Vipassana Centre at Kasane, Mumbai. This initiative focuses on enhancing the kitchen and dining facilities to accommodate a growing number of participants, particularly individuals from marginalized communities. By improving the infrastructure, the project aims to create a more inclusive and conducive environment for meditation and personal development.

Vipassana meditation has been widely recognized as a transformative practice that fosters emotional resilience, mental clarity, and holistic well-being. However, the Centre faced challenges in catering to the increasing number of participants due to limited kitchen and dining capacities. Many of the attendees, particularly those from Scheduled Caste (SC) communities, rely on the Centre for structured meditation courses that support their personal and spiritual growth. The lack of adequate facilities was a significant barrier to providing an uninterrupted and enriching experience.

Recognizing this challenge, CSL took proactive steps to support the expansion of the kitchen and dining facilities, ensuring that the Centre could continue to serve a larger population effectively. This intervention included upgrading the existing infrastructure, enhancing the efficiency of meal preparation, and providing a comfortable dining experience for all participants. By facilitating these improvements, CSL has directly contributed to the Centre's mission of promoting mental well-being and self-development among disadvantaged communities.

The outcomes of this initiative have been highly impactful. The newly expanded facilities have significantly improved the Centre's capacity to accommodate more individuals, allowing them to benefit from the Vipassana courses without logistical constraints. Participants now have access to a well-equipped space that fosters a sense of community and mindfulness, reinforcing CSL's commitment to sustainable and meaningful social development. Moving forward, the completion of

the remaining work, certified by a Licensed Civil Engineer and recommended by CSL's CSR team, will ensure the long-term effectiveness of this project in enriching lives and empowering communities through meditation and learning.
