Subject: Study visit of Department- related Parliamentary Standing Committee on Industry to Visakhapatnam, Kolkata and Srinagar from 31st Oct., 2023 to 04th Nov., 2023-reg.

Sir/Madam,

Reference is invited to the observations made by the **Department- related Parliamentary Standing Committee during its subject visit from 31st Oct., 2023 to 04th Nov., 2023. It may be noted that** All Central Public Sector Undertakings are mandated to procure 25% (as amended in 2018) of their annual value of goods or services from Micro and Small Enterprises as per Public Procurement Order for Micro & Small Enterprises (MSEs). The Policy also mandates **4% procurement from SC/ST entrepreneurs and 3% procurement from women entrepreneurs** out of the 25% procurement from MSEs. The overall procurement targets from SC/ST entrepreneurs and women entrepreneurs is yet to be met.

2. It has been observed that while some CPSEs have been able to meet the targets and sub-targets under the Policy, most CPSEs are unable to meet the Policy targets. In this regard, greater coordination among CPSEs is required and the CPSEs who have been able to achieve the targets are requested to kindly share their best practices for the benefit of all. Additionally, all CPSEs are requested to kindly deliberate and give their suggestions on measures which may be undertaken to increase procurement from MSEs, particularly, women and SC/ST MSEs.

3. As an additional step, an integration and synchronization of the efforts of CPSEs with the efforts of field offices of MoMSME may be put in place, so that more MSEs owned by SC/ST and women entrepreneurs can be benefitted.
