A. Scope of work

- Provide hotel accommodation for 80 sailors of an Indian Naval vessel in AC double room with attached toilet/bath and basic amenities for a tentative duration of 485 days extendable upto 90 more days tentatively starting from end of December 2024.
- Provide galley with dining room suitable for 80 sailors at the hotel premises for a tentative duration of 485 days extendable upto 90 more days tentatively starting from end of December 2024. Galley and dining area should have the following facilities.
- i. Heavy duty industrial burners 08 nos.
- ii. Hot plates 01 no.
- iii. 25 AMP socket 03 nos
- iv. Deep freezers (500 ltrs) 02 nos
- v. Refrigerator (250 + ltrs) 02 nos
- vi. Industrial washing machine 01 no
- vii. Dryer 01 no
- viii. Vegetable chopping table 01 no
- ix. Commercial grinder 01 no
- x. Exhaust fan 01 no
- xi. Microwave oven (34 ltrs) 01 no
- xii. Bread Toaster (06 slice) 01 no
- xiii. Separate store rooms for fresh and dry provisions 01 AC and 01 non AC.
- xiv. Scullery area (for washing utensils) and kitchen sink.
- xv. Suitable space and power supply to install 01 industrial washing machine.
- xvi. Dining facility with minimum 06 dining tables and 24 dining chairs. Dining facility should have wooden separation.
- xvii. Arrangement for daily disposal of dry and wet waste.
- xviii. Provision of adequate waste baskets at kitchen and dining area.
- xix. 01 number RO purified drinking water in dining/galley space



B. Prequalification criteria

- 1. The hotel should be located within a distance of 10 kilometers from CSL.
- The hotel should have the capacity to accommodate minimum of 80 personnel in a single premises (an undertaking as per annexure III to be submitted along with technical bid).
- 3. The bidder should be in the business of providing lodging facility. Necessary documents in proof to be submitted along with the technical bid.
- 4. The firm should have access to the hotel for commutation of minimum 27 seater buses.
- CSL shall conduct a site visit and shall evaluate the facilities and readiness of the hotel to provide the services as per scope of work. Based on the evaluation the suitability shall be decided.

C. Terms and Conditions

- Galley/dining facility shall be utilized for preparation of 03 major meals and 02 tea/snacks for 80 personnel in a day for entire duration. All rooms should have adequate tables & chairs, lockers, linen, mattress, bed sheets, pillow covers, blankets, hot water etc.
- 2. Housekeeping of all rooms is to be undertaken once in a day and dining hall, recreation facility etc. is to be undertaken twice in a day.
- 3. LPG at galley is to be arranged by the hotel through authorised distributor. Payment for LPG cylinders shall be made on actuals based on certification of usage by ships officer.
- 4. Power and fresh water supply at the facility is to be provided 24 hrs without any interruption.
- 5. Drinking water is to be provided to all inmates without restrictions
- Accommodation and galley with dining facility is required for a tentative duration of 485 days extendable upto 90 days as per the same rate, terms and conditions at the discretion of CSL.
- 7. The facility shall be inspected by ship staff and CSL rep. from time to time and minor requisites if any will have to be catered.
- 8. Rate is to be quoted as per the rate format placed at annexure II. Rate per head per day is to be quoted under table A for providing accommodation and rate per day is to be quoted under table B for providing galley with dining room and other facilities.

- 10. Total number of personnel mentioned is indicative and may vary. Payment shall be made for actual occupancy on monthly basis (actual number personnel for actual days occupied) within 30 days of receipt of invoice at CSL.
- 11. Vendor details to be submitted as per annexure IV.
- 12. Cochin Shipyard Limited reserves the right to reject any or all the offers without assigning any reason whatsoever.
- 13. Cochin Shipyard Limited reserves the right to award the contract to one or more contractors during the pendency of this contract, depending upon the actual necessity.
- 14. Price bid of technically acceptable firms will only be considered for opening.
- 15. CSL reserves the right to terminate the work order at short notice in case the firm's performance is found not satisfactory with regard to compliance of contract conditions. No claim whatsoever will be entertained by CSL on this account.

- 3. Bid is to be submitted in two bid system [in two attachments with password protection-Technical bid (attachment A) & Price bid (attachment B) in PDF format only.
- 4. The bidder is expected and deemed to have read, understood and agreed to all instructions, forms, terms and specifications etc. in the tender document while bidding.
- 5. Failure to furnish all information required or false/ambiguous information or submission of bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of the bid.
- 6. All pages of the offer (including all supporting documents/attachments) should be signed by the authorized signatory of the bidder in acceptance of tender conditions and
