CORRIGENDUM NO.2

Sub: Corrigendum No.2 Dated: 16/04/2025 for 'BLASTING AND PAINTING OF HULL BLOCKS& OTHER OUTFIT ITEMS OF SHIPS USING PAINT SHOP FACILITY AT CSL, KOCHI'

1. Subsequent to the above, CSL here by amends/incorporate clauses for tender enquiry as following (*changes are highlighted in Blue and Bold-Italics*) :

CLAUSE NO.	AMENDMENT
Clause 2.1 of Annexure III (Read as)	The scope of work under this contract shall be surface preparation and painting of hull blocks of ships and other types of vessels, steel structures / components / blocks / pipes / fittings etc. in the Marine coating shop and SSD Paint coating shop as per the technical specifications, scope of supply & obligations and safety rules for contractors. <i>This shall include all the activities from cleaning the blocks before blasting, to the final survey acceptance after painting.</i>
Clause 5 (a) of Annexure III (Read as)	Paint brushes, rollers, man coolers, inspection equipment like telescopic mirrors, DFT gauges etc., <i>24V lamp for lighting</i> , power tools and hand tools for cleaning and preparation of rusted/ damaged surfaces to the required standards.

<p>Clause 5 (h) of Annexure III</p> <p>(Read as)</p>	<p>The contractor will be responsible for the daily upkeep and operation of equipments required for blasting and painting. Spares for maintenance will be supplied by CSL on request. Major breakdowns of equipments shall be attended by CSL.</p>
<p>Clause 5 (i) of Annexure III</p> <p>(Read as)</p>	<p>The contractor shall erect and dismantle the scaffolding required for blasting and painting in compliance with CSL standards. The required scaffolding material will be provided by CSL.</p>
<p>Clause 7 (f) of Annexure III</p> <p>(Additional Clause)</p>	<p>Scaffolding materials will be provided by CSL. However, the erection, dismantling and process of getting the scaffoldings approved by the safety dept. shall be under the scope of the contractor.</p>
<p>Clause 7 (g) of Annexure III</p> <p>(Additional Clause)</p>	<p>High pressure washing machines will be provided by CSL for the purpose of fresh water washing of the blocks.</p>

2. Except the above, all other terms and conditions of the tender & Corrigendum No.1 will remain unchanged.
