Corrigendum – 3

- The following clause is added as clause no. 9.4 of 'Notice Inviting Tender':
 - Subsidiaries of foreign companies which are registered in India and having establishment towards providing required services in India are allowed to participate in this tender. Such entities can participate either on the basis of their credentials (Technical & Financial) or on the basis of the credentials (Technical or Financial) of their parent company as per the 'Minimum Qualification Criteria' applicable for this tender.
 - If an Indian company claims the Work Experience criteria and/or Financial Criteria like Turnover, Net worth etc. on the basis of its Foreign Principals, the firm can participate in the tender subject to submitting documentary evidence to prove that Foreign company has a minimum of 75% shareholding in the Indian company. In addition, the foreign principal must submit an undertaking as per **Encl: 1** to provide all required technical knowhow and financial assistance to Indian firm for successful completion of the project including defect liability period.
- The following clause is added as clause no. 9.3 (g) and 9.3 (h) of 'Notice Inviting Tender':
 - In case bidder does not own covered fabrication facility with sufficient floor space equipped with plasma / CNC cutting facility, welding equipment, crane facilities etc., then the bidder may hire such a facility for the fabrication of trestles & keel beams. In such case, a Memorandum of Understanding (MoU) or an agreement between the bidder and the firm providing such facilities shall be submitted along with the offer. Details of the fabrication facility shall be submitted along with the offer. If the bidder becomes successful and the work is awarded to them, then the MoU shall be converted into an agreement and details to be shared with Employer later.
 - Since this tender pertains to a short-term contract, a change of fabrication facility will not be entertained. However, if the same is necessitated due to reasons beyond the reasonable control of contractor, the change of fabrication facility can be approved by the Engineer, provided the contractor hires an equivalent facility matching the contract requirement.
