Subsequent to the subject RFP, Corrigendum – 1dated 28 May 2025 and Corrigendum – 2 dated 18 June 2025, please find below clarifications regarding submission of documents and amendment pertaining to extension of tender submission date and tender opening date/time:

(i) Annexure 2 Appendix 2, SI 8, 9, 10 & 11 - Submission of documents

- Completion certificate issued by the Client organization for whom the jobs have been executed by the bidder with requisite details such as nature of the job, executed value etc


Copy of the Payment certificate/evidence of payments made against the contract/ purchase order. (Certification of CA/Statutory Auditor shall also considered as evidence of payment)

READ AS

1) Copy of the letter of award/Contract/Purchase order showing scope of the work.











- 2) Completion certificate issued by the Client organization for whom the jobs have been executed by the bidder with requisite details such as nature of the job, executed value etc.
- 3) Copy of the Payment certificate /evidence of payments made against the contract/purchase order. (Certification of CA/Statutory Auditor shall also considered as evidence of payment)

Or

In case the consultant is not legally permitted to disclose details of any of the above documents due to confidentiality clause included in the respective contracts, self-certificate from Managing Director/CEO is to be submitted indicating details of scope of work, date of award of work, date of completion, value of order and payment details. The firm shall also submit certificate issued by Chartered Accountant to ensure authenticity of the information over and above MD/CEO self-certificate.

The above clause shall supersede clarification given in the respective clauses in Corrigendum1 dated 28 May 2025.

(ii) Newly Added: Clause No. 11 - Resource Requirements (Annexure - 1, Instruction To Bidders And General Terms & Conditions)

The Bidder shall deploy a team comprising of personnel meeting the prescribed eligibility criteria as specified at Note II of Annexure II, Appendix-2 of the RFP.

Bidders to be noted that no additional cost shall be paid for additional resources, if any, above the mandatory resources as specified in this RFP, that may be essential for proper and effective functioning of SPMO to fulfill the scope outlined in this RFP, regardless of the number of initiatives CSL may undertake at its discretion during the contract term. Also, it is the responsibility of the bidder to ensure that adequate resources are deployed beyond the minimum requirements specified in this RFQ, to successfully execute all initiatives to CSL's satisfaction, without any additional cost to CSL.

(iii) Optional Price Format as per Encl. A to be filled & submitted along with the Price Bid Format in a sealed envelope. Un-priced bid for optional service shall also be submitted as part of technical offer.



(iv) The tender submission and opening date/time are amended as follows:

Tender submission date &time: 15th July 2025 before 1500 Hrs.

Tender opening date & time: 15th July 2025 at 1530 Hrs.

2. All other terms and conditions and scope of services shall remain the same.
