#### Similar Supply means:

Supply of Steel Pipes/ Elbow of ASTM A106 Grade B/ AH 36 or Equivalent Grade Certified for AH 36with IRS certification for State/Central Govt., Shipyards, MNCs or similar etc. within the last 5 years, ending last day of month previous to one in which applications are invited (Copy of PO along with the delivery challan/Invoice is required).

ii. Audited Balance sheets showing turnover, Profit & Loss account of the firm for the preceding 03 years (2021-22, 2022-23, 2023-24) should be submitted along with the application for prequalification.

iv. The Tenderer should enclose copy of MSME Certificate in relevant field (if applicable), PAN, GST registration certificate, Income tax returns for last three FY (2021-22, 2022-23,2023-24).

v. Offers from joint ventures/consortium will not be accepted.

vi. Net worth of the bidder must be positive as per the latest balance sheet. (MSME/NSIC will get exemptions)




