- 2. The pre-bid meeting will be held on 20.03.2023 at IAC Conference Hall of CSL from 14.00 PM. to discuss the detail scope of work of the tender. The contractors are requested to depute their representative to attend the Pre bid meeting to assess the condition of the Geysers on board INS Vikrant prior to submitting the offer.
- 3. Contractors who have deputed representative for pre bid meeting only will be considered for submission of offer.
- 4. Information to participate in pre-bid meeting and queries, if any should be forwarded in time to following mail ID: <u>pradeep.k@cochinshipyard.in</u> with a copy to <u>vidhu.s@cochinshipyard.in</u>
- 5. The tenders are to be submitted in two bid system; **Part I : Techno Commercial Bid** and **Part II : Price Bid** as Soft copy and should reach the undersigned on or before the date and time as stipulated:

6. MODE OF SUBMISSION OF BIDS

- Tender should be submitted in soft copy via E-mail only. CSL will not accept any other mode of tender considering prevailing COVID -19 SOP of CSL.
- The subject of the E-mail should clearly state the tender enquiry number and due date of submission. **Price Bids are to be password protected** and password is not to be forwarded unless asked for.
- Tender Documents should be submitted in PDF Format and Directly openable from the PDF format. Offers not complying with the above shall be summarily rejected without further intimation.
- Tenders, Techno- commercial bid (Part-I) and Price bid(Part -II) shall be submitted separately via e mail to:

- 7. The Bids shall be received at Cochin Shipyard Ltd on or before 14.00 Hrs on 23rd March 2023 and Part I Techno-Commercial Bid will be opened at 14.30 Hrs on the same day.
- 8. Late tenders / tenders with conditions will be summarily rejected.





- 9. CSL takes no responsibility for delay, loss or non-receipt of tenders sent by e-mail.
- 10. Only technically qualified bids will be considered for price bid opening. After evaluating the bids for both technical aspects and commercial terms, the technocommercially qualified bidders will be intimated regarding the date and time of opening of Part II Price Bid. Intimation will be as per prevailing SOP with respect to the COVID-19 situation, until such time COVID-19 protocol is applicable in CSL.
- 11. Merely opening of Techno-Commercial Bid cannot be construed as acceptance of offer for awarding of contract.
- 12. All rules & regulations specified by the Govt of Kerala and CSL, pertaining to the present COVID-19 pandemic situation should be adhered by the bidder.
- 13. The following shall be submitted along with Part I (Techno-commercial) Bid:
 - i. **Original tender document duly signed on all pages** including Terms & conditions of enquiry, general conditions and technical specification placed at Annexure I, II, III, IV & V
 - ii. The Techno Commercial Check List at Annexure IV filled up completely and duly signed. The non submission of duly filled Techno Commercial checklist will lead to the rejection of the bids.

1. <u>कार्य का विवरण / DESCRIPTION OF WORK</u>

- 1.1 This tender enquiry pertains to the awarding of contract for Servicing of fresh water geysers including the replacement of 16 Nos. defective heating coils along with flange as per the following documents:
 - 1.1.1 Cochin Shipyard Ltd Terms and conditions (Annexure I)
 - 1.1.2 Cochin Shipyard Ltd General conditions (Annexure II)
 - 1.1.3 Scope of work / Technical Specification (Annexure III)
- 1.2 The scope of work includes servicing of 16 in Nos. water geysers, including replacement of heating coil with flange for all the geysers, rectification of Electrical, Instrumentation and mechanical defects if any and 48 hrs post servicing trials up to the entire satisfaction of CSL & Indian Navy, with twelve months service warrantee for the rectification carried out in accordance with CSL Terms and conditions in all respects.
- 1.3 Vendor shall provide comprehensive warranty for minimum 1 year defect free operation of Geysers. Any damage, Electrical/Mechanical defect identified during the warranty period shall be rectified free of cost. All tools & tackles required for carrying out the jobs will be under Vendor's scope.
- 1.4 Vendor shall inspect the 16 Nos. Geyser on board INS VIKRANT for replacement of all defective heating coil along with flange and for identifying any defect in electrical/instrumentation/mechanical parts of the Geyser prior to the submission of quotation.
- 1.5 The servicing should be carried out in accordance with National/International standards. Bidders are requested to study the scope of work before submitting their offer. Clarification, if any, required may be obtained from **Mr. Pradeep K, AGM (Habt. IAC)** before quoting.



2. विक्रेताओं के लिए पात्रता मानदंड / QUALIFICATION CRITERIA FOR BIDDERS

The sub contractor should qualify the following PQ Criteria.

- 2.1 The Bidder shall have relevant experience in servicing of heavy duty water geysers. The firm has to submit the documentary evidence which supports the above mentioned experience.
- 2.2 Documents to be provided to prove credentials of the firm to undertake the subject work. eg: Skilled Manpower, Work experience of similar job, etc. The firm has to submit the documents which validate the above mentioned Clause 2.1, 2.2 requirements.
- 2.3 Bidder shall not be under a declaration of ineligibility issued by Govt. of India/ State govt. /Public Sector Undertakings etc. The bidder shall not have been debarred / black listed by CSL or by any of the Public Sector Undertaking or Government department etc. A self declaration from the firm with this effect shall be provided at the time of submission of Techno commercial offer.

3. प्रस्ताव की वैधता / VALIDITY OF OFFER

3.1 The offer shall be valid for acceptance for a period of 90 days from the date of opening of the Part-I Techno-Commercial Bid.

4. अनुबंध प्रदान करने का तरीका / METHOD OF AWARDING CONTRACT

- 4.1 Contract will be concluded with the Bidder qualifying to techno-Commercial conditions and emerging as L1.
- 4.2 Once work order is placed, successful bidder should be able to start the servicing works immediately after intimation from the execution officer from CSL.
- 4.3 CSL reserves the right to cancel the tender if required.

5. <u>बोलियां जमा करने के लिए दिशानिर्देश / GUIDELINES FOR SUBMISSION OF BIDS</u>

5.1 Technical Bid (Part –I)

- 5.1.1 The technical bid as specified in the scope of work (Annexure III) shall be submitted by E-mail indicating Tender Number and Description of work in the subject line.
- 5.1.2 The following shall be submitted along with technical Bid, failing which the bid may be summarily rejected:-
- 5.1.3 Original tender document general Terms & conditions and technical specifications placed at Annexure I, II, III & IV duly signed on all pages.



5.1.4 Copy of un-priced bid format of each category of works at Annexure V.

6. Price Bid (Part-II)

- 6.1 Price Bid Format: The price bids shall be prepared as per the format given in Annexure V to the enquiry. The bidder must quote all line items as per price bid format any failure in this regard will lead to the rejection of bid.
- 6.2 Currency: The price bids shall be prepared in Indian National Rupees for all bidders.
- 6.3 As per tender condition, the price bids of bidders who are not qualified Technocommercially, will not be considered for any reason.
- 6.4 The bids which are not conforming above requirements shall be summarily rejected without any further notice.

7. **कर / TAXES**

- 7.1 GST shall be applicable extra on the prescribed work. Bidders should indicate the applicable GST percentage and HSN code of the category in the offer. Bidders are also requested to furnish the following details in the invoice/Bill.

- 7.2 Any new tax/duty that may be made effective by the government for this work and paid by the contractor shall be reimbursed on production of documentary evidence.

8. भुगतान की शर्तें / PAYMENT TERMS

- 8.1 Payment will be made on 100% satisfactory completion of works on certification by the officer-in-charge.
- 8.2 All claims for payment for the work/additional work shall be submitted by the subcontractor within one month of completion of work.
- 8.3 Statutory levies such as I.T, Contribution towards PF, ESI etc., shall be deducted from the bill as applicable.
- 8.4 Payment will be made by RTGS/NEFT to the account of contractor. The name of the bank, branch, A/C No., IFSC code & other particulars shall be furnished by the contractor in the proforma of CSL.

9. <u>गोपनीयता खंड / SECRECY CLAUSE</u>

9.1 The CONTRACTOR shall be responsible to ensure that all persons employed by them in the execution of any work in connection with this contract are aware of the



- provisions of the official secrets act 1923 and to comply with the same. The CONTRACTOR shall also ensure secrecy of design, construction, equipment and completion of the vessel. Any information provided to you under this contract is to be treated as strictly confidential and is not to be disclosed to any person or persons not concerned therewith.
- 9.2 The CONTRACTOR shall ensure that their organization, suppliers/ installation agency/test and trials teams etc. shall not communicate for use in advertising, publicity, sales release or in any other medium, system details, photographs and reproduction of equipment and their fitment on board Navy vessels except without or security clearance from the Indian Navy.

10. अधिलेखन और सुधार / OVERWRITING & CORRECTIONS

- 10.1Tenders shall be free from overwriting or erasures. Corrections and additions, if any, shall be duly attested and a separate list of such corrections shall be attached with the offer.)
- 10.2All terms and conditions, other than those mentioned above, contained in the Enquiry specification (Annexure I), Cochin Shipyard Ltd General Terms and conditions (Annexure II) and other annexure pertaining to this tender shall also be attested by the bidder as a token of acceptance.

C. काम की गुंजाइश-ठेकेदार / SCOPE OF WORK-CONTRACTOR

The work shall be carried out based on the national/international standards. The scope of contractor involves the following:

- a) Replacing 16 Nos. defective heating coil along with flange and and rectify any defect identified for the electrical/instrumentation/mechanical parts during the inspection at the time of Pre bid meeting. **Suitable alloy material** is to be used for the manufacturing of coil and flanges.
- b) Servicing of 16 Nos of Geysers on board INS Vikrant.
- c) Place Skilled person to carryout service of Geysers.
- d) Offering the geysers to ship's staffs for 48 Hrs. post servicing trails.
- e) Attending any leakages/Electrical or mechanical defect that may arise during operation of Geysers/ post servicing trials.
- f) All work has to be carried out as per the instruction & guidance from the officer in charge or his authorized representative.
- g) Provide comprehensive warranty for minimum 1 year defect free operation of Geysers.
- h) Any damage, Electrical/Mechanical defect identified during the warranty period shall be rectified free of cost.





- All tools & tackles required for carrying out the jobs will be under Vendor's scope.
- j) Removal and fixing back the rectfied Geyser.
- k) Transportation of defective heating coils from CSL to the contracotr's premises for rectification will be in the scope of the cotractor.
- l) Working platform below 3Mtr will be under the scope of Contractor anyhow, the standard scaffold above 3 Mtr will be provided by CSL.
- m) Appropriate Personal Protective Equipment (PPE) for employees deputed for the Service jobs.
- n) Obtaining Work Permits and hot work permissions.
- o) Vendor shall not contract with any other sub vendor without the prior written consent from CSL. Such consent shall not relieve the vendor from any of his responsibilities & liabilities under the purchase order.

- a) Issue of Gate Passes for Men and material.
- b) Coordinate with the Indian Navy for offering the trials of the geyser
- c) Crane and forklift for material movement from Quay 3 based on availability
- d) Standard scaffold above 3 Mtr, if required.

E. काम करने की पद्धति / METHODOLOGY OF WORKING

- a) Contractor shall understand the scope of work and deploy skilled manpower accordingly to start the work immediately on intimation of issue of work order/ instruction from the officer in-charge.
- b) Obtain appropriate work permits and permissions for carrying out the job.
- c) Vendor shall provide comprehensive warranty for minimum 1 year defect free operation of Geysers.
- d) The work shall be completed within one month from the date of intimation of issue of work order.
- e) Subcontracting the work without the written intimation to CSL is treated as violation of the contract.
- f) The complete work is to be carried out with the highest degree of workmanship.
- The Contractor is to ensure proper cleanliness all around his work area while working on board ship. The contractor shall arrange to collect and clean up every day all the waste, scrap, debris etc. generated by their workmen while





working on board the ship and other locations and deposits the same suitably at specified location at his cost to the complete satisfaction of Yard. In case of any failure on his part to comply with the requirement, Yard will arrange the required cleaning entirely at the contractor's cost.

- h) The firm contractor shall be responsible for any damage caused to the material supplied by CSL. Compensation with penalty for damage or loss of the item will be recovered from the Contractor, in the event of loss or damage. The responsibility is limited only with respect to the damages caused due to any mistake or negligence of contractor.
- i) Contractor / firm is required to work round the clock/ Sundays/ holidays as per the requirement of concerned department in order to complete the work in time.
- j) The upper age limit of all workers and supervisors employed by the contractor firm The upper age limit of all workers and supervisors employed by the contractor firm prevailing rules of CSL.
- k) Any particulars/literature/information/certificates required by the Shipyard in connection with the work is to be forwarded free of cost.
