



9. General Remarks

a) Name Plate (s)/Caution Plate (s) and Instrumentation

The name plate(s) and caution plate (s) shall be written in English indicated in SI unit. All major machinery, electrical and equipment shall be provided with identification nameplates made from stainless steel/brass plates as per manufactures standard and label plates indicating equipment type, capacity, electric rating etc. shall be fitted as per manufacturer's standard. Instrumentation shall also be indicated in SI unit.

b) Liability

Manufacturer shall bear all responsibilities for the shop trials and the delivery of the machinery or equipment.

c) Piping Flange

Piping end connection shall be as per EN1092-1 Type 01 PN10/ PN16 Flat Face as applicable. Mating flanges shall be supplied for all ends, if there is any deviation with the standard mentioned above.

d) Screw Thread

Screw thread if any, shall be in accordance with ISO standard.

e) Grease Nipple

Pin type grease nipple, where grease is supplied shall be used.

f) Painting

Painting schedule shall be as per manufacturer's standard and the painting scheme shall be specified.

g) Preservation

Recommended method of preservation and names of recommended preservatives shall be indicated. Maximum R.H. (Relative Humidity) at Howrah in West Bengal is around 80% and minimum R.H is at around 60%.

h) Special Tools

Special tools if any required for installation have to be supplied with the equipment.

i) Instruments

Instruments to be mounted on the equipment have to be supplied with the equipment.

- 1. General Requirements
- a) The Oil Dispersant arm and its accessories must be suitable for marine applications, function smoothly and achieve full specified performance at design and environmental conditions without any undue effect on maintenance or life.
- b) It should withstand air contamination through oil, salt and other contaminants associated with the marine environment.
- c) The system shall be permanently installed oil dispersant spraying type.
- d) The system should contain oil spill dispersant arm, nozzles and suitable flexible hoses.
- e) Oil Dispersant tank of 5.8 m³ (at 100% capacity) is provided onboard the vessel.
- f) The preliminary schematic diagram for the system is mentioned at Annexure-1 for reference only.



If the firm proposes any alternative means of the oil dispersant system, the same shall be proposed as optional offer.

- 2. Oil Spill Dispersant (OSD) Arm
- a) Oil dispersant spraying arms to be installed on both sides of main deck.
- b) The spray arms shall be extendable or swiveling type. The spray arms shall be rigged or deployed quickly whenever required.
- c) The length of each OSD spray arm shall be minimum 4.5m.
- d) The arms shall be suitable for mounting fixed on the deck.
- e) The OSD spray arm shall be made of marine grade anti-corrosive material.
- f) The spray arm shall have minimum four number of nozzles spaced evenly for neat and diluted dispersant spraying.
- g) All necessary nozzles and accessories shall be supplied along with the OSD arm.
- h) Certification of the oil spill dispersant arm shall be as per applicable norms.
- Other accessories
- a) All flexible hoses supplied along with the equipment shall be of type approved by any IACS member.
- b) The end connection of flexible hose shall be preferably camlock type (2").


