Annexure 1, Para 3.12: 15OD straight union of SS316L shall be supplied by the machinery contractor for steering gear system. The union supplied shall be complied with Class I piping system as per IRS Class. IRS certification shall be done by HCSL separately after the product supply (Note: if the item supplied is found as rejected, the machinery contractor shall take necessary action for immediate replacement without affecting the production schedule). Total requirement of connectors per vessel is 14 Nos and box clamps as required for steering gear pipe support are also to be supplied by the contractor. Total requirement of box clamps per vessel is 15 Nos. Sample to be submitted to HCSL for approval before delivering the entire lot at HCSL.	Annexure 1, Para 3.12: 15OD straight union of SS316L shall be supplied by the HCSL for steering gear system. Box clamps as required for steering gear pipe support shall also be supplied by HCSL.

B. Following two clauses also to be considered in “Annexure 3 Terms & Conditions of Enquiry”:

23. SUB CONTRACTING AND ASSIGNMENT

- a. Contractor shall not assign nor transfer the Work Order nor shall any share or interest therein in any manner or degree be transferred or assigned by Contractor to a third party without prior consent in writing of HCSL.
- b. Contractor shall not contract with any subcontractor and/or vendor without the prior written consent of HCSL. Such consent shall not relieve the Contractor from any of his responsibilities and liabilities under the Work Order. In addition, Contractor shall ensure that the terms and conditions of any such contract shall comply with and correspond to the terms and conditions of the Purchase Order/ Work Order.

24. DEFECT LIABILITY PERIOD: The contractor has to guarantee/warranty the workmanship for a minimum period of 06 months from the date of successful completion of sea trials against defective workmanship. During this period any defect shall be repaired by the Contractor free of cost. Any trouble or defect originating with the workmanship of any facilities installed arises at any time up to 06 months from the date when the sea trials are successfully completed, and the CONTRACTOR is notified thereof, the CONTRACTOR shall at his own expense and as quickly as possible make such alteration / repairs and replacements as may be necessary to comply with the above guarantees and shall reimburse any costs and expenses incurred by HCSL in connection with such trouble or defect. If the contractor fails to take action as above as HCSL shall direct, HCSL shall be free to take corrective/ alternative action at the contractor's cost and risk within a reasonable time.

- C. Last date of submission of tender is extended upto 02.07.24 at 1500 Hrs. The date of tender opening will be 02.07.24 at 15.30 Hrs.
- D. All other term and conditions shall remain unaltered.
