

## ONBOARD PIPE FITMENT & STRUCTURAL OUTFITTING WORKS IN IN 4 Nos OF MULI PURPOSE VESSELS (MPV)

#### 1. कार्य का विवरण / DESCRIPTION OF WORK

- 1.1. This tender enquiry pertains to the awarding of contract for **Onboard Pipe Fitment & Structural Outfitting Works in MPV (Multi Purpose Vessels)** as per the following documents:
- 1.1.1. Cochin Shipyard Ltd Terms and conditions (Annexure I)
- 1.1.2. Cochin Shipyard Ltd General conditions (Annexure II)
- 1.1.3. Enquiry specification (Annexure III)
- 1.2. The scope of work includes collection of pipes and onboard fitting as per drawings, including flushing and pressure testing of piping system up to the entire satisfaction of CSL / Owner / Class surveyor, and up to the delivery of the vessel; with the available infrastructure facilities and Equipments / materials / consumables provided by Cochin Shipyard Ltd (CSL) in accordance with the enclosed Specifications and drawings, delivery schedule, CSL Terms and conditions in all respects.
- 1.3. *Bidders* are requested to study the scope of work before submitting their offer. Clarification, if any, required may be obtained from **M (MOF)** before quoting.

#### 2. विक्रेताओं के लिए पात्रता मानदंड / QUALIFICATION CRITERIA FOR VENDORS

- 2.1. The Bidder shall be a single firm having experience in pipe erection works and onboard pipe works in ships or floating marine structures in Ship Building Area and must have experience in MS,SS and copper pipe welding works.
- 2.2. The technical experience means "the experience of successfully completed similar works (as per clause 2.1 above) costing not less than 20 lakes executed during the last 5 years ending 30 April-2023. In the case of ongoing works, work progress report





- from the authorized officer of the work order issued firm shall be submitted for considering CSL requirement.
- 2.3. Bidder shall have an average annual turnover during last 3 years, ending 31st March 2023 should not less than Rs. 20 Lakhs (INR). The bidder shall submit the annual turnover as per the format placed at Appendix- D
- 2.4. The bidder should have qualified welders having relevant WPS approved by classification societies.
- 2.5. The contractor must have a site-in charge/ supervisor to execute work, with a minimum experience of 3 yrs in piping field.
- 2.6. Documents to prove credentials of the firm to undertake the subject work. eg: Details of available equipments & facilities, Skilled / qualified Manpower, Work experience of similar job, etc. The firm has to submit the documents which validate the above mentioned Clause 2.1 2.5 requirements. Work order for material supply will not be considered.
- 2.7. The project shall comprise of completed work having comparable nature to that of pipe fabrication /erection/ ship pipe repairs/erection or piping on floating marine structures and erection of structural outfitting and equipment installation. If the experience claimed by the bidder is of no relevance with respect to erection, then such experience will not be considered for pre-qualification. Decision taken by CSL in this regard will be final.
- 2.8. The Bidder should furnish the required work-specific information and satisfactory documentary evidence such as copy of work order / agreement and a certificate from the employer for satisfactory completion of work or any other relevant document indicating completion of work shall be submitted to CSL in support of its claim of experience.
- 2.9. Bidder shall not be under a declaration of ineligibility issued by Govt. of India/ State govt./ Public Sector Undertakings etc. The bidder shall not have been debarred / black listed by CSL or by any of the Public Sector Undertaking or Government department etc.
- 2.10. For order value above one crore, executing sub contractors with HSE rating of 4 stars or above only will be considered and for new vendors, these vendors who are submitting CSL approved HSE plan along with the tender document only will be considered.



#### 3. प्रस्ताव की वैधता / VALIDITY OF OFFER

3.1. The offer shall be valid for acceptance for a period of 90 days from the date of opening of the Part-I Techno-Commercial Bid.

#### 4. अनुबंध प्रदान करने का तरीका / METHOD OF AWARDING CONTRACT

- 4.1. Cochin Shipyard Ltd (CSL) is constructing 08 numbers of MPV (SH-29- 36) vessels. As per current requirement, CSL intends outsource the onboard pipe fitment and Structural outfitting Works of **04 numbers vessels**. However, the contract may be further extendable to other 04 vessels also on same rate, terms & conditions of this contract on mutual agreement based on currently awarded work performance of firms at site.
- 4.2. The scope of work is defined as Part A & Part B per vessel.(Refer Scope of Work in Annex-III and Price Bid format at Annex-V).
- 4.3. Contract will be concluded with the Bidder qualifying to techno-Commercial conditions and emerging as L1 for each part / bidder willing to match with L1 rate.
- 4.4. Considering the limited time period available for project completion, CSL reserves the right to split order at L1 rate as per clause 4.5 & 4.6 below-
- 4.5. <u>Part A:</u> The scope of work corresponding to 25% of total work per vessel ( i.e equivalent to 1 vessel out of 4 vessels) is assured for L1 bidder. Balance 75% will be equally awarded to other five bidders who are willing to match the L1 rate. Selection of this bidder will be in the sequence of ascending order of lowest rate quoted (L2, L3, L4....).
- 4.6. <u>Part B:</u> The scope of work corresponding to 40% of total work per vessel is assured for L1 bidder. Balance 60% will be equally awarded to other two bidders who are willing to match the L1 rate. Selection of this bidder will be in the sequence of ascending order of lowest rate quoted (L2, L3, L4....).
- 4.7. Work distribution/ allocation based on number of firms willingness to match L1 rate is detailed at Appendix C
- 4.8. Vessel number and area within the vessel for executing the work to each firms will be allocated by executing officer based on vessel readiness at CSL/ priority of vessels
- 4.9. In the event of no other firms are willing to match L1 rate, CSL reserves the right to place order in part/ full on L1 firm, depending upon project schedule, priorities, capacity to mobilize manpower, previous performance, financial capabilities etc.
- 4.10. CSL reserves right to reduce/ increase the percentage work based on the performance of work undertaking firms at site.

- 5.2. Structural Outfitting Works (chequered frame structures/ plates/ platforms/ gratings etc., man-holes, hatches, ladders, steps, rungs, handrails, coamings, sounding caps, bottom plugs, equipment foundations, bollards/ chalks, if any etc.) onboard vessel/ block stages (Ref : Appendix B)

- 5.3. Quantum of work indicated is for estimation purpose only, actual quantum of work executed at site shall be considered for the payment purpose. Downward or upward variation of quantity shall be anticipated.

## 6. <u>कार्य की प्रगति तथा समापन की समय – सारणी / WORK PROGRESS AND</u> SCHEDULE OF COMPLETION

- 6.1. All Works corresponding to each vessel should be completed within 6 Months from the date of working area readiness from CSL. Work period will be tentatively from June 2023 to July 2025. In the case of split order, the firm should work in line with CSL requirement as per the instruction of officer-in –charge.
- 6.2. The contractor in turn shall submit their detailed scheduled of completion of the work, in consultation with the officer In-charge. The progress of work shall be made in tandem with the progress of completion of the vessel allowing sufficient time for other interface activities/works.
- 6.3. Yard has the right to change the schedules of the project to the interests of the company and the firm should be capable of adjusting the resources according to the instructions from the Yard contact person.



6.4. Detailed working schedule (Weekly/monthly) etc to be prepared and submitted to yard personnel. However, a detailed overall schedule, in a reasonable manner should be submitted prior to commencement of work.

#### 7. कार्य प्रक्रिया / WORK PROCEDURE

- 7.1. The work procedure briefly described below, detailed for each category of works are mentioned in the Annexure III to the tender enquiry.
- 7.2. Necessary job instructions, drawings etc. for the work will be issued by CSL.
- 7.3. Contractor is to carry out the work as per the specifications / drawings supplied, and to the satisfaction of CSL.
- 7.4. Contractor should maintain the quality as per CSL Quality Standards, yard quality procedures. Inspection will be carried out during fabrication by CSL.
- 7.5. Contractor shall submit the weekly /monthly progress reports to CSL.

#### 8. अनुबंध की वैधता / VALIDITY OF CONTRACT

8.1. Once the contract is awarded, the price offered and mutually agreed shall remain firm till completion of work and no escalation in rate shall be allowed by CSL on whatsoever reason thereafter.

9.1. The complete work has to be carried out under the survey of ship classification society / owner / CSL.

#### 10.1. Technical Bid (Part –I)

- 10.1.1. The technical bid as specified in the scope of work (Annexure III) shall be submitted in single sealed cover, super scribed by the bid No, tender No. and date.
- 10.1.2. The following shall be submitted along with technical Bid, failing which the bid may be summarily rejected:-
- 10.1.2.1.Original tender document general Terms & conditions and technical specifications placed at Annexure I, II & III duly signed on all pages.
- 10.1.2.2. The commercial Check List at Annexure IV filled up completely and duly signed
- 10.1.2.3. Copy of un-priced bid format of each category of works at Annexure V.



- 10.1.2.4.As per Govt. of India guidelines, Integrity pact (IP) should be signed for all contracts above Rs. One Crore. Accordingly IP should be signed and forwarded along with the offer.
- 10.1.3. The non submission of duly filled commercial checklist will lead to the rejection of the bids.

#### 10.2. Price Bid (Part-II)

- 10.2.1. The bid shall be comprehensive of the nature of Outfitting Works onboard MPV Series Vessels shall be inclusive for all the applicable charges envisaged under the scope of the contractor as specified in the technical specification Annexure III.
- 10.2.2. Bidders shall quote total amount in figures and in words. Corrections and additions if any must be attested/ duly signed by the bidder. In the case of error in multiplication/addition in amount calculated, the rate quoted will be considered as correct and the amount will be calculated accordingly. Conditional rebates & discounts, incomplete/ ambiguous offer will be rejected.
- 10.2.3. The price bid shall be all inclusive of scope of contractor on lump sum basis and any rates on variable basis will not be accepted within the price bid and thereafter throughout the period of the contract. Any variable rates if deemed inevitable and applicable only in special cases/situations (not in the normal course of execution of contract) will only be considered for mutual agreement.
- 10.2.4. Price Bid Format: The price bids shall be prepared as per the format given in Annexure V to the enquiry. The bidder must quote all line items as per price bid format any failure in this regard will lead to the rejection of bid.
- 10.2.5. Rates of individual line items for the overall L1 is considered as L1 rate for each part (Part A & Part B) of Price bid irrespective of lower rates in case of the line items within the part of other bidders.
- 10.2.6. Currency: The price bids shall be prepared in Indian National Rupees for all bidders.
- 10.2.7. As per tender condition, the price bid which were not opened will not be returned back at any reason.
- 10.2.8. The bids which are not conforming above requirements shall be summarily rejected without any further notice.


#### 12. **कर** / TAXES

- 12.1. GST shall be applicable extra on the prescribed work. Bidders should indicate the applicable GST percentage and HSN code of the category in the offer. Bidders are also requested to furnish the following details in the invoice/Bill.
  - 12.1.1. Applicable rate of GST/SAC Code
  - 12.1.2. Firms GST Reg. NO
  - 12.1.3. Service accounting code (SAC) as prescribed by statutory authorities.
  - 12.1.4. GST Reg. No. of Cochin Shipyard Ltd (32AAACC6905B1ZD).
- 12.2. Any new tax/duty that may be made effective by the government for this work and paid by the contractor shall be reimbursed on production of documentary evidence.

#### 13. भुगतान की शर्तें / PAYMENT TERMS

- 13.1. Payment will be released in 4 stages (Both Part A & Part B), for the following work completion stages and on certification by the Officer-in-charge.
  - i) 20% of work order value on completion of 50% of piping / structural works against furnishing of PBG as per tender clause.
  - ii) Payment of additional 30% of work order value on completion of 80% of piping works / equipment erection.
  - iii) Payment of additional 40% on sea-trial readiness.
  - iv) Balance 10% after successful sea trail or delivery of vessel.
- 13.2. All claims for payment for the work/additional work shall be submitted by the subcontractor within one month of completion of work.
- 13.3. Invoice for payment should be submitted through VIM (Vendor Invoice Management) Portal in CSL web site.

- 13.4. Statutory levies such as I.T, Contribution towards PF, ESI etc., shall be deducted from the bill as applicable.
- 13.5. Payment will be made by RTGS/NEFT to the account of contractor. The name of the bank, branch, A/C No., IFSC code & other particulars shall be furnished by the contractor in the proforma of CSL.





#### 14. प्रतिभूति जमा / SECURITY DEPOSIT


14.1. The successful tenderer shall remit 5 % of the value of the contract as security deposit within 15 days of receipt of the work order. This amount has to be remitted by way of demand draft or bank guarantee (in approved proforma of CSL) from any of the nationalized banks, valid till the satisfactory completion of the entire work. The Security Deposit will be released after satisfactory completion of the contract/guarantee period (if no separate BG as per clause 15 is furnished) and on certification of nil liability to CSL by Officer-in charge. The Security Deposit retained will not bear any interest.

#### 15. निष्पादन गारंटी / PERFORMANCE GUARANTEE

- 15.1. The complete work carried out by the contractor shall be guaranteed against performance of work and/or poor workmanship for a period of one year from the date of completion of work. Any damage or failure due to defects in execution of the work for a period of 12 months from the date of completion of work, such damage or failure occur within the guarantee period, the contractor shall rectify/rework the defect as applicable without any extra expenditure to CSL and such repaired work shall be guaranteed for a further period of one year from the date of repair.
- 15.2. Should any unsatisfactory performance and / or damage or failure occur due to poor workmanship and poor quality material used by the contractor, the contractor shall be solely responsible for payment/reimbursement of expenditure incurred by Ship owner for rectifying the defect.
- 15.3. Towards this, a performance guarantee equivalent to 5 % of the value of the contract to be furnished by the contractor along with submission of first bill in case of pro rata/stage payment or completion of entire work in other cases, as per payment terms, by way of a bank guarantee (in approved proforma of CSL) from a nationalized bank valid till the expiry of the guarantee period.
- 15.4. Performance Guarantee is applicable for all bidders irrespective of MSME/NSIC registration for necessary coverage under the performance guarantee clause.

#### 16. परिसमापन क्षतिपूर्ति / LIQUIDATED DAMAGES

16.1. The progress of work will be monitored against the mutually agreed detailed schedule referred in clause. Liquidated damages for delays in execution of the work envisaged as per this order, for any reason other than force majeure conditions, will be recovered at the rate of 0.5% of the basic value of the delayed work per week or





part thereof, subject to a maximum of ten (10) percent of the basic value of the delayed work.

## 17. <u>आदेश रद्द करना और जोखिम अनुबंध / CANCELLATION OF ORDER AND RISK</u> CONTRACTING

- 17.1. In the event the contractor fails to complete the work promptly and satisfactorily as per the terms of the order, and if the work is delayed beyond the agreed schedule, CSL, without prejudice, reserves the right to cancel the order and get the work done at contractor's cost and the expenditure so incurred including any damage or loss will be recovered from him and the Security Deposit furnished by him is liable to be forfeited either in whole or in part.
- 17.2. In addition to above tender holiday will be imposed against the firm as per discretion of CSL.

## 18. <u>कार्मिकों की सुरक्षा और प्राथमिक चिकित्सा / SAFETY OF PERSONNEL AND FIRST AID</u>

- 18.1. The contractor shall be entirely responsible for the safety of all the personnel employed by him on the work. In this regard, he may adopt all the required safety measures and strictly comply with the safety regulations in force. A copy of CSL's "Safety Rules for Contractors (Revised)" is available with SB-Outsourcing department for reference.
- 18.2. The Contractor may arrange to suitably insure all his workmen/ other personnel in this regard. CSL will not be responsible for any injury or illness to the Contractor's workmen/other personnel during execution of the works due to whatsoever reasons.
- 18.3. In this regard, the Contractor will have to fully indemnify CSL against any claims made by his workmen/other personnel.
- 18.4. The Contractor shall provide and maintain so as to be readily accessible during all working hours, a first aid box with prescribed contents at every place where he employs contract labour for executing the works.

#### 19. <mark>अप्रत्याशित घटना /</mark> FORCE MAJEURE

19.1. Should failure in performance of any part of this contract arise from war, insurrection, restraint imposed by Government act or legislation of other statutory authority, from explosion, riot, legal lock-out, flood, fire, act of Govt. or any inevitable or unforeseen event beyond human control which will be construed as a



- reasonable ground for extension of time, CSL may allow such additional time as is mutually agreed to be justified by the circumstances of the case.
- 19.2. The occurrence / cessation of force majeure situation have to be informed with documentary evidence within 15days from the date of occurrence / cessation.

#### 20. मध्यस्थता / ARBITRATION

- 20.1. Any disputes arising during the currency of the contract shall, in the first instance be settled by mutual discussions and negotiations. The results of such resolution of dispute shall be incorporated as an amendment to the contract, failing which the parties can resort to arbitration.
- 20.2. If any dispute, disagreement or question arising out of or relating to or in consequence of the contract, or to its fulfillment, or the validity of enforcement thereof, cannot be settled mutually or the settlement of which is not herein Specifically provided for, then the dispute shall within thirty days from the date either party informs the other in writing that such disputes, disagreement exists, be referred to arbitration. The arbitrators shall be appointed and the arbitration proceedings shall be conducted in accordance with and subject to the Arbitration and Conciliation Act, 1996 (No. 26 of 1996) as amended form time to time and the decision of the Arbitrators shall be final and binding on the parties hereto. The arbitration will be done by a Board comprising one officer nominated by each party, and a mutually agreed Umpire. Each party shall bear its own cost of preparing and presenting its case. The cost of arbitration shall be shared equally by the parties unless the award provides otherwise. The enforcement of the award shall be governed by the rules and procedures in force in the State in which it is to be executed. Performance under this Contract shall however, continue during arbitration proceedings and no payment due or payable by the parties hereto shall be withheld unless any such payment is or forms a part of the subject matter of arbitration proceedings.
- 20.3. In case of disputes, the same will be subjected to the jurisdiction of courts at Ernakulam, Kerala, India only.

#### 21. क्षेत्राधिकार / JURISDICTION

21.1. All questions, disputes or differences arising under/out of or in connection with this contract shall be subject to the jurisdiction of the Courts in Cochin.



#### 22. सामान्य शर्तें / GENERAL CONDITIONS

- 22.1. Quality of workmanship shall conform to the specification/ standards laid down by CSL
- 22.2. CSL reserves the right to award the work to more than one contractor or to take over partially or fully the work depending upon the scheduled requirements.
- 22.3. Compliance of all statutory safety requirements and other safety rules stipulated by CSL and other applicable statutory bodies shall be the responsibility of the Contractor while working at CSL premises. The Contractor should ensure that their workmen and staff are adequately covered under Insurance.
- 22.4. Damages caused to the Shipyard properties/tools/accessories should be rectified by the Contractor at his cost or proportional recoveries will be made from the contractor while passing their bills for payment.
- 22.5. Cochin Shipyard Limited reserves the right to terminate the Contract at short notice
- 22.6. in case the Contractor's performance is found not satisfactory with regard to progress of work, quality, time factor, labour dispute with their workers, poor safety records etc., and other contractual obligations. No claim whatsoever will be entertained by Cochin Shipyard Limited on this account.
- 22.7. The Contractor shall have to engage men on round the clock basis and also on Sundays and holidays, if required. Work has to be completed to the satisfaction of Cochin Shipyard representative deputed for the job. The job should be completed at the time specified by the representative deputed for the job for each stage of work.
- 22.8. The Contractor shall indemnify CSL and CSL's personnel against any claims arising out of accidents or injuries to workmen or other persons or damage to other property which may arise during the execution of the contract or from breach of any Law or Regulation prior to delivery and acceptance of the items at CSL.
- 22.9. It is also to be understood by the Contractor that Cochin Shipyard Limited does not bind itself to give the Contractor any regular or specific quantity or area of work and it shall be done at the sole discretion of CSL depending on the prevailing site conditions and other limiting factors and no claim on this account from the contractor shall be entertained.
- 22.10. The Contractor shall also be governed by the General Conditions of Contract of CSL, General Safety Rules and other relevant labour laws.
- 22.11. The contractor shall arrange to collect and clean up every day all waste, scraps; debris, etc. generated by the work men while working onboard the vessel and other locations and dispose the same suitably at his cost to the full satisfaction of CSL. In



- case any failure on his part to comply with this requirement, CSL will arrange the required cleaning entirely at the contractors cost.
- 22.12. The upper age limit of all workers and supervisors employed by the contractor and those contractors who do or supervise the job themselves shall be as per the prevailing rules of CSL.
- 22.13. General Manager (SB) or his authorized representative will be the Officer-in-charge of this Contract.
- 22.14. Withdrawal of the quotation after it is accepted or failure to make contract execution within the stipulated completion period will entail cancellation of the order and forfeiture of EMD/ Security Deposit, if any/ and or risk purchase.
- 22.15. Subcontracting to other vendors shall be only after written intimation and approval of competent CSL authorities. Vendor shall not delegate or subcontract any of its obligations under the agreement without CSL's written consent. Vendor will remain liable for all subcontracted obligations and all acts or omissions of its subcontractors.
- 22.16. The procedures of work, standard operating procedures of work including documents like welding procedure specifications developed by CSL are intellectual property of CSL. Vendors shall not use or copy the procedure in any format without the written consent of competent authorities of CSL.
- 22.17. Vendor shall return the CSL resources to CSL immediately after provision of all deliverables and services or any termination of the agreement.
- 22.18. Conditional discounts, if any, will not be reckoned for tender evaluation/comparison purposes. However the same will be considered at the time of placement of purchase order if the firm turns out to be lowest bidder.

- 23.1. Tenders shall be free from overwriting or erasures. Corrections and additions, if any, shall be duly attested and a separate list of such corrections shall be attached with the offer.)

All terms and conditions, other than those mentioned above, contained in the Enquiry specification and drawings (Annexure I), Cochin Shipyard Ltd General Terms and conditions (Annexure II) and other annexure pertaining to this tender shall also be attested by the bidder as a token of acceptance.
- 23.3. CSL reserves the right to reject any or all bids without assigning any reasons whatsoever and or based on the past unsatisfactory performance by the bidders at



CSL/other PSE's/Government Departments. After issuing the work order, CSL reserves the right to terminate the contractor if the performance of the contractor is not found satisfactory. The decision of CSL regarding the same shall be final and conclusive.

#### 3 SCOPE OF WORK

#### **PART-A: PIPE OUTFITTING WORKS**

The scope of work includes collection of pipes, valves & miscellaneous items as per MLF from Stores/shops/contractors skid, transportation to the ship/ blocks, fitment





on board the ship/ blocks and assistance for flushing & entire work shall be as per the MLF, Yard plan, pipe support drawing, key plan, and CSL quality standards etc.

- > Technical details:
  - Number of pipes: approx 5009 nos.
  - Total Length of pipes 6652 m approx.
  - Number of valves 855 nos approx.
  - Number of joints 10000 approx. (including butt, sleeve, flanges, bhd penetrations etc.)
- a) The job includes collection of pipes from shop, transportation to the ship and fitment onboard the ship as per the MLF, Yard plan and Revision drawings if applicable, pipe support drawing, key plan, schematic drawings and CSL quality standards etc.
- b) All fitment and welding job are under the scope of Outfitting contractors.
- c) Jobs including outfitting of all the bulkhead penetrations, brackets, supports, doublers Pad, erosion pads, striking pads, Roxtek coupling, scuppers, heat-exchangers, temp. gauges, strainers, flow-meters, level gauges/ sigh glasses, bellows, eductors etc.
- d) Also all the foundations and seats if any for the above will be done by the respective contractors, which includes alignment, marking, fitment and welding.
- e) The job includes leak / hose testing of overboard valves/pipes, fixing of valves and supports, blanking of valves, rose boxes, scupper, removing and refitting of pipes, if required for other works etc.
- f) All the accessories like bolts & nuts, valves, strainers, clamps, gaskets, U clamps and any components required for completion of pipe/ structural outfitting will be supplied by CSL as per MLF.
- g) Fitment and welding of accessories like bosses/ square flange for fixing the instruments/gauges will be under the scope of the contract.
- h) Precision tubes laying, fitment and bending as per yard plan and CSL BOM are under the scope of tender.
- i) The layout of piping system including making pipe system withstand 1.5 times system working pressure and then offering to QC and subsequently to OWNER & CLASS to their best satisfaction. Any comments arising during the layout to be liquidated immediately. If more than one contractor is engaged in a single system,





the pressure testing will be done by CSL, provided, any leakage rectification delay will be accounted against the particular contractors.

- j) Contractor shall ensure all pipe supports fabricated are painted before fitment onboard the ship; otherwise it has to be handed over to CSL for painting.
- k) The outfit survey of tanks to be presented to the QC and subsequently to OWNER & CLASS after completing all piping related jobs including mopping the debris and dewatering if any. The tank needs to be presented for box up survey after completing all the works and same needs to be closed. The gasket, bolt and nut will be provided by CSL.
- l) Installation and fitment of all closing pieces to machineries including flexible hoses and bellows are within the scope of the contract.
- m) All template pipes will be supplied by CSL in tack welded condition which needs to be welded onboard as per site condition. Pipes with flanges/ sleeves in tack-weld condition needs to be welded onboard as per site condition.

Final fitment of chequered plates will be done at a later stage.
- b) Modification on the chequered floor/ platforms, if any has to be done as per site condition.
- c) Chequered plates/ platforms needs to remove and refitted using the fasteners more than one time for various related jobs and before final fitment, thorough cleaning of the compartment has to be done.
- d) Collection of foundation/seats for equipment/ machineries including life boat davits, life rafts from shop and Engine room lifting beams, transportation to the ship/ block, fitment, alignment and welding onboard the ship including carlings and lifting lugs etc., assistance for laboratory tests and completion of class survey if required. Foundation to be offered to QC prior to welding. Fabrication will be done by CSL.
- e) Man-holes, ladders (both vertical and inclined), steps, rungs, drain-plugs, sounding caps etc also has to be fitted during block stage/ on-board vessels. All hot works to be completed prior to tank testing.
- f) The fabrication/fitment and welding of foundations for for LSA/FFA items as per site condition. Fitment and welding of coaming plates/ handrails is also under the scope of contract.
- g) Load testing of hooks and I beams



- h) The job includes drilling of holes on foundation, protection of the machinery onboard as per CSL requirement (Fire cloth and GI sheet with frame if required), fitment of all accessories, fixing of name plates and torque tightening if required.
- i) All hot works like fitment of lifting lugs of cradle etc. if required for the erection of the foundation is under the scope of contract.
- j) The machineries to be positioned after the QA of equipment seats and drilling to be done on the foundation.
- k) Removal and refit of pipes if required.
- l) Each contractor should have a good coordination with his counterpart in the same vessel.

#### 4 SCOPE OF YARD

- a) The design & supply of materials for the piping work under the mentioned scope of work.
- b) Providing the MLF, Yard plan, pipe support drawing, key plan, and CSL quality standards etc.
- c) Consumables (welding rods & shielding gas only) will be supplied by CSL.
- d) The accessories like bolts & nuts, valves strainers, clamps, silencers will be provided by CSL.
- e) Power supply, Water, compressed air (at available pressure) and cutting gases at centralized points.
- f) Services of CSL cranes and forklifts will be provided subject to availability.
- g) Required space inside the Yard (as on available area)
- h) Power and water supply to office space / container / room, at free of cost.
- i) Staging above 3m height.
- j) Arranging QC/ Owner for inspection and survey.

#### 5 <u>METHODOLOGY OF WORKING</u>

- a) A detailed project report to be submitted prior to commencement of works.
- b) The subcontractor shall deploy/nominate a person who will be in charge of the work for the entire period of project execution. He shall keep close liaison with CSL officers/supervisors concerned and ensure smooth and satisfactory progress of the work from time to time and shall be available for the entire duration of the project.
- c) Necessary competent supervisors for the work, to be deployed.



- d) Employees of the firm shall work under close co ordination with yard personnel, structural contractors and Piping/Painting/Electrical subcontractors with a conciliatory approach and team spirit to achieve the project completion in time.
- e) The Contractor is expected to have full knowledge and understanding of the Labour rates, conditions, practices etc prevalent in the Yard and premises. The contractor shall be entirely responsible for all matters related to manpower and labour engagement for the subject contract.
- f) Issues related to availability and utilization of manpower shall be dealt by the Contractor. Availability of competent labour with requisite skills for the specified jobs shall be ensured by the contractor.
- g) The complete work is to be carried out with the highest degree of workmanship under the inspection of CSL, Classification society (when specifically indicated in the technical specifications), Ship owner, or any other agency nominated by Shipyard.
- h) The contractor shall execute the work in every area under instruction/intimation to CSL personnel at site. Clearance from CSL in terms of permits/internal regulations etc as applicable from time to time shall be obtained. The contractor shall obtain necessary hot work sanctions, permission to work in confined areas, safety clearance for scaffolding done by the contractor, electrical related provisions etc. as per CSL safety rules.
- i) The Contractor is to ensure proper cleanliness all around his work area while working on board ship. The contractor shall arrange to collect and clean up every day, all the waste, scrap, debris etc. generated by his workmen while working on board the ship and other locations and deposit the same suitably at specified location at his cost to the complete satisfaction of Yard. In case of any failure on his part to comply with the requirement, Yard will arrange the required cleaning entirely at the contractor's cost.
- j) The firm / contractor shall be responsible for any damage caused to the material supplied by CSL. Compensation with penalty for damage or loss of the item will be recovered from the Contractor, in the event of loss or damage. The responsibility is limited only with respect to the damages caused due to any mistake or negligence of contractor.
- k) Contractor / firm are required to work round the clock / Sundays/ holidays as per the requirement of concerned department in order to complete the work in time.





- l) The upper age limit of all workers and supervisors employed by the contractor / firm and those contractors who do or supervise the job themselves shall be as per the prevailing rules of CSL.
- m) Any particulars/literature/information/certificates required by the Shipyard in connection with the work is to be forwarded free of cost.

#### 6 <u>SAFETY/STATUTORY RESPONSIBILITY</u>

- a) The contractor shall be entirely responsible for the safety of all the personnel employed by him on the work. In this regard, he should adopt all the required safety measure and strictly comply with the safety regulations in force. A copy of CSL's "Safety Rules for Contractors (Revised)" is available with SBOC Department for reference.
- b) The Contractor should arrange to suitably insure all his workmen/other personnel in this regard. CSL will not be responsible for any injury or illness to the Contractor's workmen/other personnel during execution of the works due to whatsoever reasons.
- c) In this regard, the Contractor will have to fully indemnify CSL against any claims made by his workmen/other personnel.
- d) The Contractor shall provide and maintain so as to be readily accessible during all working hours, a first aid box with prescribed contents at every place where he employs contract labour for executing the works.

WHEREAS the BIDDER is a private company / public company / Government undertaking / Partnership / registered export agency, constituted in accordance with the relevant law in the matter And the PRINCIPAL is a Government of India PSU performing its functions on behalf of the President of India.

#### NOW, THEREFORE,

To avoid all forms of corruption by following a system that is fair, transparent and free from any Influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be

Entered into with a view to:-



Enabling the PRINCIPAL to obtain the desired said stores/equipment/item at a competition price in Conformity with the defined specifications by avoiding the high cost and the distortionary impact of

Corruption on public procurement, and Enabling BIDDERs to abstain from bribing or indulging in any corrupt practice in order to secure the Contract by providing assurance to them that their competitors will also abstain from bribing and Other corrupt practices and the PRINCIPAL will commit to prevent corruption, in any form, by its Officials by following transparent procedures.

The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:-

#### 1. COMMITMENTS OF THE PRINCIPAL

- 1.1. The PRINCIPAL undertakes that no official of the PRINCIPAL, connected directly or indirectly with the contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER, either for themselves or for any person, organization or third party related to the contract in exchange for an advantage in the bidding process, bid evaluation, contracting on implementation process related to the contract.
- 1.2. The PRINCIPAL will, during the pre-contract stage, treat all BIDDERs alike and will provide to all BIDDERs the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERs.
- 1.3. The officials of the PRINCIPAL will report to the appropriate Government office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such a breach.

In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the PRINCIPAL with full and verifiable facts and the same is prima facie found to be correct by the PRINCIPAL, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the PRINCIPAL and such a person shall be debarred from further dealings related to the contract process.





In such a case while an enquiry is being conducted by the PRINCIPAL the proceedings under the contract would not be stalled.

### 2. COMMITMENTS OF BIDDERS

The BIDDER commits itself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any precontract or post-contract stage in order to secure the contract or in furtherance to secure it and in particular commit itself to the following:-

- 2.1. The BIDDER will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the PRINCIPAL, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
- 2.2. The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the PRINCIPAL or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract of any other contract with the government for showing or forbearing to show favour or disfavor to any person in relation to the contract of any other contract with the Government.
- 2.3. BIDDERs of foreign origin shall disclose the name and address of their Indian agents and representatives, if any and Indian BIDDERs shall disclose their foreign principals or associates, if any.
- 2.4. BIDDERs shall disclose the payments to be made by them to their Indian agents/brokers or any other intermediary, in connection with this bid/contract and the payments have to be in Indian Rupees only.
- 2.5. The BIDDER further confirms and declares to the PRINCIPAL that the BIDDER is the original manufacturer/ integrator/authorized agent of the stores/equipment/items and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the PRINCIPAL or any of its functionaries, whether officially or unofficially to the award of the contract to the BIDDER, nor has any amount been paid, promised or intended to be paid to any such



- individual, firm or company in respect of any such intercession, facilitation or recommendation.
- 2.6. The BIDDER, either while presenting the bid or during pre-contract negotiations or before signing the contract, shall disclose any payments he has made, is committed to or intends to make to officials of the PRINCIPAL or their family members, agents, brokers or any other intermediaries in connection with the contract and the details of services agreed upon for such payments.
- 2.7. The BIDDER will not collude with other parties interested in the contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
- 2.8. The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.
- 2.9. The BIDDER shall not use improperly, for purposes of competition or personal gain, pass on to others, any information provided by the PRINCIPAL as part of the business relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.
- 2.10. The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- 2.11. The BIDDER shall not instigate or cause to instigate any third person to commit any of the actions mentioned above.
- 2.12. If the BIDDER or any employee of the BIDDER or any person acting on behalf of the BIDDER, either directly or indirectly, is a relative of any of the officers of the PRINCIPAL, or alternatively, if any relative of an officer of the PRINCIPAL has financial interest/stake in the BIDDER's firm, the same shall be disclosed by the BIDDER at the time of filing of tender. The term 'relative' for this purpose would be as defined in section 6 of the Companies Act 1956.
- 2.13. The BIDDER shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any employee or the PRINCIPAL.

### 3. PREVIOUS TRANSGRESSION

3.1. The BIDDER declares that no previous transgression occurred in the last three years immediately before signing of this Integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any Public



Sector Enterprise in India or any Government Department in India that could justify; BIDDER's exclusion from the tender process.

3.2. The BIDDER agrees that if it makes incorrect statement on this subject, BIDDER can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

#### 4. EARNEST MONEY (SECURITY DEPOSIT)

- 4.1. While submitting commercial bid, the BIDDER shall deposit an amount NIL (to be specified in RFP) as Earnest Money as applicable/Security Deposit, with the PRINCIPAL through any of the following instruments:
  - (i) Bank Draft of Pay Order in favor of CSL.
  - (ii) A confirmed guarantee by an Indian Nationalized Bank, promising payment of the guaranteed sum to the PRINCIPAL on demand within three working days without any demur whatsoever and without seeking any reasons whatsoever. The demand for payment by the PRINCIPAL shall be treated as conclusive proof of payment.
  - (iii) Any other mode or through any other instrument (to be specified in the RFP).
- 4.2. The Earnest Money if applicable/Security Deposit shall be valid upto the complete conclusion of the contractual obligations to the complete satisfaction of both the BIDDER and the PRINCIPAL, including warranty period.
- 4.3. In case of the successful BIDDER a clause would also be incorporated in the Article pertaining to Performance Bond in the Purchase Contract that the provisions of sanctions for Violation shall be applicable for forfeiture of Performance Bond in case of a decision by the PRINCIPAL to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.
- 4.4. No interest shall be payable by the PRINCIPAL to the BIDDER on Earnest Money/Security Deposit for the period of its currency.

### 5. SANCTIONS FOR VIOLATIONS

- 5.1. Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the PRINCIPAL to take all or any one of the following actions, wherever required: -
  - (i) To immediately call off the pre contract negotiations without assigning any reason or giving any; compensation to the BIDDER. However, the proceedings with the other BIDDER(s) would continue.



- (ii) The Earnest Money Deposit (in pre-contract stage) and/or Security Deposit/ Performance Bond (after the contract is signed) shall stand forfeited either fully or partially, as decided by the PRINCIPAL and the PRINCIPAL shall not be required to assign any reason therefore.
- (iii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER.
- (iv) To recover all sums already paid by the PRINCIPAL, and in the case of an Indian BIDDER with interest thereon at 2% above the prevailing Prime Lending Rate of State Bank of India, while in case of a BIDDER from a country other than India with interest thereon at 2% above the LIBOR (London Inter Bank Offer Rate). If any outstanding payment is due to the BIDDER from the PRINCIPAL in connection with any other contract for any other stores, such outstanding payment could also be utilized to recover the aforesaid sum and interest.
- (v) To en cash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the PRINCIPAL, along with interest.
- (vi) To cancel all or any other contracts with the BIDDER. The BIDDER shall be liable to pay compensation for any loss or damage to the PRINCIPAL resulting from such cancellation/recession and the PRINCIPAL shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
- (vii) To debar the BIDDER from participating in the future bidding processes of CSL for a minimum period as deemed appropriate, which any be further extended at the discretion of the PRINCIPAL.
- (viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middle man or agent or broker with a view to securing the contract.
- (ix) In cases where irrevocable Letters of Credit have been received in respect of any contract signed by the PRINCIPAL with the BIDDER, the same shall not be opened.
- (x) Forfeiture of Performance Bond in case of a decision by the PRINCIPAL to forfeit the same without assigning any reason for imposing sanction for violation of this pact.
- 5.2. The PRINCIPAL will be entitled to take all or any of the actions mentioned at para 6.1(i) to (x) of this pact also on the Commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER), of an offence as defined in chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other statute enacted for prevention of corruption.



- 5.3. The decision of the PRINCIPAL to the effect that a breach of the provisions of this pact has been committed by the BIDDER shall be binding on the BIDDER. However, the
- 5.4. BIDDER can approach the Independent Monitor(s) appointed for the purposes this Pact.

### 6. FALL CLAUSE

6.1. The BIDDER undertakes that it has not supplied/is not supplying similar product/systems/items or subsystems at a price lower than that offered in the present bid in respect of any other Ministry/Department of the Government of India or PSU and if it is found at any stage that similar product/systems or sub systems/items was supplied by the BIDDER to any other Ministry/Department of the Government of India or PSU at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to the PRINCIPAL, if the contract has already been concluded.

### 7. INDEPENDENT MONITORS

7.1. The PRINCIPAL has appointed Independent Monitors (hereinafter referred to as Monitors) for this Pact in consultation with the Central Vigilance Commission.

7.2. The task of the Monitors shall be to review independently and objectively, whether and to what extend the parties comply with the obligations under this Pact.



- 7.3. The Monitors shall not be subject to instructions by the representatives of the parties and perform their functions neutrally and independently.
- 7.4. Both the parties accept that the Monitors have the right to access all the documents relating to the project/procurement, including minutes of meetings.
- 7.5. As soon as the Monitor notices, or has reason to believe, a violation of this pact, he will so inform the Authority designated by the PRINCIPAL.
- 7.6. The PRINCIPAL accepts that the Monitor has the right to access without restriction to all Project documentation of the BUYER including that provided by the BIDDER. The BIDDER will also grant the Monitor, upon his request and demonstration of a valid interest, unlimited access to his project documentation. The same is applicable to Subcontractors. The Monitor shall be under contractual obligation to treat the information and documents of the BIDDER/Subcontractor(s) with confidentiality.
- 7.7. The PRINCIPAL will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the parties. The parties will offer to the Monitor the option to participate in such meetings.
- 7.8. The Monitor will submit a written report to the designated Authority of PRINCIPAL/Secretary in the Department/ within 8 to 10 weeks from the date of reference or intimation to him by the PRINCIPAL /BIDDER and, should the occasion arise, submit proposals for correcting problematic situations.

### 8. FACILITATION OF INVESTIGATION

In case of any allegation of violation of any provisions of this pact or payment of commission, the PRINCIPAL or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER. The BIDDER shall provide necessary information and documents in English and shall extend all possible help of the purpose of such examination/inspection.

### 9. LAW AND PLACE OF JURISDICTION

This Pact is subject to Indian Law. The place of performance and jurisdiction is the seat of the PRINCIPAL.

#### 10. OTHER LEGAL ACTIONS

The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extent law in force relating to any civil or criminal proceedings.



### 11. VALIDITY

- 11.1. The validity of this Integrity Pact shall be from date of its signing and extend upto 5 years
  - or the complete execution of the contract to the satisfaction of both the PRINCIPAL and the BIDDER/Seller, including warranty period, whichever is later. In case BIDDER is unsuccessful, this Integrity Pact shall expire after six months from the date of the signing of the contract.
- 11.2. Should one or several provisions of this Pact turn out to be invalid; the remainder of this pact shall remain valid. In this case, the parties will strive to come to an agreement to their original intentions.
