2. The scope of the turnkey work includes complete design, manufacture, supply, installation, testing and commissioning of following systems in accordance with the Technical Specification, Drawings and Bill of quantities.
 - a) Fire water system
 - b) Industrial water system
 - c) Compressed air system
 - d) Carbon dioxide system
 - e) Acetylene manifold facility.
 - f) Potable water piping (interconnection of existing line to tie in points)
 - g) Oxygen system piping (interconnection of existing line to tie in points)
 - h) Argon system piping (interconnection of existing line to tie in points)
3. The location of the above works is at Cochin Shipyard Limited, Kochi which is located on the South Western coast of India at latitude 9^o 57' 14" N and longitude 76^o 17' 20" E, in the state of Kerala.
4. Bid document is available at CSL website www.cochinshipyard.in and <https://eprocure.gov.in/epublish/app>. Interested contractors / firms may download the bid documents from the website and submit their offer.
5. Bidders submitting the bid after downloading from the website shall have to furnish the cost of the bid documents through Banker's Cheque / Demand Draft / NEFT payment from any Nationalized Bank / Scheduled Bank in India drawn in favour of CSL, payable at Kochi for the amount indicated in the NIT, and enclose the same in the sealed cover along with Techno Commercial bid failing which the bid shall not be considered for further consideration / evaluation.
6. This work comes under the category of Works Contract. All the firms who are registered with District Industries Centre and come under the category of Micro & Small Enterprises holding a valid EM Part-II certificate, tender forms will be issued free of cost. Required documents for proof of MSME registration shall be submitted in this regard.
7. It is a specific requirement for considering the bid that the Bidders should sign and submit an "Integrity Pact" to be executed between the Bidder and CSL and to be enclosed along with Techno Commercial bid. Bids not accompanied by a duly signed "Integrity Pact" shall be liable for rejection. Integrity Pact shall be in force and shall cover the bid processing also. Integrity Pact shall cover this tender throughout its various phases, and Integrity Pact would be deemed as a part of the contract though an appropriate provision. The interested firms shall deposit their offer in the tender box kept at the office of Infra Projects Dept, Ground floor, Administrative Building, Cochin Shipyard Ltd on or before **15:00 Hrs IST on 21 June 2023** and the technical bid will be opened on the same day at **15:30 Hrs IST**. Email tenders will not be accepted.
9. Only bidders with valid Permanent Account Number (PAN), GST Registration, EPF/ESI registration need to participate in this tender. Proof of respective registration shall be submitted along with the bid.
10. The tenderer should keep open the validity of the tender normally for 90 days from the date of opening of bid. However, it is also obligatory for the tenderer to keep the validity open for another 60 days for which request in writing / email by DGM (Infra Projects), before the expiry of the original validity, would be intimated. The receipt of the intimation of DGM (Infra Projects) should be acknowledged. Should any tenderer withdraw his tender before this period or makes any modifications in the terms and conditions of the tender which are not acceptable to CSL, the earnest money deposited by the tenderers shall be forfeited.
11. Bids received after the stipulated last date and time for receipt of bids, due to any reasons will not be considered.
12. Tenders with conditions and conditional rebates / discounts will be summarily rejected.
13. CSL reserves the right to postpone / cancel / reject any or all the bids without assigning any reason thereof at any stage of the tender, which shall be binding on all bidders.
