Sub: CORRIGENDUM No.1 Dtd: 26/05/2023 for Electrical Outfit Structural Works – Installation of Cable Ways & Equipment Seats Excluding Superstructure of MPV (SH.29-SH.36)

Ref: 1. Tender No. SB-OSD/MPV/774/2023 Dtd: 16.05.2023

Subsequent to the above, CSL here by amending the clauses of tender enquiry as followings:

1. Note (E) of Annexure V of Tender enquiry is amended as :
"Modification/additional works up to +10% of total work order value per vessel in price bid shall be under contractor's scope. For re-works more than 10%, the following shall be applicable :
 - i) *In case of relocation of work due to amendment in CSL drawings, 40% of that particular line item rate for removal & dry-survey and installation rate as applicable for installation at new location".*
2. Clause no.2.5 of Annexure I of the tender enquiry is amended as :
"Sufficient number of supervisors and workmen with relevant experience is to be provided by the firm. Document supporting the experience of the supervisors/workmen is to be provided. In order to meet CSL time line a minimum of 15 workmen / vessel has to be arranged by the successful firm. An undertaking which confirms the above requirement as per the format placed at Appendix- B shall be submitted along with the offer".
3. Undertaking is attached as Appendix B of the tender enquiry.

4. **Date of receipt of bids (Part I – Techno-Commercial Bid & Part II-Price Bid) extended up to 01st June -2023 at 15.00 Hrs.** and Part I Techno-Commercial Bid will be opened at **15.30 Hrs** on the same day.
5. Except the above, all other terms and conditions of the tender enquiry will remain unchanged.
