TERMS AND CONDITIONS

TENDER FOR CONSTRUCTION OF MATERIAL STORAGE SHED

1. DESCRIPTION OF WORK:

- 1.1. This tender enquiry pertains to the awarding of contract for construction of material storage shed adjacent to existing NBS shed at UCSL Malpe.
- 1.2. The work involves the fabrication, supply, erection, and finishing of a new structural steel shed to be constructed adjacent to the existing new building shed and Piping shed at UCSL.
- 1.3. The new shed shall share one side with the New Building Shed and also adjoin the Piping Shed. All works shall be carried out in accordance with the provided GA drawings, standard engineering practices, and relevant Indian Standards.

2. SCOPE OF WORK:

- 2.1. Structural Steel Works.
- 2.1.1. Columns
 - Section: 450 ISBM
 - Base Plate: 25 mm thick plate (700 mm × 1100 mm)
 - Top Plate: 8 mm thick plate
 - Columns shall be fabricated with required stiffeners and splice connections.
 - Columns to be fixed on the existing foundation after verifying alignment, level, and bolt positions.
 - Necessary shims, base grouting, and levelling arrangements to be provided by the contractor for accurate erection.
 - Column spacing, orientation, and height shall conform to GA drawings.
 - Two additional columns to be provided with proper foundation as per the GA drawings.

2.1.2. Beams and Trusses

- Main Truss:
 - Top & bottom chords: 100 NB × 5.4 mm thick circular pipe
 - Web members: 50 NB × 3.6 mm thick circular pipe
- Gusset plates: 16 mm thick mild steel plates at joints.
- · All trusses to be erected as per spacing and slope indicated in GA drawings.

Purlins and Girts 2.1.3.

- ISMC 125 mm channel section.
- Fixed using cleats and galvanized bolts/nuts.

2.1.4. Bracings

- Top and side bracing: 40 NB × 2.9 mm thick pipe.
- Bracings to be securely welded or bolted at designated locations.

Fasteners and Welding 2.1.5.

Bolted connections: M16 hotedip galvanized bolts and nuts.

• Welding to conform to IS 816 / IS 9595, using E7018 electrodes.

2.2. Roofing and Side Cladding Works

- Material: Pre-coated Galvalume sheet, 0.50 mm total coated thickness.
- Profile: Trapezoidal, 5-corrugation type.
- Protective Film: Sheets shall be supplied with a minimum 25-micron protective guard film to prevent scratches during handling and transportation.
- Sheet Length: Sheets shall be supplied in single lengths up to 10 meters.
- Colour: The colour of the new roofing sheets shall match the existing NBS roof (RAL 5015).
- Fixing: Roofing sheets shall be fixed using GI self-drilling screws with cyclone washers with EPDM seal, ensuring watertight joints.
- Fixing: Sheets shall be fixed using GI self-drilling screws with cyclone washers and EPDM seals, ensuring watertight joints.
- Flashing: L-flashing shall be provided to ensure leak-proof installation and proper water drainage.

2.3. Gutter and Rainwater System

- · Fabrication and installation of rainwater gutters along roof edge.
- Material: PVC gutters and downpipes of suitable diameter and thickness.
- Sufficient downpipes to be provided.

2.4. Shutters

- Three (3) nos. of shutters as per GA drawings.
- Type: GI rolling shutters with side guides, locking arrangement, and all required fittings.

2.5. Surface Preparation and Painting

2.5.1. Surface Preparation:

Surface preparation shall be carried out by mechanical or abrasive cleaning to remove rust, oil, grease, and mill scale.

2.5.2. Primer Coat

- Type: Two coats of Epoxy Phenylamine Primer.
- Volume Solids: Minimum 63%.
- Dry Film Thickness (DFT): Minimum 100 microns per coat.
- Performance: Shall exhibit a minimum salt spray resistance of 1500 hours.

2.6. Intermediate Coat

• Type: Two coats of Epoxy coating cured with Aliphatic Amine.

- Volume Solids: Minimum 85%.
- Dry Film Thickness (DFT): 150 microns per coat.
- Performance: Shall exhibit a minimum salt spray resistance of 2000 hours.

2.7. Finish Coat

- Type: Two coats of Aliphatic Acrylic Polyurethane (PU) paint.
- Volume Solids: Minimum 52%.
- Dry Film Thickness (DFT): 50 microns per coat.
- Performance: The coating shall retain at least 80% gloss level after 1000 hours of UV-B lamp exposure.

3. THE SCOPE OF THE CONTRACTOR ALSO INCLUDES:

- 3.1. Collection, Transportation/unloading of materials/other equipment in UCSL premises.
- 3.2. Maintaining the required Dimensional accuracy and surface finish as per UCSL Standards.
- 3.3. Providing all personnel protective items like safety helmets, gloves, welding shields, goggles, leg guards, safety belts, aprons, safety shoes, etc. to their employees.
- 3.4. All civil works shall be executed as per relevant Indian Standards.

4. THE SCOPE OF UCSL ALSO INCLUDES THE SUPPLY OF THE FOLLOWING MATERIALS:

- 4.1. Supply of electricity and water while erection at the UCSL site shall be provided by UCSL.
- 4.2. Crane/Hydra at UCSL premises will be provided by UCSL as per the availability.

5. INFRASTRUCTURE AND CONSUMABLES:

5.1. Welding electrode and-all other consumables such as cutting wheels, grinding wheels, etc., are under the scope of the contractor.

7. SCHEDULE OF COMPLETION:

- 7.1. Duration for completion and handing over of fully commissioned material storage shed shall be 2 months counted from 7th day of issuance of work order/ confirmation.
- 7.2. Defect liability period for material storage shed works shall be 12 Months counted from the date of handing over of fully completed material storage shed to UCSL.

8. WORK PROGRESS AND SCHEDULE:

- The construction of the material storage shed shall commence and be completed as per the schedule of completion indicated art clause no. 7 above.
- 8.2. The work is urgent and hence the contractor should start the work within 7 days from the issue of work order/ Confirmation.
- 8.3. The contractor must submit a detailed schedule of work.

9. ADDITIONAL WORKS:

- 9.1. Any additional work up to 5% growth of work in terms of total weight/unit is to be envisaged and is to be undertaken without any additional price impact.
- 9.2. Any minor modifications, resulting from the change in statutory regulations prevailing at the time of final inspection of work to be carried out by the Contractor free of cost. In case of rework/modification/additional work, written consent is to be obtained from the officer in charge before the commencement of the work.
- 9.3. Contractor shall carry out the complete work in accordance with Shipyard's approved of drawings submitted. Any minor modifications from drawing or any other work or supply of material, which is not specified hereunder, but is considered incidental and essential for the successful completion of the job shall be carried out by the Contractor without any additional charge.
- 9.4. Contractor shall execute, during or after completion of the work, any minor job connected with the work, that is considered necessary by Shipyard.
- 9.5. The contractor shall be responsible for any damage caused to the material supplied by UCSL. Compensation with penalty for damage or loss of the item will be recovered from the Contractor, in the event of loss or damage.

10.INSPECTION

- 10.1. The complete work has to be carried out under the UCSL officer in charge.
- 10.2. Contractor to maintain the required dimensional accuracy and surface finish as per quality standards.
- 10.3. All works shall be as per strict compliance with weight control and approved drawings.

11.MINIMUM QUALIFICATION CRITERIA FOR PARTICIPATING IN THE TENDER WILL BE AS FOLLOWS:

11.1. The contractor should have one similar structural work of not to be less than Rs. 90 lakhs in last 5 years from the date of issue of tender document. Satisfactory completion certificate from the Client for work done should be submitted along with bid. For ongoing work, relevant certification from client shall be submitted along with copy of Purchase Order.

Or

The contractor shall have successfully completed of at least two similar structural works in last 5 years from the date of issue of tender document. The value of each work should not be less than Rs. 60 lakhs. Satisfactory completion certificate from the Client for work done should be submitted along with bid. For ongoing work, relevant certification from client shall be submitted along with copy of Purchase Order.

Or

The contractor shall have successfully completed of at least three similar structural works in last 5 years from the date of issue of tender document. The value of each work should not be less than Rs. 45 lakhs. Satisfactory completion certificate from the Client for work done should be submitted along with bid. For ongoing work, relevant certification from client shall be submitted along with copy of Purchase Order.

- 11.2. The Annual Turnover of the contractor should be more than Rs. 35 Lakhs in each financial year for the last three preceding years. (Audited Balance sheets showing turnover, Profit & Loss account of the firm for the preceding 03 years (2022-23, 2023-24,2024-25) should be submitted along with the application for prequalification).
- 11.3. Offers from joint ventures/consortium will not be accepted.
- 11.4. Bidder shall not be under a declaration of ineligibility issued by Govt. of India/ State govt./ Public Sector Undertakings etc. The bidder shall not have been debarred / black listed / under Termination list by UCSL or by any of the Public Sector Undertaking or Government department etc.

12. METHOD OF AWARDING CONTRACT:

- 12.1. Contract will be concluded with Bidder qualifying technically (including eligibility criteria), agreeing to Commercial conditions (Annexure -V) and emerging as L1.
- 12.2. UCSL also reserves the right to split the work orders to any number of bidders willing to match with L1 rate, if the performance of selected bidder is not satisfactory.
- 12.3. UCSL reserves the right to cancel the tender if required.

13. VALIDITY:

13.1. The offer shall be valid for a period of 12 months and no escalation in rate shall be allowed by UCSL on whatsoever reason.

14. RATE:

14.1. Rates are to be quoted in the Price Bid Format at Annexure IV attached herewith.

15. PAYMENT TERMS:

15.1. Payment will be done in TWO (02) stages:

Stage I: 50% of Total contracted value

Payment shall be made upon supply of materials, based on actuals, along with acceptance certificate from the executing UCSL officer.

Stage II: 50% of Total contracted value

Payment shall be made upon completion of the entire scope of work, based on actuals, handing over to UCSL.

- 15.2. Payment shall be made within 30 days from the date of submission of bill and work completion certificate from the executing UCSL officer.
- 15.3. Invoice shall be submitted with necessary work completion certificate duly certified by UCSL representative on actuals.
- 15.4. Payment will be made by RTGS/NEFT to the account of Agency. The name of the bank, branch, A/C No., IFSC code & other particulars shall be furnished by the Agency in the proforma of UCSL.

16. TAXES & DUTIES:

- 16.1. GST shall be applicable extra on the prescribed work. You are requested to furnish the following details in the invoice/Bill.
 - Applicable rate of GST/SAC Code
 - Firms GST Reg. NO.
 - Service accounting code (SAC) as prescribed by statutory authorities.
 - GST Reg. No. of Udupi Cochin Shipyard Limited (29AAACT1281B1ZO).

17. SECURITY DEPOSIT:

17.1. The successful tenderer shall remit 5% of the value of the contract as security deposit within 15 days of receipt of the work order. This amount may be remitted by way of demand draft or bank guarantee (in approved proforma of UCSL) from any of the nationalized banks, valid till the satisfactory completion of the entire work. The Security Deposit will be released on certification of satisfactory completion of the contract and no liability to UCSL by Officer-in charge. The Security Deposit retained will not bear any interest.

18. PERFORMANCE GURANTEE:

- 18.1. The complete work carried out by the contractor shall be guaranteed against defective on poor workmanship for a period of one (01) year from the date of completion of work, any work found defective during this period is to be repaired entirely at the contractor's cost and such repaired items shall be guaranteed for a further period of three months from the date of repair.
- 18.2. Should any unsatisfactory performance and / or damage or failure occur due to poor workmanship and poor-quality material used by the contractor, the contractor shall be solely responsible for payment/reimbursement of expenditure incurred by UCSL for rectifying the defect.
- 18.3. Towards this, a performance guarantee equivalent to 5% of the value of the contract to be furnished by the contractor on completion of the works by way of a

bank guarantee (in approved proforma of UCSL) from a nationalized bank valid till the expiry of the guarantee period. In case the contract fails to submit the PG in time, SD mentioned at Clause 17 will be retained till the expiry of guarantee period.

19. LIQUIDATED DAMAGES:

- 19.1. The progress of work will be monitored against the mutually agreed detailed schedule. Liquidated damages for delays in engagement of manpower as per the requirement, for any reason other than force majeure conditions, will be recovered at the rate of half percent of the value of the contract per week or part thereof, subject to a maximum of ten (10) percent of the value of the contract.
- 19.2. For better clarity, order values mentioned in LD clause are values excluding duties and taxes (Basic value). Liquidated damages, if any, shall be decided and settled only after the completion of the entire project but prior to the release of Final stage Payment.
- 19.3. If, for any reasons, supplier has a justification towards delay in supply / work execution and would intend to consider applicability/ non applicability of LD, the same shall be intimated to UCSL by way of a letter, failing which it will be deemed that delay is attributable to the supplier.
- 19.4. Delay in supply/Interruption of the work for reasons not attributable to supplier shall entitle extension of the order execution period for proportionate period without any additional cost to UCSL.

20. POWER OF ATTORNEY:

- 20.1. The tenderer(s) shall have to sign in each page of the tender documents with official stamp as a token of his acceptance of the conditions stated therein.
- 20.2. The person signing the tender form on behalf of another or on behalf of a firm, shall enclose to the tender, a Power of Attorney or the said deed duly executed in his favour or the partnership deed giving him such power showing that, he has the authority to bind such other persons or the firm, as the case may be, in all matters pertaining to the contracts. If the Person so signing the tender, fails to enclose the said Power of Attorney, his tender shall be liable for being summarily rejected. The Power of Attorney shall be signed by all partners in the case of partnership concern, by the Proprietor in the case of a proprietary concern, and by the person who by his signature can bind the company in the case of a Limited Company.

21. TERMINATION & LIMITATION OF LIABILITY:

- 21.1. This contract may be terminated upon the occurrence of any of the following events.
- 21.2. By agreement in writing of the parties hereto;
- 21.3. By the non-defaulting party, upon default by the other party, of any clause of this contract, if not remedied within fifteen (15) days, or such longer time as may be agreed upon by the parties, after receipt of notice thereof in writing from the nondefaulting party;
- 21.4. By the other party, upon either party;
 - i. Making the assignment for the benefit of creditors, being adjudged a bankrupt or becoming insolvent; or
 - ii. Having a reasonable petition filed seeking its' dissolution or liquidation, not stayed or dismissed within sixty (60) days; or
 - iii. Ceasing to do business for any reason.
- 21.5. For fraud and corruption or other unacceptable practices

- 21.6. Upon expiry or termination of this Contract, neither party shall be discharged from any antecedent obligations or liabilities to the other party under this Contract unless otherwise agreed in writing.
- 21.7. UCSL may by notice in writing to Agency to terminate the order after issuing due notice i.e., 30 days' notice period. UCSL shall be entitled to compensation for loss limited to the order value.
- 21.8. Liability maximum that can be claimed by the Agency shall be limited to what is due to be and has been paid by UCSL for work done as per the payment milestones and limited to work order value.

22. ARBITRATION & JURISDICTION:

- 22.1. Any disputes arising during the period of the contract shall, in the first instance be settled by mutual discussions and negotiations. The results of such resolution of dispute shall be incorporated as an amendment to the contract, failing which supplier shall approach the UCSL Grievance Redressal Committee as per relevant clause of the Contract.
- 22.2. If any dispute, disagreement or question arising out of or relating to or in consequence of the contract, or to its fulfillment, or the validity of enforcement thereof, cannot be settled mutually or the settlement of which is not herein specifically provided for, then the dispute shall within thirty days from the date either party informs the other in writing that such disputes, disagreement exists, be referred to arbitration. The arbitrators shall be appointed and the arbitration proceedings shall be conducted in accordance with and subject to the Arbitration and Conciliation Act, 1996 (No. 26 of 1996) as amended from time to time and the decision of the Arbitrators shall be final and binding on the parties hereto. The arbitration will be done by a Board comprising one arbitrator nominated by each party, and a mutually agreed Umpire. Each party shall bear its own cost of preparing and presenting its case. The cost of arbitration shall be shared equally by the parties unless the award provides otherwise. Performance under this Contract shall however, continue during arbitration proceedings and no payment due or payable by the parties hereto shall be withheld unless any such payment is or forms a part of the subject matter of arbitration proceedings.
- 22.3. Seat & Venue of Arbitration: The seat & venue of arbitration shall be at Bangalore.
- 22.4. Language of Arbitration: The Language of arbitration shall be English.
- 22.5. Governing Law: The contract shall be governed by Indian Law.
- 22.6. In case of disputes, the same will be subjected to the jurisdiction of courts at Bangalore, Karnataka.

23. SUB CONTRACTING AND ASSIGNMENT:

- 23.1. Contractor shall not assign or transfer the Purchase Order/ Work Order or any share or interest therein in any manner or degree to any third party without the prior written consent of UCSL.
- 23.2. Contractor shall not contract with any subcontractor and/or vendor without the prior written consent of UCSL. Such consent shall not relieve the Contractor from any of his responsibilities and liabilities under the Purchase Order/ Work Order. In addition, Contractor shall ensure that the terms and conditions of any such contract shall comply with and correspond to the terms and conditions of the Purchase Order/ Work Order.

24. SECRECY & RESTRICTION ON INFORMATION TO MEDIA:

- 24.1. The information contained in the enquiry as such shall NOT be communicated to any third party without prior approval of UCSL.
- 24.2. Information in respect of contracts/orders shall NOT be released to the national or international media or anyone not directly involved in its execution without the written approval of UCSL.

25. CANCELLATION OF ORDER AND RISK CONTRACTING:

- 25.1. In the event the Agency fails to complete the work promptly and satisfactorily as per the terms of the order, and if any work is delayed beyond thirty (30) days from the agreed schedule, UCSL, without prejudice, reserves the right to cancel the order and get the work done at Agency's cost and the expenditure so incurred including any damage or loss will be recovered from him and the Security Deposit furnished by him is liable to be forfeited either in whole or in part.
- 25.2. UCSL also reserves to right to impose penalties ranging from Rs. 100 to Rs.500 to the employees of agencies and will be deducted from the bills, for any habitual offence on the cleanliness of uniforms, lack of obedience, not attending the tasks etc., and will be to the discretion of the Officer in charge for the work.

26. FORCE MAJEURE

26.1. Should failure in performance of any part of this contract arise from war, insurrection, restraint imposed by Government act or legislation of other statutory authority, from explosion, riot, legal lock-out, flood, fire, act of God or any inevitable or unforeseen event beyond human control which will be construed as a reasonable ground for extension of time, UCSL may allow such additional time as is mutually agreed to be justified by the circumstances of the case.

27. IMS GUIDELINES:

- 27.1. UCSL implemented an Integrated Management System (IMS) and the Quality Management System (QMS) within the yard. As part of IMS, subcontractors shall comply with the following measures related to the Quality, Health, and Safety & Environment (QHSE) policy of UCSL.
 - Meeting or exceeding customer requirements.
 - b) Assuring quality of the products and service.
 - Preventing occupational ill health & injuries.
 - d) Ensuring safe work sites.
 - e) Conserving natural resources.
 - Preventing / minimizing air, water & land pollution.
 - Handling and disposal of Hazardous wastes safely.
 - h) Complying with statutory & regulatory and other requirements.
 - Developing skills and motivating employees.
- 27.2. Occupational Health, safety & Environmental requirements of UCSL shall include the following.
 - a) The contractor (or a sub-contractor performing work on behalf of the contractor) is deemed to comply with the Occupational health, safety and environmental policy of the company and also to all operational controls/standard operating procedures and shall undertake the work in total compliance with the requirements of the established Integrated Management System (IMS) of the companyor

- b) The Contractor shall undertake the work in total compliance with all applicable legal/statutory requirements related to occupational health, safety and environment effective in the state of Karnataka.
- It is the sole responsibility of the contractor to assure that any subcontractor/s who shall perform works in company lands/facilities/worksites on behalf of the contractor, is also following all requirements related to the System Integrated Management of the company health/safety/environmental Rules effective in the state.
- shall provide/implement and operate/practice The contractor environmental occupational health, safety and measures/facilities, for their period of contract, in their activities/at their work sites, which shall be required according to the IMS of the company or that required by the health/safety/environmental Rules established and effective in the state, at their own cost.

A copy of UCSL's "Safety Rules for Contractors (Revised)" is available with HSE department for reference.
- 28.2. The Agency may arrange to suitably insure all his workmen/ other personnel in this regard. UCSL will not be responsible for any injury or illness to the Agency's workmen/other personnel during execution of the works due to whatsoever reasons.
- 28.3. In this regard, the Contractor will have to fully indemnify UCSL against any claims made by his workmen/other personnel.
- 28.4. The Agency shall provide and maintain so as to be readily accessible during all working hours, a first aid box with prescribed contents at every place where he employs contract labor for executing the works.

29. LABOUR LAWS AND REGULATIONS:

- 29.1. The Contractor should employee INDIAN NATIONALS with valid citizenship only for works inside UCSL premises.
- 29.2. The Agency shall undertake and execute the work with contract Labor only after taking license from the appropriate authority under the Contract Labor (Regulation & Abolition) Act 1970. CONTRACT

All Persons, except those exempted under the respective Acts, shall necessarily be insured under the ESI scheme and be made members of the EPF Scheme from the day of their engagement as personnel in the Company. In Case 1, All such insured Persons should carry with them their ESI Identity Card for verification by the authorities. 30. OVERWRITING & CORRECTIONS:

30.1. Tenders shall be free from overwriting or erasures. Corrections and additions, if any, shall be duly attested and a separate list of such corrections shall be attached with the offer.




