ANNEXURE-I

A. SCOPE OF WORK

- The scope of work includes design, supply, installation, testing and commissioning of high quality fast-acting NVR based IP CCTV surveillance system in Cochin Shipyard Limited – Kolkata Ship Repair Unit on turnkey basis as per following details.
 - a) The system should be designed to facilitate the monitoring of the cameras 24 x 7 basis with 30 days back up.
 - b) The system should have the facility to enable the video recording manually whenever required. The NVR should have the facility to support minimum 1 No. 8 TB surveillance hard disk to get maximum recording backup. The system should have a security/ password protection to NVR system to avoid un-authorized access of video footage/ data storage.
 - c) The fixed bullet type outdoor IP cameras shall be installed on suitable PVC box aesthetically at inside the CKSRU as per CSL requirement to cover the entire area properly.
 - d) The IR PTZ cameras shall be installed on the dry dock at suitable location to cover the entire dry dock properly.
 - e) 2 No's 43" commercial smart LED TV to be installed one at the Security room (CCTV control room) and another at the HOD room for viewing real-time livestream from all the CCTV cameras.
 - f) All the channels of the NVR should be fully licensed and the license should be perpetual/ valid lifetime without any kind of usage restrictions. All camera's & NVR with viewing software shall be from the same make.
 - g) 4 port Gigabit POE network switch, 8 port Gigabit POE switch, 32P Network Video Recorder 2 HDD up to 20TB storage, UPS, 4 U rack shall be installed and mount properly.
 - h) Install the display and NVR as per site condition with proper mounting and Establish connectivity with compatible cable. Provide a mouse for control/ operation purpose.
 - A UPS shall be provided with 30 minute backup time Provide power from UPS to NVR & to cameras through POE network switch.
 - j) The system is presently designed for total 11 Nos. cameras (9 Nos. bullet cameras & 2 Nos. PTZ cameras). There shall be provision for addition of cameras as per available NVR channel.
 - k) All mountings and cabling should be done aesthetically.
 - NVR shall be connected to monitor properly using HDMI cable and HDMI selector for selecting the input to monitor.
 - m) Proper connectivity should be established between all equipment with compatible cables and connectors.
 - Programming, Testing and commissioning of the system shall be performed to the satisfaction of CSL Officer-in charge of the project and the system shall be presented to CSL for performance validation during commissioning time.
 - o) All the required materials, labour, tools and tackles to complete the job scope is in the contractor scope.
- 2) <u>The major components for CCTV system</u>: The following indicative list of items along with respective quantities (not limited to) shall be considered minimum requirement for preparing the quotation. However, if any extra item or

quantity required for successful competition of the project, same to be added by the Contractor under their scope of work without any extra cost.

3) <u>Cabling:</u>

- a) Cables shall be laid from cameras to NVR pipes with proper clamping and bunching as per the site requirement.
- b) The cable shall be laid properly and clamped as required and proper identifications shall be given at both ends.
- c) The cable shall be laid in single length and joints shall be avoided.
- d) Cables, pipes, terminal strips, jack, glands, connectors, reducers, bent, Elbow termination accessories, case and cap and other required materials for the cabling work shall be supplied by the contractor/bidder.
- e) Provide sufficient length cables as per site condition and establish proper connectivity between all equipment as per scope of work.

4) <u>Note:</u>

- a) For understanding the site conditions, site study can be arranged.
- b) The contractor should provide drawings/operation / service manuals of all items supplied and also the detailed operation manual of the CCTV integration along with service hints.
- c) Training to be provided in operation/ selection settings etc. to the maintenance staff/ operator.
- d) Any additional items including software & hardware /accessories, components other than those specified above required for the satisfactorily completion of this projects shall be under the scope of work of the contractor under no extra cost.
- e) Transportation of materials, erection, commissioning etc is in the scope of contractor.

f) Power supply of 230 Volts, 50Hz, Single phase at the camera location shall be done by CSL. However, necessary details to provide the power supply at required locations shall be given by the contractor.

On site clearance, the contractor should commence the work immediately on priority basis, as directed by executing officer. In the event of delay from CSL side, the same will not be considered onto the contractors work completion period.
- 7) The quoted model should have technical support with spares for a minimum period of 5 years from the date of commissioning of the system.
- 8) The bidder shall clearly provide the model no. and brand name for the quoted items along with required supporting documents/ brochure/ datasheets.
- Tender reference (tender number and Name of Work) should be clearly indicated on the top of respective covers. Cover 1: Technical bid [Duly signed all technical documents including eligibility criteria, un priced bid] Cover 2: Price Bid

- 15) <u>Performance guarantee</u>: The contractor has to guarantee the supply and installation for a minimum period of One Year as Performance guarantee from the date of commissioning and acceptance of the entire system by CSL against defective workmanship / inferior quality of materials used. Any defects found during the above period have to be rectified by the contractor at his own expenses including replacement of components if any required. The defects are to be attended within 48 Hr from the time of intimation from CSL and immediate solution shall be attained.

Misleading or false representations in the forms, statements and attachments submitted in proof of eligibility requirements will result in summarily rejection/ disqualification of the submitted offer at any point of time whatever may be the status of the process. Password protected tenders shall be send via email in prescribed format to <u>amitkumar.das@cochinshipyard.in</u> by the due date and time.
- 2) In the case of tenders floated in website, all corrigenda, addenda, amendments and clarifications to tender specifications will be hosted in the website www.cochinshipyard.in and not in the newspaper. Bidder shall keep themselves updated with all such developments from CSL web site till the last date and time of submission of tender. However, it is advised to contact the officer-in-charge of the work for any clarifications before the due date of the tender.
- All documents, instructions, catalogues, brochures, pamphlets, norms, reports, labels on deliveries and any other data shall be in English language.
- 4) L1 shall be arrived based on lowest quoted total amount excluding GST. Price Bids shall be evaluated based on L1 cost as per the price bid format. Normally CSL will award the contract to the Bidder who has been substantially responsive to the bidding documents and who has offered lowest evaluated total amount. However, if in the opinion of CSL, the total price or certain item rates quoted by the lowest evaluated bidder are considered high, CSL may invite such bidder for price negotiation. This contract shall also not be deemed to create any partnership, joint venture or any association between CSL/CKSRU and the firm.
- CSL/CKSRU reserves the right to award the contract to one or more firms or may split the scope of work, depending upon the actual necessity, as deemed fit.
- 8) CSL/CKSRU reserves the right to reject any or all the offers without assigning any reason whatsoever.
- 9) The rates agreed upon as per quotation remain firm and fixed and will not be changed till conclusion of contract including extended period, if any.
- 10) CSL/CKSRU reserves the right to terminate the contract at short notice in case the firm's performance is found not satisfactory with regard to progress of work, quality, time factor, labour dispute with their workers, poor safety records and other violation of any contract conditions. No claim whatsoever will be entertained by CSL/CKSRU on this account.
- 11) The bidders are expected to inspect the site to know the nature of work and site condition with prior intimation to the officer in charge. Bidders can contact officer-in-charge of the work which is indicated in the tender document for any

clarification before submitting the offer. If clarifications/details are not obtained before the tender is submitted, no claim on this account will be admitted. Withdrawal of the quotation after it is accepted or failure to make the supply/execution within the stipulated delivery/completion period will entail cancellation of the order and forfeiture of EMD/Security Deposit, if any/ and or risk purchase.

- 25) The contractor is expected to acquaint himself with the site conditions, labour situation, wage and benefits applicable to labourers, working hours, out turn of work by labour and the fluctuations which are likely to happen till the work is completed on all the above aspects prior to quoting the rates.
- 26) The work shall be inspected by the Officer -in-charge, his authorised representative or any other third party deputed by the Officer-in-charge. Officer-in-charge will have full liberty to impose penalties for the violation of any of the agreement clauses.
- 27) Cochin Shipyard Limited reserves the right to make minor alterations, additions or substitutions to the existing specifications/ scope of work, if found necessary during the progress of work and the contractor is bound to carry out the work without any additional cost, as per such altered specifications.
- 28) Force Majeure Condition: Should failure in performance of the contract or part there of arise from war insurrection, restrain imposed by Government, Act of Legislature of other statutory Authority or illegal strike (event like local strike/ harthal etc in the yard, state or national), riot legal lock out, flood, fire, explosion, Act of God of any inevitable or unforeseen beyond human capacity which may be constructed as reasonable ground for an extension of time, CSL may allow such additional time as is mutually agreed. to be justified by the circumstances of the case. The occurrence/ cessation of force majeure situation is to be informed with documentary evidence within 15 days from the date of occurrence or cessation.

29) Tax Elements:

- b) Permanent Account Number (PAN) obtained from Income Tax Department should be mentioned in the invoice for inclusion of PAN in the TDS returns filed by CSL.
- c) GST Id should be mentioned.
- d) The invoices should be as per the provisions of GST law. The invoices should mandatorily contain the HSN code/SAC and GSTIN number along with other particulars. The GST charged (CGST & SGST or IGST) should be separately indicated in the invoice.

32) Safety Rules:

All personnel deployed at site shall wear PPE at all times when working within the factory premises of CKSRU. PPE is to be provided by the contractor/firm including, coverall, safety shoes, safety helmet, gloves, safety glasses, full body harness etc. The firm/contractor shall be entirely responsible for the safety of all personnel employed by him on the work and should ensure that the personnel are adequately covered under insurance.
- b) The firm shall be solely responsible for any consequences arising out of any loss, damage or accident caused to the personnel engaged by him on duty. Any labour issues with employees have to be settled by the contractor or firm themself. CSL/CKSRU will not have any responsibility for any issue between firm and the employees, for any injury or illness to firm's workmen/other personnel during execution of work. In this regard firm will have to fully indemnify CSL/CKSRU against any claim made by his workmen/other personnel.
- c) Additional safety provision: For the work carried out within dock area the contractor shall abide by all provisions of the dock workers (Safety, Health and Welfare) Regulation 1990 without causing any damage / accident in the work premises which will be ultimately causing loss to CKSRU either directly or indirectly. The Contractor has to take all the necessary safety measures to prevent any damage/ accident at site during the execution of work.

33) Statutory Conditions and Labour Laws:

- a) The firm must comply with statutory requirements, ESI/EPF, and other labour laws/regulations in force and as amended from time to time by Govt. of India. The firm must abide by minimum wages act as governed by Govt. of India rules in force and as amended in future.
- b) The firm shall observe and comply with the provisions of all labour and industrial laws and enactments and shall comply with and implement the provisions of the Factories Act, 1948, `Employees Provident Funds & Miscellaneous Provisions Act, 1952, Employees State Insurance Act, Payment of Gratuity Act, minimum Wages Act, Payment of Bonus Act, Contract Labour (Regulation and Abolition) Act and all other enactments as are applicable to them and their workmen employed.
- c) All contract workmen, except those exempted under the respective Acts, shall necessarily be insured under the ESI scheme and be made members of the EPF Scheme from the day of their engagement as contract workmen at CKSRU. All such insured contract workmen should carry with them their ESI Identity Card for verification by the authorities. No contract workmen without a valid ESI Identity Card for verification by the authorities will be permitted to work in the company.
- d) The firm shall be solely responsible for the payment of wages, salaries and other legal dues of its personnel who are employed or deployed by it from time to time. The firm shall promptly pay all due salaries and wages to its personnel providing service and salary has to effect before 10th of every month preceding the wage month. CSL reserves the right to ask the firm to submit satisfactory evidence of payment due, salaries etc. In any event,

CSL/CKSRU shall not be liable for any payments, dues, wages and salaries of the personnel employed by the firm.

- 34) Arbitration: It is clarified that the firm cannot go for arbitration for any disputes arising out of the agreement related to this contract work. Cochin Shipyard Ltd. has a grievance redressal cell and all questions, disputes difference or differences arising under, out of, or in connection with the contract after hearing by Cochin Shipyard Ltd Grievance Redressal committee shall be subject to Indian Laws in force and at the exclusive jurisdiction of the courts at Kochi.

- d) The bidder is expected and deemed to have read, understood and agreed to all instructions, forms, terms and specifications etc. in the tender document while bidding.
- e) Failure to furnish all information required or False/ambiguous information or submission of bid not substantially responsive to the bidding documents in every respect will be at the Bidder's risk and may result in rejection of the bid.
