#### **SCOPE OF WORK & TECHNICAL SPECIFICATION**

#### 1. SCOPE:

The scope of work under this tender specification covers the following:

- a. Design, manufacture, supply, installation and commissioning of 12 meter long High Mast with all its accessories as per Technical Specification, complete in all respect.
- b. Design and construction of R.C.C. foundation for 12 meter long High Masts including foundation bolts as per Technical Specification, complete in all respect.

**Note:** CSL shall provide the feeder cable (incoming cable for high mast panel) of required size up to Feeder Pillar of the high mast.

#### 3.1 Structure:

The High mast shall be of continuously tapered, polygonal cross section, 12 sided, presenting a good & pleasing appearance and confirming to the above data sheet to give an assured performance and reliable service.

#### 3.2 Construction:

Each section shall be fabricated out of individual plate duly folded and welded. There shall be only one longitudinal seam weld per section. Section fabricated out of multiple plates or with more than one weld shall not be accepted.

Each mast shaft section shall be without any circumferential weld joint except base flange. The mast base flange shall be free from any lamination or incursion and provided with supplementary gussets between the bolt-holes to ensure elimination of helical stress concentration. Exposed portion of bolt, nuts & washer shall be hot dip galvanised.

#### 3.3 Door opening:

An adequate door opening shall be provided at the base of the mast and the opening shall be such that it permits clear access to equipment like winches, cables, plug and socket, etc. and also facilitate easy removal of the winch.

#### 3.4 Luminaire carriage:

The luminaire carriage shall be fabricated out of MS pipes and finished with hot dipped galvanization. There shall be suitable number of arms to mount the required nos. of luminaires as per the above data sheet enclosed. The system shall also make sure that lateral movement of the luminaire carriage is arrested considerably.

The inner lining of the carriage shall be provided with protective PVC arrangement, so that no damage is caused to the surface of the mast during the raising and lowering operation of the carriage. The entire Lantern carriage shall be hot dip galvanized after fabrication. All hardware used shall have necessary corrosion protection provision.

There shall be 02 Nos. of latching pins fixed at the top of luminaire carriage equally spaced, which shall move along latching barrels to fix the luminaire carriage with the head frame. These latching pins shall have independent rotation. These pins shall be spring loaded and wire ropes shall pass through these pins towards end termination. There shall be indicators on the two latching pins to indicate correct latching of the luminaire carriage. Each latching pin shall be capable of supporting the weight of the entire luminaire carriage.

#### 3.5 Raising and lowering mechanism:

#### 3.5.1 Winch:

The double drum winch shall be completely self-sustaining without the need for brake shoe, springs or clutches and self-lubricating type by means of an oil bath. The drums are to be grooved to provide perfect seat for stable and tidy rope lay and arrangement for distortion free rope end termination. The capacity, operating speed, safe working load, recommended lubrication and serial number of the winch shall be marked on each winch.

Manufacturer's Test Certificate for the winch will have to be provided. A test certificate shall be furnished by the contractor for each winch in support of the maximum load operated by the winch.

Latching head frame system is to be designed in order to take the load off the wire ropes once the luminaire carriage is latched in head frame.

#### 3.5.2 Head Frame:

The latching head frame shall be fabricated out of MS sections and finished with hot dipped galvanization to protect from environmental factors. The head frame shall house pulleys made of non-corrosive aluminium alloy, gunmetal bush bearing and stainless-steel shaft to make the pulley operation maintenance free for a longer time. These pulleys shall be of diameter large enough to accommodate stainless steel wire ropes and trailing cable. The pulley assembly shall be fully protected by a canopy, galvanized internally and externally. Close fitting guides and sleeves shall be provided to ensure that the ropes and cables do not get dislodged from their respective positions in the grooves.

There shall be two numbers of latching barrels on the bottom part of the head frame through which the latching pins move. There shall be cam profiles built in these barrels to guide the movement of latching pins. Lightening finial is to be fixed on top of the headframe.

#### 3.5.3 Stainless Steel Wire Ropes:

The stainless-steel wire ropes shall be in 7/19 construction with central core in the same material of grade, diameter and breaking load as given in data sheet.

Two continuous lengths of stainless steel wire ropes shall be used in the system and no intermediate joints are acceptable in view of the required safety. No intermediate joints/terminations, either bolted or else, shall be provided on the wire ropes between winch and lantern carriage.

The end construction of wire rope for the winch drum shall be fitted with copper talurit, the other end of the wire ropes are taken through two pulleys in head frame and terminated at latching carriage with wire termination clamp and with bulldog grips. The rope termination in the winch shall be such that distortion or twisting is eliminated and at least 5 to 6 turns of rope remains on the drum even when the lantern carriage is fully lowered and rested on the rest pads.

#### 3.6 Electrical System, Cable and Cable Connections

The multi core trailing cable from base compartment to junction box at luminaires carriage shall be 1.1 KV grade and type as specified in the data sheet of copper conductor with male female connectors.

Wiring from junction box to luminaries is to be done using 3 core 1.5 sq. mm PVC/ XLPE insulated, PVC sheathed, copper conductor flexible cable (shall be a part of erection activity of the high mast).

Suitable arrangement is to be provided in the base compartment to receive and terminate incoming power cable and MCB in a box for isolation of incoming power supply.

#### 3.7 Power Tool for the Winch:

Three phase, single speed, 6 pole high-powered, certified motor of rating suitable to lift the load mounted on adjustable plate to adjust the length of winch motor coupling chain is to be provided in base compartment.

Mechanical torque limiter is to be mounted on motor shaft to stop transmission of motion from motor to winch in case of excess load and thus prevent the damage to winch and breakage of rope.

Earth terminal using 12 mm diameter hot dip galvanized bolts shall be provided on the door stiffener of the mast for lightning and electrical earthing of the mast.

#### 3.8 Lightning Finial

One number heavy duty 1.2 m long hot dip galvanised lightening finial shall be provided for mast on the head frame to get a direct conducting path to the earth through the mast.

#### 3.9 Earthing Terminals:

Separate earth terminals using 12 mm diameter GI Bolts shall be provided at convenient locations on the base of the High Mast for connection with suitable size GI Flat, for lightning protection and earthing of electrical accessories installed on the High Mast.

#### 3.10 Feeder Pillar

Mast shall be provided with a feeder pillar housing Suitable TPN MCB incomer, single dial time switch and outgoing contactor for automatic switching on and off luminaries, raise lower push buttons for motor operation, incoming terminals and outgoing terminals for power cable and for motor.

Power cable of suitable size up to the feeder pillar/ base compartment of high mast from supply point shall be provided by CSL.

#### 3.11 Incoming Power Cable

1.1 KV grade, XLPE insulated, PVC sheathed, Aluminium conductor, armoured cable for power supply of suitable size shall be provided from feeder pillar to the base compartment of the high mast. Cable shall be taken to the base compartment of the high mast through the provision made in the foundation. Power cable of suitable size up to the feeder pillar from supply point shall be provided by CSL.

#### 3.12 Civil Work

All the civil work including foundations, earth pit etc. is in bidder's scope.

#### 4. ELIGIBILITY CRITERIA:

Experience having successfully completed similar works (Supply and installation of high mast tower lights) during the last 5 years ending last day of month previous to the one in which tenders are invited should be either of the following:

Three similar completed works each costing not less than the amount equal to Rs.3 Lakhs.

OR

Two similar completed works each costing not less than the amount equal to Rs.4 Lakhs.

OR

One similar completed work costing not less than the amount equal to Rs. 6.5 Lakhs.

(Details of orders executed along with completion certificate from the client indicating value of work executed and performance shall be submitted in this regard. The similar work should have been executed in India.).

- 5. The average annual financial turn over should be at least 8 Lakhs during the last 3 consecutive financial year (FY 2022-23, FY 2021-22 & FY 2020-21). (Copy of audited balance sheets showing turnover profit & loss account of the firm for the preceding 3 FY's should be submitted).
- **6.** The bidder should possess valid 'A' grade/ 'B' grade electrical contractor's license issued by West Bengal State Govt or should associate with an electrical contractor having above license. A certified copy of contractor's license shall be submitted along with the tender document. All the works shall be carried out in the presence of a full-time supervisor with a valid supervisory license. Contractor should ensure to follow the rules and regulations of Central Electricity Authority of India (CEA).

#### TERMS AND CONDITIONS

- 1. Tenderers are to carefully go through the terms and conditions and the technical specification of the items for which offers are called for
- 2. Offer shall be submitted in the prescribed form in the 'CKSRU Tender Box' located at CSL-Kolkata Ship Repair Unit, Gate No.9, Netaji Subhas Dock, Circular Garden Reach Road, Kolkata 700024, and has to be addressed to The Deputy General Manager (CKSRU), Cochin Shipyard Limited, CSL-Kolkata Ship Repair Unit, Kolkata 24.
- 3. In case of bid sent through e-mail, then the documents should be password protected and the passwords should be passed on to the concerned officer while attending the bid opening or by e-mail or SMS immediately before the tender opening against the request from concerned officer.
- 4. **Validity:** The offer should be valid for a minimum period of four months from the tender closing date.
- 5. Earnest Money Deposit (EMD): Rs.10,000/- (Rupees Forty Thousand only) EMD for a valid bid has to be submitted by the bidder in the form of demand draft / FDR / Bank Guarantee (Encl.2) drawn in favour of Cochin Shipyard Limited from scheduled bank except Co-operative bank in case of indigenous bidders and from international bank as per the CSL approved list in case of foreign bidder. Cheques are not acceptable. Bids submitted without EMD will be rejected. No interest shall be paid for the EMD, Security Deposit or Performance guarantee. EMD will be returned to the unsuccessful bidder's post finalization of tender and issue of Work Order to the L1 bidder.
- 6. Cost of Tender Form: Rs.1000/- (Rupees One Thousand only)
  Tender form cost has to be submitted by the bidder in the form of demand draft while submitting the technical bid, drawn in favour of Cochin Shipyard Limited from scheduled bank except Co-operative bank in case of indigenous bidders and from international bank as per the CSL approved list in case of foreign bidder. Cheques are not acceptable. This is a non-reimbursable amount.
- 7. <u>Mode of tender:</u> The tender for the work will be based on Two Bid system. The tender shall consist documents as indicated at Annexure-4.
- 8. Bidders can contact Officer-in-Charge of the work which is indicated in the tender notice for any clarification before submitting the offer. If clarifications/details are not obtained before the offer is submitted, no claim on this account will be admitted.
- 9. Bidders to note that no advance payment will be made by CSL against work order/ supply order issued.
- 10. Corrections and additions if any in the bid must be attested/ duly signed by the bidder. In the case of error in multiplication/addition in amount calculated, the unit rate quoted will be considered as correct and the amount will be calculated accordingly. Conditional rebates & discounts, incomplete/ambiguous offers are likely to be rejected.
- 11.L1 will be arrived based on the lowest total amount quoted for the entire work excluding GST. Bidder has to quote for all line items. Partially quoted bid will be rejected.
- 12. Normally CSL will award the contract to the Bidder whose bid has been substantially responsive to the bidding documents and who has offered lowest evaluated total amount. However, if in the opinion of CSL, the total price or certain item rates quoted by the lowest evaluated bidder are considered high, CSL may invite such bidder for price negotiation. Lowest quoted bidder shall attend such negotiation meetings and if requested by CSL shall provide the analysis of rates/break up of amount quoted by him for any or all items of Schedule of Rates/ prices to demonstrate the reasonability. As a result of negotiation, bidder may offer rebate on his earlier quoted price.
- 13. No enhancement of rate for whatever cause will be allowed once the offer is accepted and an order is placed.

14. GST/Duties, if any, payable extra is to be indicated in the techno-commercial part for two bids.

#### 15. Payment terms:

- a) 100% payment shall be released after completion of total scope of the work and acceptance by CSL representative at CKSRU site.
- b) Supplier shall indicate details like PAN, GST details etc. required for processing payment. Payments will be made through NEFT/RTGS/Cheque mode and necessary details shall be furnished by the supplier in the format at Enclosure-1.
- c) CSL reserves the right for the deduction of taxes and duties as applicable from the bill or invoice.
- d) The invoice to be raised on Officer in-charge, Cochin Shipyard Limited, CSL-Kolkata Ship Repair Unit, Dry Dock Office Building, Netaji Subhas Dock, Gate No.9, Circular Garden Reach Road, Kolkata – 700024.
- e) GST No. of CSL-Kolkata Ship Repair Unit is 19AAACC6905B1Z1.
- f) Payment will be released tentatively within 30 days from the date of submission of bill duly certified by the authorized CSL representative at Kolkata. Delay in submission of bills will lead to delay in processing of payment.

#### 16. RESTRICTIONS UNDER RULE 144 (XI) OF THE GENERAL FINANCIAL RULES (GFRS), 2017

- a. Certificate shall be submitted by the bidders as per the below format along with their offer, stating compliance with office order OM No. 6/18/2019-PPD dated 23<sup>rd</sup> July 2020 (as amended from time to time shall be applicable) regarding restrictions under rule 144 (ix) of the General Financial Rules (GFRs).
  - "I have read the clause regarding restrictions on procurement from as bidder of a country which shares a land border with India and on sub- contracting to contractors from such countries; I certify that this bidder is not from such a country or, if from such a country, has been registered with the competent authority and will not sub contract any work to a contractor from such countries unless such contractor is registered with competent authority. I hereby certify that this bidder fulfills all requirement in this regard and is eligible to be considered"

Where applicable, evidence of valid registration by the competent authority shall be attached.

- b. Any bidder from a country, which shares a land border with India, will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. In works contracts, including turkey contracts, contractors shall not be allowed to sub contract works to any contractor from a country which shares a land border with India unless such contractor is registered with Competent authority. Relevant certificate to be submitted by bidder from a country which shares land border with India except for bidders to which Govt. of India has extended lines of Credit or in which Govt. of India has development projects, along with the offer as proof of registration with competent authority, failing which the offer will not be considered. A certificate is to be submitted by the bidder for compliance with the order referred above long with tender documents for consideration of offer (Wordings are as per Clause below). If such certificate given by a bidder whose bid is accepted is found to be false, this would be a ground for immediate termination and further legal action in accordance with law.
- c. Registration should be valid at the time of submission of bids and at the time of acceptance of bids. In respect of supply otherwise than by tender, registration should be valid at the time of placement of order. If the bidder is validly registered at the time of acceptance /order placement, registration shall

- not be a relevant consideration during contract execution.
- d. The competent authority for the purpose of registration under the order shall be Registration committee constituted by the Department of Promotion of Industry and Internal Trade (DPIIT). Details of the committee and procedure for registration and restrictions shall be as per Ann. I of the Order -Public Procurement no 1 dt 23.7.2020 issued by Ministry of Finance, department of Expenditure.
- e. "Bidder" (including the term 'tenderers', 'consultant' or 'Service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.
- f. "Bidder from a country which shares a land border with India" for the purpose of this Order means:
  - a) An entity incorporated, established or registered in such a country; or
  - b) A subsidiary of an entity incorporated, established or registered in such a country; or
  - c) An entity substantially controlled through entities incorporated, established or registered in such a country; or
  - d) An entity whose beneficial owner is situated in such a country; or
  - e) An Indian (or other) agent of such an entity; or
  - f) A natural person who is a citizen of such a country; or
  - A consortium or joint venture where any member of the consortium or joint venture falls under any of the above
- g. The beneficial owner for the purpose above will be as under:
  - In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.
     Explanation
    - a. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five per cent of shares or capital or profits of the company.
    - b. "Control" shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreements or voting agreements.
  - 2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more judicial person has ownership of entitlement to more than fifteen percent of capital or profits of the partnership.
  - 3. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals,
  - 4. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official;
  - 5. In case of trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.

- h. An Agent is a person employed to do any act for another, or to represent another in dealings with third person.
- i. The successful bidder shall not be allowed to sub-contract works to any contractor from a country, which shares a land border with India unless such contractor is registered with the Competent Authority.

#### 17. Definitions:

- 32. Transportation and Transit insurance shall be in the scope of supplier and unit prices quoted are to be inclusive of the same.
- 33. Packing Material should be eco-friendly.
- 34. Supplier should follow the statutory requirements of products offered.
- 35. Products supplied shall be nontoxic and harmless to health. In the case of toxic materials Material Safety Datasheet may be furnished along with the material.
- 36. After submission of tender, no unsolicited correspondence will be entertained.
- 37. Cochin Shipyard Limited does not bind itself to accept the lowest or any tender but reserves to itself the right to reject any or all or a part of any tender at its discretion. After submission of tender, no unsolicited correspondence will be entertained.
