# GUIDELINES REGARDING PERSONS WITH BENCHMARK DISABILITIES USING THE SERVICES OF A SCRIBE

Facility of scribe is permissible under the Government of India rules governing the recruitment of Persons with Benchmark Disabilities, for Persons with Benchmark Disabilities who have disability of 40% or more if so desired by the person, and his/her writing speed is adversely affected. In all such cases where a scribe is used, the following rules will apply:-

- Please ensure that you are eligible to use a scribe as per the Government of India rules governing the recruitment of Persons with Benchmark Disability.
- Both the candidate as well as the scribe will have to give a suitable undertaking, in the prescribed format given under.
- The scribe may be from any academic stream.
- The candidate availing services of a scribe is eligible for "compensatory time" of 20 minutes for every hour of the examination. This includes candidates with disability who have physical limitation to write including that of speed whether availing the facility of scribe or not.
- Only candidates who request for compensatory time at the time of reporting for the test will be allowed such concessions since compensatory time given to candidates shall be system based, it shall not be possible to allow such time if he / she has not informed the same in advance.
- Candidates who have not requested for compensatory time in advance shall not be allowed such concessions.
- A person acting as a scribe for one candidate cannot be a scribe for another candidate. In addition the scribe arranged by the candidate should not be a candidate for the test. If violation of the above is detected at any stage of the process, candidature of both the candidate and the scribe will be cancelled.
- Any misconduct committed by the scribe shall amount to a misconduct committed by the candidate who is using the scribe and is liable for disciplinary action as may be deemed appropriate.
