4. Call letters for the PowerPoint Presentation and Personal Interview through Video Conferencing shall be sent by e-mail to the provisionally short-listed candidates separately. **Please note that the call letters shall not be sent by post.**

Short-listed candidates should ensure that they fulfill all the eligibility requirements viz. age, qualification, experience, caste, disability etc., as advertised vide Vacancy Notification No. UCSL/IMS/HR/VN/F/11-AM/QC/MAT/U&M/2025/37 dated 04 March 2025 before attending the selection process. Verification of identity of candidates shall be done at the start of the Video Conferencing.

Candidates attending the selection process through Video Conferencing shall present the copy of call letter along with Aadhaar Card (in Original) for Identity Verification. **Those who do not produce the call letter and Aadhaar Card (in Original) shall not be allowed to appear for the Video Conferencing and further selection.**
7. All instructions related to the selection process are detailed in the call letter. Candidates are advised to go through the call letter in detail

Original Certificates of the short-listed candidates shall be verified at the time of joining or at any other stage as decided by Udupi CSL. **Candidature is provisional subject to verification of certificates for proof of age, qualification, experience, caste, disability etc. and meeting the notified eligibility requirements.** At the time of certificate verification/joining, if the candidates short- listed are found not meeting the eligibility requirements or fail to produce certificates in original or if at any stage, it is found that any information furnished by the candidate is false/ incorrect, or there has been suppression of facts and information, the candidate shall not be considered for selection and candidature/appointment will be cancelled/rejected without further notice.
